# Superior Town Council approves library policy, appoints new police chief

The Superior Town Council met for its monthly meeting in October.

Agenda items included accepting the resignation of Police Chief Frank Alanis. Alanis is resigning his position with the Town of Superior to become the Chief of Police for Central Arizona College.

Alanis has worked for the Town of Superior for four years and recently attended the FBI Academy. In 2021, Chief Alanis was selected as the Arizona Police Chief of the Year.

The Town Council accepted his resignation, unanimously and thanked him for his service to Superior.

"You taught us what to expect in a police chief and we thank you," said Vice Mayor Michael Alonzo.

State law prohibits a Town from operating without a Chief of Police. Council voted to go into an executive session to discuss their options for hiring a new Chief of Police. The options were to appoint Lt. Chavez as an interim chief until a permanent chief could be hired or do a full hiring process. Chief Alanis recommended to Council that they should promote Lt. Tim Chavez as the

After a 20-minute executive session (non-public meeting), the Council returned and voted unanimously to hire Chavez as the new police chief and directed the Town Manager to negotiate a salary package. Chavez came to Superior after his retirement as the Chief of Police for the Gila River Indian Community.

The council also voted with a 5-1 vote to approve the original library policy that was presented to the council at the September meeting. The council tabled the original policy after concerns by Councilman Bruce Armitage that the policy did not protect children, based on the policy guidelines from the Library Bill of Rights by the American Library Association.

Councilmember Amy Byrd quickly made a motion to approve and adopt the original policy presented, which keeps the Library Bill of Rights in the policy and protects everyone's First Amendment rights to read. The motion passed with Councilman Armitage voting against the policy. Public discussion or debate amongst council did not occur due to the quick voting procedures that ended debate.

Council also approved a contract with the Arizona Department of Transportation Aeronautics division for construction of a new helicopter landing zone at the Superior Municipal Airport. Construction is expected to begin soon.



Effective September 1, 2023, all customers except Irrigation Project Pumps will be charged Irrigation Project Pumps will be charged \$0.056 per kilowatt-hour (kWh) billed in addition to our existing electric power rates published in the Federal Register (87 FR 77628, Dec. 19, 2022). This will replace the April 1, 2023, PCA of \$0.0249 per kWh.

per kWh. While SCIP has long-term contracts for power from the Western Area Power Authority, most of SCIP's power supply is purchased through short-term transactions based on current and forecasted market rates. Recent weather-related events combined with Weather-related events combined with the high demand for energy resources have increased power market rates. Because purchased power costs are in part determined by market rates that are not under our control, we need to immediately implement the PCA to meet our financial and statutory requirements. We will continue to monitor energy rates and adjust the PCA as needed.


