Mountain Vista Closes Kindergarten Class



he COVID-19 pandemic has taught us all many things. One particular lesson I have learned is the importance of rapid, accurate transparency. Therefore, I'm reaching out to let our community know that Mountain Vista

K-8 School is choosing to temporarily close one of our kindergarten classrooms. The classroom will be closed because we currently have two positive cases of COVID-19 in that classroom cohort. By temporarily closing the classroom, we hope to slow and ultimately stop the spread of COVID-19 at our school. The classroom will be locked this afternoon (Monday, October 25) and will remain locked for 24 hours. The classroom will be deep cleaned on Wednesday, October 27. The students will be welcome back to campus and their classroom on Tuesday, November 2, provided they are healthy and symptom free. While the classroom is closed the students will complete paper and pencil assignments and family projects from home

Together with our school principal, we spoke with the families of each child in this classroom cohort. We personally notified all possible close contacts. We are following guidelines and recommendations from the health department as well as our District's Safe Return to In-Person Learning Plan which can be found on our website at www.osd2.org. We continue to be vigilant when it comes to cleaning, washing our hands, covering our coughs and sneezes, and staying home when we do not feel well. We encourage families to speak with their children about how we can keep ourselves safe and healthy. For many families, this includes wearing a face mask or receiving a COVID-19 vaccine.

This is a small community and just as germs, bacteria, and viruses travel fast, information (both false and accurate) can often travel even faster. It is my hope that by sharing this information with you today, we can help prevent unnecessary concern, panic, or misinformation. We are in the midst of difficult times. This is officially the third consecutive school year impacted by the COVID-19 pandemic. The last "normal school year" our fourth graders experienced was kindergarten. Our students in kindergarten through third grade have only known school to include unannounced transitions to distance learning, face masks, temperature checks, and the frequent use of hand sanitizer.







San Manuel advances to quarterfinals; Miners to

On Oct. 22, the San Manuel football team hosted the first round of the Division One playoffs against Tempe Prep. The game started off with the Miners' Andres Rodriguez kicking off the ball to Tempe Prep. San Manuel's defense had to adjust to Tempe Prep being such a pass-based offense. Tempe scored first, reaching the end-zone with a pass play. The Miners worked to keep up in score. Noah Huerta made San Manuel's first touchdown, powering through a wall of defense into the end-zone. By the end of the first quarter the score was San Manuel, 8, and Tempe Prep, 14.

The second quarter saw the Miners defense working hard to suppress Tempe's passing. Ralphie Valencia made an end-zone catch to boost them up to 14, while Nicolas Velasquez scored the two-point conversion, bumping them up to 16 at the end of the second quarter, while Tempe Prep had 20.

"The team did really well, going into the half down by four, and coming out adjusted and making plays to come out on top," head coach Ernie Ivy told the *Miner*.

Quarter three started off with the Miners returning the kickoff, and Noah Huerta carrying it 30 yards. Tempe Prep was able to get themselves another touchdown, putting them at 26. San Manuel continued to work hard, taking the lead by the end of the third quarter, with a 30-26 score. The fourth quarter had San Manuel continuing to grow their lead, while holding Tempe down. By the end of the game, the Miners held at 52 while Tempe Prep had 32, sending San Manuel to the next round of playoffs.

Coach Ivy acknowledged Noah Huerta, Ralphie Valencia, and Nicolas Velasquez for having a good night on offense. Coach Ivy also wanted to recognize the younger players

who stepped it up and did very well, Dominic Rodriguez, Jacob Tafoya, and Augustine Romero.

"We will start preparing on Monday with the team, for Mohave," coach Ivy stated, "the coaches started on Saturday."

The Miners will travel to Bullhead City Saturday, Oct. 30, to face off against Mohave Accelerated. They will play inside the Anderson Auto Group Fieldhouse, located at

3663 Bullhead Pkwy., Bullhead City, AZ 86442.

Copper Corridor Communities Seeing Increase of COVID-19 Cases

Recently, State and National media have reported an increase in positive COVID-19 Cases. The communities of the Copper Corridor have also started to see an increase in positive cases. The new Delta variant of COVID-19 has been reported as highly transmissible. The CDC and other health officials warn that those who are not vaccinated should continue to practice physical distancing, wear masks in public and avoid crowded places and is also strongly recommending everyone wear a mask indoors and in group settings.

Governor Doug Ducey has signed executive orders that prohibit Cities and Towns from mandating mask wearing, limiting restaurant capacity or other enacting other physical distancing requirements. At this time there is no indication that there will be any restrictions put into place. Local schools are also prohibited from requiring masks be worn on campus.

COVID Vaccines are readily available at local clinics in the region including Cobre Valley Clinics in Superior and Kearny, Pinal County Public Health and Sun Life Clinics. Other chain pharmacies such as Walgreens, grocery story pharmacies and CVS also have vaccines available.

We last reported daily COVID-19 case increased on Oct. 11, 2021. Above is a chart showing our last reported number and the current number of total cases for each of the Copper Corridor communities through Oct. 25, 2021. Keep in mind that zip code data also includes unincorporated areas around a community. For instance, Riverside/Kelvin area is included in the Kearny zip code. Aravaipa and Dudleyville are included in the Winkelman zip codes, etc.

Those experiencing COVID-19 symptoms should seek testing and quarantine until they can confirm a negative test.

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.



Support Local: Oracle Community Learning Garden

n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. Copper Area News wanted to give something back to the local business community as a thank you for supporting us through these troubled times. Our newspapers (Copper Basin News, Superior Sun and San Manuel Miner) have been featuring local businesses and non-profits since the beginning of 2021, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, Copper Area News has featured 119 businesses and groups in the Copper

Corridor.

As the COVID-19 Pandemic took its toll, businesses, families and even local non-profits had to adjust their strategies to keep their missions moving forward while working through the pandemic. Meetings were moved to Zoom and fundraisers had to become creative as in-person events were not allowed.

One local non-profit has continued operating business as usual even through the pandemic, with some alterations.

For the last five years, the Oracle Community Learning Garden has been providing education and space to the community. Located at the former skate park in Oracle, the garden seeks to be a place where people can come together and just be in peace.

The outdoor venue allowed local volunteers to continue meeting in a socially-distanced way, although all gatherings were curtailed until it was safe to begin meeting again.

With local residents receiving their vaccines and COVID numbers dropping in the communities, organizers at the garden

deemed it safe to gather again. And in pure Oracle-style, the Learning Garden hosted the 13th annual Fiesta de Las Calabazas on Sunday, with live music from Mother Cody Band, pumpkin decorating, plant sale and model trains.

Also this Sunday, the SaddleBrooke Rotary Club placed a Peace Pole in the garden.

According to the Rotary International website, a Peace Pole is an internationally-recognized symbol of the hopes and dreams of the entire human family, standing vigil in silent prayer for peace on earth. Each Peace Pole bears the message "May Peace Prevail on Earth" in different languages on each of its four or six sides. There tens of thousands of Peace Poles in nearly every country in the world dedicated as monuments to peace. Oracle's Peace Pole is the newest one.

The Oracle Community Learning sponsors classes from local schools such as Mountain

Vista on Monday afternoons. These school programs are for students to learn about gardening and growing their own food.

The Oracle Community Learning Garden is also participating in a program to grow and replant willows along the San Pedro River.

The garden grew 600 willow trees to be replanted. It also grew some native plants which were planted on the banks of the Gila River in Kearny to replace the tamarisks that were removed following the Gila River Fire several years ago.

The Oracle Community Learning Garden has several projects that are ongoing. The garden is working on a pollinator garden/path. They also have eight spaces to rent. The garden is open 24 hours a day, 7 days a week.

"We would like to thank the community for helping to create the garden. We welcome everyone," said volunteer Susan.
