Manage Volunteer Performance and Impact, 7. Acknowledge, Celebrate and Sustain Volunteer Involvement. Douglas Gretzler

Copper Area News has received some articles from a former corrections officer from Arizona State Prison. This retired officer spent 25 years with the Arizona Department of Corrections working all custody levels from juvenile detention units to Death Row. The author wishes to remain anonymous. He hopes to provide the readers with a view of what it is like working with inmates and what life is like behind prison walls. **INTRODUCTION**

The job of a corrections officer is not easy. The nature of the job, working with men or women behind bars can be stressful. Working in high custody units can add to the stress. The Arizona Department of Corrections has a high staff turnover rate. One in five staff members quit within the first couple

of years of being hired or use the training and experience they receive to transfer to Sheriff departments or Federal corrections.

Maximum custody inmates are either there because they are doing long sentences, are convicted of violent crimes or they are problem inmates while in prison. Inmates on Death Row are under a sentence of death and have nothing to lose by acting out against staff or other inmates. Officers must always be on the alert to prevent these inmates from harming other inmates or staff. To understand the type of inmates that are housed on Death Row, I will provide you with a few of their stories, the crimes they committed and some of their prison life.

ouglas Gretzler spent 25 years on Death Row before being executed in 1998. At the time, he had been on Death Row longer than anyone in the state and he was responsible for more killings (17) than any inmate in Arizona's prisons. Doug Gretzler met Willie Luther Stillman while they were both drifting aimlessly around the country. Steelman was a formerly institutionalized mental patient. When they met, it was the beginning of a robbery and killing spree unlike any ever seen in the southwest.

Steelman, 28, was from Lodi, California. He had a criminal record but no crimes of violence. Gretzler 22, was from the Bronx in New York. He had no criminal record. They met in Denver, Colorado where they shared an apartment with Steelman's sister. On Oct. 11, 1973, they left Denver and traveled to Phoenix, Arizona with a girl who introduced them to Yafa Hacohen, 21, (also known as Katherine Mestites in earlier news reports) and Robert Robbins, 19, who lived in a trailer home outside of Mesa, Arizona. On Oct. 17, the rampage of death began.

Michael Adshade and Ken Unrein picked up Gretzler and Steelman who were hitchhiking. Gretzler and Stillman forced the two Phoenix men, both 22 years old, to drive their van to California. In California, the two men were strangled and stabbed to death. Their bodies were found on Nov. 11 near Oakdale, California. It is believed that on Oct. 20, Steelman and Gretzler abducted a couple near Petaluma, California where the van Gretzler and Steelman had stolen broke down. After raping the young woman, they released the couple near Mountainview, California.

Steven Loughran, 18, of Marysville, California made the mistake of picking up the two men who then forced him to

drive back to Arizona. Upon arriving in Arizona, Gretzler and Steelman murdered Loughran and dumped his body near the foothills of the Superstition Mountains near Apache Junction. His body was found on Nov. 10 and authorities said he had been killed around Oct. 22 or 23. Gretzler and Steelman returned to the Mesa trailer home of Hacohen and Robbins where they shot and killed them both.

On Oct. 29, Steelman and Gretzler arrived in Tucson, Arizona by bus. On Nov. 1, they were picked up while hitchhiking then forced the driver to drive them to a place where they were to meet a couple that would sell them a .22 caliber pistol. This gun would later be used in a dozen murders. The driver of the vehicle was 19-year-old Gilbert Sierra, a miner who worked at the Magma Mine in San Manuel. Sierra was murdered and his body dumped near Gates Pass. He was shot twice in the head and once in the back. The couple who sold the killers the gun later told police they somehow managed to escape after witnessing Sierra's murder. They would later give information against Gretzler and Steelman.

Vincent Armstrong, a University of Arizona student, picked Steelman and Gretzler up, as they were hitchhiking in the University area. Gretzler and Steelman then took over the vehicle at gunpoint. Armstrong was lucky as he was able to jump out of the moving vehicle going about 30 miles an hour. The two killers then looked for a place to dump the stolen vehicle. While cruising, they came upon Michael Sandberg, a former Marine captain and now a graduate student, washing his car. They forced him into his apartment on Ft. Lowell Road. His wife Patricia was in the apartment. The Sandbergs were bound hand and foot and then shot in the head. Their bodies would not be found until Nov. 9. Gretzler and Steelman stole the Sandberg's vehicle, some cash and identifications and headed for California.

Walter Parkin owned the only grocery store in the small town of Victor near Lodi, California. On Nov. 7, 1973, the bodies of Walter, 33, his wife Joanne, 31, their children – Lisa, 11, Robert, 9; Debbie Earl, 18, a babysitter; Richard and Wanda Earl, Debbie's parents; Ricky Earl, 15, Debbie's brother, and Mark Lang, 20, Debbie Earl's boyfriend were found at the home of the Parkins. All the victims had been bound and gagged and shot at close range in the head. A total of nine innocent people killed to cover up a \$3,000 robbery of Parkin's grocery store safe. Sheriff Michael Canlis said, "It looks like the work of a madman."

Two days after the murders, the killers were tracked to motel in Sacramento, California. Gretzler was taken at the motel. Steelman was arrested later at an apartment building.

Gretzler gave up information about the Sandbergs, allowing Tucson police to find their bodies. Seventeen murders committed in a three-week period. Had they not been caught, how many more would have died?

After a legal fight with the state of Arizona, California got to prosecute the murderers first. Arizona wanted to have the trial first as they still had the death penalty for murder. In California the maximum penalty for murder was life in prison. Arizona was also worried that the trials in California could possibly hurt their cases.

Gretzler pleaded guilty to nine counts of murder. Steelman waived a jury trial and was tried by a judge who found him

guilty on all counts. They were found guilty and sentenced to life in prison. Judge Chris Papas at the sentencing said, "Steelman was the architect and engineer while Gretzler was a willing follower." California would reinstate the death penalty in 1974.

Steelman and Gretzler's lawyers fought extradition to Arizona. They would lose the case and the order to extradite the prisoners to Arizona was signed by then California Governor Ronald Reagan. In Arizona, they would both be found guilty for the murders of the Sandbergs and sentenced to death. Steelman would beat the hangman, so to speak, dying from liver disease in 1986.

On June 3, 1998, Douglas Gretzler. while laying on the gurney awaiting death by lethal injection, said, "From the body of my soul, I am so deeply sorry and have been for years for murdering Patricia and Michael Sandberg.

Though I am being executed for that crime, I apologize to all 17 victims and their families."
