# ADOT prepares snowplows in advance of season's winter weather

The Arizona Department of Transportation's statewide fleet of snowplows is ready to roll wherever and whenever needed now that crews have completed the annual process of equipping the vehicles with what's needed to clear snow and ice from state highways.

Many of ADOT's 200 snowplow vehicles are used for other important work, primarily as dump trucks, during our warmer weather. By late summer, crews begin to install the large plow blades and other equipment so those trucks are once again prepared as large, powerful snowplows.

Systems that measure and spread deicing agents on highways also are installed each year in the beds and on the backs of snowplows.

Each year, ADOT has approximately 400 employees who are trained and approved to work as snowplow operators.

ADOT reminds drivers to also prepare for traveling in winter conditions, if necessary. Helpful safety information is available at azdot.gov/KnowSnow. ADOT also provides highway conditions all year via ADOT's 511 Travel Information site, the AZ511 app or by calling 511. Highway information and answers are also available via ADOT's X (formerly Twitter) feed (@ArizonaDOT) and the agency's Facebook page (facebook.com/AZDOT).

During a busy 2022-23 winter season, ADOT snowplows logged more than 1.25 million miles clearing snow and ice from the state's highways. The figure was 605,000 miles during the 2021-22 winter season. The agency's snowplow operators logged more than 66,000 hours working to remove snow and ice as safely and quickly as possible from state highways last winter.





## Arizona Trail information kiosk installed in Kearny

Kearny joins six other Arizona Trail Gateway Communities to host an informational kiosk, three of which are in the Copper Corridor. The kiosks are being funded by a grant by the Arizona Office of Tourism. The seven communities with a kiosk are: Sierra Vista, Patagonia, Oracle, Kearny, Superior, Payson and Flagstaff.

"The Arizona Trail is an amazing and beautiful connector of the communities across the Copper Corridor," said Mila Besich, Executive Director of the Copper Corridor Economic Development Coalition. "These new kiosks helping to promote the Gateway Communities along the Arizona National Scenic Trail are important additions helping visitors to learn more about the community they are visiting while also educating others on the Arizona Trail."

She added that the kiosk in Superior is "gorgeous."

He is fondly remembered as a Family Practitioner in San Manuel where he started his practice in 1961 and worked there until two weeks after his 83rd birthday. He enjoyed the town, its people and saw many changes in the community over the years.

He enjoyed travel, which he got from his father, and enjoyed hiking, birding, but most of all he loved his profession. He would always express how much he liked people and wanted to help them get well or be healed. The concern he had for others was evident by his caring nature. 

Upon graduating from medical school, he took an Army Internship at Tripler Army Hospital in Honolulu, Hawaii. After completing the Internship, he was stationed at Fort Lewis in Tacoma, Washington where Robert (Bobby) was born. The Army then sent Dr. Brower to Korea, where he missed the birth of his second son, Steven.

After finishing his Army obligation, he was in Private Practice in Baton Rouge, Louisiana. But soon he realized that he wanted more time with his family, so he decided on an industrial medicine job in West Virginia for a couple of years, but his family did not care for the weather. Arizona looked so much nicer. So, in 1961 he decided to venture to San Manuel, Arizona, where he became a highly respected, accomplished and dedicated physician.

He continued his obligation to the military and joined the Air Force Reserves at Davis Monthan Air Base in Tucson. After 20+ years, he retired from the military as a Lieutenant Colonel.

Of all that he accomplished, he enjoyed his life and practice in San Manuel the most. He had many friends and enjoyed working with all his colleagues at the San Manuel Hospital and Clinic. Dr. Brower was respected and loved by so many, not only because of his huge generosity and deep compassion, but his outpouring of love for others.



He insisted until he could not do so any more to not have a service upon his death. He wanted only a private get together with his family, saying there was no need for a lot of fuss. If people wanted to toast him and think nicely of him, that would suffice. We will honor his wishes even though there are many who want to celebrate his life.



The community gathered last week for an all-you-can-eat soup and salad





## Stay safe while decorating for the holidays; APS offers tips to avoid injuries

A festive display of lights and decorations can add to the holiday cheer, but without safety steps, it can also send you to the emergency room. According to the Consumer Product Safety Commission, there are about 160 decorating-related injuries every day during the holiday season. Almost half of the incidents involve falls from ladders. And inside there

are more than 1,000 candlerelated fires each season and hundreds of fires started with Christmas trees.

APS offers these safety tips to avoid holiday decorating

• When stringing lights outside, use a wooden or fiberglass ladder, and be sure to stay away from overhead power lines. Only use your ladder on level ground.

Don't use the top rung and don't lean away to hang decorations.

• Avoid stringing any outdoor lighting or electrical cords where water from irrigation or sprinklers may be present.

 Check for labels showing the lights have been certified for outdoor use. Discard light sets with broken or cracked sockets, frayed wires or loose connections.

• Use more than one circuit to avoid overloading household wiring. Follow the manufacturer's recommendation for the number of light strings that can be connected safely.

 Consider using LED holiday lights, which run much cooler than their traditional counterparts, are less of a fire risk and use much less energy. • Turn off holiday lights before going to bed or leaving the

It's also important to stay safe inside the house:

• If using a live holiday tree, make sure to add water often to the tree stand. If the tree is losing a lot of needles or the needles become brittle, do not turn on decorative electrical lights. The heat from the




