Mammoth-San Manuel Schools to shift elementary school to online

Mammoth-San Manuel School Administrators made the hard decision to move students in grades kindergarten through fifth grade to online learning Dec. 1, 2021, through Jan. 11, 2022, due to a COVID-19 outbreak.

Superintendent Julie Dale-Scott said that in the last two weeks of school, five elementary classes were closed due to students with COVID-19 cases.

"We will move to remote learning only for grades K-5 from Wednesday, Dec. 1-Jan. 11, 2022, coming back on Wednesday, Jan. 12, 2022, to ensure that students don't bring more illness back to the campus after they have been on holiday with family. Safety is our biggest concern, but education is very important," the superintendent said.

The district elected to leave the junior and senior high school students on campus.

"We don't want to move to remote learning for the 6-12 graders at the end of the semester as these grades are so important for college acceptance. We have seen ourselves how much closing our campus and receiving only online remote learning has affected our students and we want to remain open, continuing that in-person learning for as many students as we can. The health department agreed that keeping 6-12 on campus would be the best option," Dale-Scott told the Miner.

Teachers will be teaching from their classrooms for all grades whether students are doing remote learning or in-person instruction. The district will continue to provide breakfasts and lunches for all students. Elementary students will have their breakfasts and lunches delivered once a day as the district did last year. Grades 6-12 will continue to be served on campus

Final day to voice concerns for redistricting is Saturday

This week, the towns of Hayden, Winkelman and Superior joined other rural towns in Eastern Arizona to show support for a proposed rural legislative district in Eastern Arizona.

The initial maps for Arizona's redistricting process were approved on Sept. 14, 2021, by the Arizona **Independent Redistricting** Commission (IRC). The approved grid maps are of equal populations for the congressional and legislative districts as required by the state constitution.

Following the 2020 Census, the Independent **Redistricting Commission** began hosting a series of workshops and open houses to redraw the legislative district lines to reflect the new population.

Almost immediately, a

group of citizens in Rural Eastern Arizona began campaigning to redraw the lines to favor the rural towns.


