## Crash claims life of Oracle woman

An Oracle woman was killed in an early morning accident earlier this month.

According to Bart Graves, Public Information Officer for the Arizona Department of Public Safety, on Dec. 13, 2022, at approximately 6:01 a.m., a vehicle driven by Joan Page of Oracle attempted to cross State Route 77 at Triangle Ranch Road (milepost 100.8). The vehicle failed to yield to another vehicle traveling southbound on SR 77 and the second vehicle collided with the driver's side of Page's vehicle. Page was pronounced deceased at the

scene

Graves said the driver of the other vehicle refused medical treatment, adding, "Impairment is not suspected."

This was the second fatal accident within eight days, keeping investigators busy. The first accident occurred Dec. 5 at approximately 8 p.m. at milepost 106.5 north of Oracle.

The victim in the Dec. 5 accident has not yet been identified, Graves said.

# San Carlos Apache Tribe and Gaming Enterprise awards local town with annual 12D Funding

Each year the San Carlos Apache Tribe and Apache Gold Casino Resort sets aside funding, which is commonly known as 12D Funding. This funding is distributed to surrounding cities, towns, and/or county non-profit organizations on an annual basis through a stringent selection process.

In years past, applications would be submitted and they would select three recipients; but this year, like so many other local businesses and non-profit organizations, the San Carlos Apache Gaming Enterprise (SCAGE) had unique challenges from recovering in 2020. Although, they stayed committed and

awarded a well-deserved non-profit organization and this year they were only able to give it to the Town of Hayden in the amount \$24,118.24; the additional funding will assist in replacing old radios and communications equipment.

The partnership with the Town of Winkelman dates back many years, so it only seemed fitting to reach out with some financial assistance through the town's police department. The Town of Winkelman police department area encompasses 450 square miles, which includes the Apache Sky Casino and surrounding communities of Dudleyville, Kearny, Mammoth and San Manuel.
