William John O'Hara

An old Marine died today . . . William John O'Hara passed away peacefully at his home in Tucson, Arizona, on Dec. 15, 2021. He was born as the third son and youngest child to Tony O'Hara and Mandy Arbour on Jan. 7, 1937, at the Bonnieview outside Waubaushene, Ontario.

At the age of 15, he emigrated to the United States and two years later he enlisted in the US Marine Corps. Just two years after that, while stationed in Toyko, Japan, he became a US citizen. Known as Bill while growing up and John after he became a Marine, our hero proudly served his country for 20 years. After retiring from the Marine Corps, John began his second career as a flight test engineer, first with Bell Helicopter International in

Iran and later with Hughes Helicopters, McDonnell Douglas, and Boeing in Yuma and Mesa, Arizona. He retired as a flight test director from Boeing in 1999.

In 1960, John met and married Marlene Carli after a whirlwind 12-day romance. They were married for nearly 44 years before her passing in 2004. In 2006, John married Glenda Hatfield, who survives him at their Tucson home.

In addition to his wife, John will be missed by his two daughters, Erin O'Hara and husband Jim Reed of Hereford, Arizona, and Shannon O'Hara-Haworth and husband Dennis Haworth of Mesa; his two grandsons, Tim and Ben; and many, many nieces and nephews. He was preceded in death by his infant son Shawn

in 1963, as well as his parents and all five of his siblings, Frances, Reta, Peggy, Charles, and Tom. Other family surviving John includes three stepdaughters, Ginger, Gayle, and Gwen, their spouses, children, and grandchildren. Furthermore, John left a wide community of friends from among his worldly travels, his time in the Marine Corps, and through his service as a Mason.

Cremation has taken place. There will be a memorial service and ice cream social at 2 p.m. on Jan. 8, 2022, at St. John's United Methodist Church, 60 W. Veterans Blvd., Tucson, AZ. Everyone is invited to attend.

mining.



Arizona Independent Redistricting Commission makes final decision after nine days of deliberation

Phoenix, AZ - Arizona's Independent Redistricting Commission has decided on the Congressional and Legislative Maps that will last Arizona for the next 10 years. The final phase of the map-making process was completed after nine days of deliberation. Congressional District Map 13.9 vote 5-0 and Legislative District Map 16.1 vote of 3-2 were approved Dec. 22, 2021.

The five-volunteer members of the Commission, chaired by Dr. Erika

Neuberg, have spent the last seven months listening to in-person public comments from over 1,700 in-person and online comments recorded. There were also thousands emailed and mailed comments, about 17,000 comments submitted through the website portal and maps submitted by online and paper submissions. The Commission held 68 statewide sessions over the past 5 months inviting Arizona residents to provide input

into the redrawing of the maps. These meetings were in all 15 counties from remote locations to large cities, municipalities, tribal communities attended by over 4,000 residents, city mayors, council members, tribal government officials, Latino community members and various organizations.

The creation and redrawing of the nine Congressional and 30 Legislative districts were an enormous undertaking for five commissioners. Pursuant to Article IV, part 2, §§ 1(14)–(17) of the Arizona Constitution, the Arizona Independent Redistricting Commission (IRC) is responsible for drawing final Legislative and Congressional electoral maps for the State of Arizona and providing certification to the Arizona Secretary of State. Arizona's county election administrators have traditionally been invited, near the end of the process but before final certification, to suggest minor, mostly technical changes intended solely to facilitate election administration in the counties. Once the IRC does vote, each county will have seven calendar days to provide to the IRC any suggestions for minor accommodations for election administration purposes.

"From day one this has always been a very organic process," stated Erika Neuberg, Chairwoman of the Independent Redistricting Commission.





Pinal County launches new effort to curb illegal dumping

FLORENCE - A new rewards program will provide a monetary incentive for residents to submit tips and information on those illegally dumping items in the desert as part of a revamped effort to curb the issue across Pinal County.

Pinal County is a beautiful place to live, work and play. However, the amount of tires, mattresses and other items littered across the desert is unacceptable and an eyesore. The Pinal County Attorney's Office is launching a 'rewards program' that will provide a \$500 reward to tipsters who submit information on people illegally dumping items if the tip leads to charges in the case.

"This is a problem that we need the whole community to help us solve," said Pinal County Attorney Kent Volkmer.

Pinal County has also created a new, simplified online page to direct residents to any resource they are seeking. This includes how to properly dispose of bulky items, when and where to find community cleanups, and how to report an illegal dump site. "We wanted a one stop shop with all the information that people would need to do the right thing," Volkmer said. "We are really excited and hopeful that this new program is going to cut down on illegal dumping and hold those that do dump accountable."

The new online site, which includes the submission form for the rewards program, officially launched Wednesday, Dec. 8.

"There's no longer the excuse of, 'I didn't know what to do with it," Volkmer said. "All of the information is now at the end of your fingertips."
