# Migration: how do they know?

As daylight hours shorten and temperatures drop, a hint of Winter is in the air at Oracle State Park. Summer grasses have turned golden, trails and washes

invite hikers with the promise of less frequent snake encounters, and the birdsong suite includes our visitors from the North who have arrived in search of a milder climate. White-crowned Sparrows with their striking black and white-striped head pattern gather among the grasses to feast on the seeds, their songs unique and melodic. Ruby-crowned Kinglets flit and flick among the trees and bushes hunting for insects, behavior much like our year-round bundle of energy, the tiny Verdins. Three Towhee species, Spotted, Green-tailed and Aberts, are back and strutting their signature shuffle along with Canyon Towhees who are year-round residents at the Park. What a thrill to see all four of these beautiful towhee species in a single outing! And the piercing call of Northern Flickers is a sure sign that it is going to get colder.

And what of our summer regulars? Gone are the Turkey Vultures that often roosted as sentinels near the Park entrance, who gathered in kettles to climb thermals then glide South for warmer climes. Our warm weather flycatchers such as Vermillion and Ash-throated have left, and the through-flyers such as Hammonds and Dusky Flycatchers have mostly migrated. Colorful orioles, chatty kingbirds and swooping swallows have all departed, not to be encountered again until Springtime.

Birds make their migration journeys each year, often traveling thousands of miles, across deserts, oceans and mountains. How do they find their way? Scientists have studied this question for more than 50 years and it's generally accepted that, in part, birds use the sun and stars to guide them, and appear to inherit a sense of direction from their parents. A third sense, magnetoreception, is a bird's ability to sense the Earth's magnetic field which allows the bird to navigate because it senses the direction of magnetic (True) North. For a fascinating article combining biophysical chemistry, quantum-mechanical properties, and the anatomy of birds' eyes, see this this Scientific American article.

Whether "Snow-birds" such as Western Bluebirds, Northern Harriers, and Red-naped Sapsuckers, or heat lovers like Bell's Vireos, Lucy's Warblers and Western Wood-Pewees, amazing migrating birds actually learn and remember the way to places they have visited using sight, magnetoreception and their sense of smell. Let's hope they always find their way back to the Park!
