### Driver survives head-on impact with cow

Just after 7 p.m. on Saturday, Dec. 3, emergency crews responded to a report of a vehicle accident involving a cow near milepost 121 on Highway 77 between Mammoth and Aravaipa.

The Ford F350 had a single occupant and sustained major damage in the collision. Both airbags in the truck deployed and the driver sustained no injury.

"The size of the pickup truck was a substantial factor in this incident and likely saved the drivers life," said Pinal Rural and Medical District Fire Chief Bobby Apodaca.

Highway 77 was closed for a short period while the

pickup truck was towed away and local ranchers removed the cow, which unfortunately did not survive the accident. Highway 77 was opened to all traffic by 8:30 p.m. Saturday night.

On scene were Pinal Rural Fire/Medical District, Mammoth Fire Department, Arizona Department of Public Safety, Hayden Police Department and Mammoth Towing.

### Edward M. Francisco



### Fatal crash closes highway north of Oracle

On Dec. 5, at approximately 8 p.m., a two-vehicle fatal collision was reported on Highway 77 at milepost 106.5 north of Oracle.

According to Bart Graves, Public Information Officer for the Arizona Department of Public Safety, a sedan was travelling southbound when the right tires of the vehicle left the roadway. The vehicle overcorrected to the left, crossing into the northbound traffic lanes. Another vehicle was travelling northbound when it collided with the front passenger side of the first vehicle.

"The driver of the first sedan was pronounced deceased at the scene," Graves said. "The driver of the second

vehicle and a passenger were both transported to a hospital in Tucson with non-life-threatening injuries." He added that impairment was not believed to be a
