## Town of Superior purchases historic high school

The benefits of historic preservation are diverse and numerous. It serves to maintain and celebrate an appreciation of local history and heritage as well as architectural identity unique to the time period.

The importance of preservation efforts is multi-fold. It connects us to our collective past, while serving as a bridge to the future in the form of a physical time capsule. Preservation also provides the ability to revisit these once overlooked artifacts, giving us a strong sense of place and community with the constant reminder of those that came before us. All the while saving time and money by reutilizing resources that are readily available at our fingertips.

For Superior, this historic preservation journey has begun with the Town purchasing the original Superior High School. This iconic facility will become a multigenerational center featuring Town Hall operations, a library, workout facility, dance studio and senior center. The complex will also feature the

Superior Enterprise Center, which will be the home to programming for job training and entrepreneurial development including a commercial kitchen to assist food entrepreneurs.

Developing a multigenerational center was a key strategic goal Superior's council set in 2016 to ensure that the Town continues to invest in and expand Superior's quality of life amenities. The original plan called for constructing a new building, but as costs escalated, the Town pivoted to purchasing this local historic

"We are grateful that Mr. Elijah Cardon agreed to sell this important community building to the Town. As is our tradition, repurposing and modifying materials and places is how we honor and preserve our history, continue to tell our story and embrace the future," said Mila Besich, Mayor for the Town of Superior.

"We also are grateful to Resolution Copper Mine for providing funding to establish a multi-gen center for our community, where residents,

visitors and businesses alike can avail themselves of a broad range of resources for their recreational, educational and training aspirations," she added.


Built in 1925, the historic High School will become a hub for all things Superior, and the historic and important building will once again be accessible to the public. To celebrate the official purchase, the High School will be on the Superior Chamber of Commerce annual home tour on Jan. 29 and 30, 2022. The Town will be maintaining





# Shop Local: Superior UTV Rentals

n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. Copper Area News wanted to give something back to the local business community as a thank you for supporting us through these troubled times. Our newspapers (Copper Basin News, Superior Sun and San Manuel Miner) have been featuring local businesses and non-profits since the beginning of 2021, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, Copper Area News has featured 132 businesses and groups in the Copper Corridor.

When the pandemic first began in 2020, no one could really grasp how the pandemic would affect the local economy or to lifestyles of everyone affected by the pandemic and how the various laws enacted by the government would shift many hobbies and travel patterns. For Arizona the loss of winter visitors, especially those from Canada would be a big worry for tourism based businesses. In the Town of Superior, new businesses actually opened and set their course to open during the early days of the pandemic. The pandemic actually encouraged more outdoor activities and exploration. People focussed on more

localized trips to break up the monotony of staying home and Superior quickly became a day trip and weekender trip for many new visitors to Superior.

Dominic Vannucci and Gina Cavallaro realized that Superior would be an ideal location to start Superior UTV Rentals. The two long-time friends reconnected, having met when they both lived in Las Vegas. Together, they opened Superior UTV Rentals in the fall of 2021, after purchasing the building located at 701 US Highway 60. Superior has become a destination for outdoor recreation, from hiking, mountain biking, four-wheeling and of course the home of the Boyce Thompson Arboretum. It was a natural fit to open an UTV rental store in Superior, Dominic already owned a UTV rental store in Apache Junction, when they identified a building to purchase, they were anxious to open. Until their opening, there was not a business in town to rent an UTV. Gina enjoys riding in the desert and is looking forward to learning more of the trails in town.

They specialize in renting Polaris UTVs, prior to leaving in the rental everyone goes through a safety class and Gina explains the best route, the Montana Mountain loop, which is one of the premier four wheel driving routes in the State of Arizona. They rent the units for half days and full days, which are the best selling packages but also offer multi-day packages. Each unit is street legal so they can be operated on local streets and roads to access trails and of course the local restaurants and retail stores. Each rental also includes the proper safety gear, children under eighteen must wear a helmet while riding in one of the rentals.

Currently they have eight units available



for rent each day. Gina does recommend reservations in advance to ensure they have a unit available but they can often accommodate walk in groups. A deposit on a credit card is required for each rental.

### Superior hosts Little League Baseball and Softball Registration

Guidelines for proof of residency guidelines must be followed in order to register and be eligible for post-season play. Items submitted as proof of residency must be dated between Feb. 1, 2021, and Feb. 1, 2022. One item from each of the three groups is required.

Group 1: driver's license, school records, vehicle records (registration, lease, etc), employment records, insurance documents. Group 2: welfare/childcare records, Federal records (tax, social security, etc.), State records, local records, support payment records, homeowner or tenant records, military records.

Group 3: voter's registration, utility bills (gas, electric, phone, waste disposal, heating, water/sewer), financial records, medical records, home entertainment/work records (internet, cable or satellite). 
