Pinal County Waste Disposal Voucher Program 2021 announced

Pinal County Supervisor Kevin Cavanaugh is pleased to announce that the Waste Disposal Voucher Program will continue to be offered to Kearny, Oracle, Dudleyville, Mammoth, San Manuel, Aravaipa, Winkelman and SaddleBrooke Ranch residents with an increase from three to six vouchers annually to help keep our beautiful communities free from debris and unlawful dumping.

Vouchers can be obtained yearly at the Pinal County Board of Supervisors Office District 1 at 118 Catalina Ave, Mammoth. The office is open Monday to Thursday from 9 a.m. to 3 p.m. and can be reached by calling 520-866-7830 or by emailing bosdistrict1.sharedmailbox@pinal.gov.

The vouchers are valid from January to December 2021 and residents must provide a utility bill or property tax bill including the resident's name and physical address matching the address within the district. A valid ID or driver's license is also required. Residents may present the voucher and deposit trash at the Oracle Transfer Station located at 2100 E. Transfer Station Rd., Oracle, or the Dudleyville Transfer Station located at 8195 N. Hwy. 77, Dudleyville.

Each voucher allows for disposal of residential debris at no charge. One voucher allows disposal of up to 1,000 pounds. If you have any questions, please call 520-866-6685.

Copper Area News is committed to providing our readers with as much information as possible. This graph shows the positive cases as of press time on Jan. 26, 2021. We have also included a graph showing the daily counts for the past week. The state has reported that as of this past week, there has been a decrease in cases statewide. This downward trajectory has not been seen since early September, 2020. Data on January 25 was not available due to technical issues on the ADHS website.

There are a few points we would like our readers to consider when following this data.

- 1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this
- 2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
- 3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
- 4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
- 5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: https://bit. ly/3inh280
