Raymond 'Mony' R. Sanchez



Hayden and Ray varsity teams, men and women, used

the time off to get in some competition practice and play teams they might not encounter in their regular schedule.

Over the holiday break, the Hayden basketball teams were busy competing in tournaments. The boys team played in the 2021 Santa Cruz New Year's Shootout Basketball Tournament that started on

Dec. 27. The Lobos faced off against Tucson's Pueblo High School. Hayden came up short, in this close, 46-51 loss. The following day, the Lobos were able to turn the tides against hosts, Santa Cruz Valley. The game ended with the boys leading the game by a large lead, the final score being 72-39.

On Dec. 28, the Lady Lobos traveled to compete in Epic

Tourneys New Year's Classic presented by Chandler Prep. Right off the bat, Hayden was up against hosts, Chandler Prep. Unlike the boys, the girls were unable to defeat the tournament hosts. However, the Lady Lobos played a close game, resulting in a close 22-29 loss. The girls didn't play again until Dec. 30, against Lincoln Prep. The girls were able to come back from the preceding loss, winning in an even closer game. The final score of the Lincoln Prep game was 23-21. The Lady Lobos were scheduled to play against Skyline later that day, but according to AZPreps365, the game was cancelled for unspecified reasons.

The Ray High School boys basketball team competed in Epic Tourneys New Years Classic, on Dec. 28. The tournament proved to be a tough event for the Bearcats. In their first game, against the Gregory School, the boys suffered a 10-point loss of, 48-58. The following day, the 'Cats went up against Williams. The Vikings were able to walk away with the victory over the Bearcats, the final score being 48-73. On Dec. 30, the last day of the tournament, the boys played two games. The first game of the day was against Red Mesa. The Bearcats were able to keep the score of this game closer than the previous one, but were still unable to claim the win, resulting in a 52-55 loss. Their final game of the tournament was against

Miami. The Bearcats were able to take it to the Vandals, and walk away with a 62-46 win.

The 'Cats and Lady 'Cats will be busy over the next week.



Ten senior centers located in both counties

fall under the umbrella of guidance from the Pinal-Gila Council and are able to offer information, assistance, advocacy and education through a variety of sources, which includes assistance with prescription medicine, housing, rent, utilities, furniture and food among other needs that seniors and residents should encounter in their daily

lives.

The Hayden Senior Center, much like everyone in the country, faces shortages of availability in food supplies and deliveries that Center Director Annie Hinojos seeks every opportunity to insure meal deliveries are continued to the home bound.

The center's dining room

reopened in November to those wishing to eat in or continue to pick up carry out meals. They offered a Thanksgiving meal on Nov. 18.


