

Pinal County Assessor announces that 2024 property valuation notices mailed; how and when to appeal your valuation

The 2024 valuation notices were mailed to Pinal County property owners last week and should now be appearing in mailboxes. If you believe that your property is not correctly valued or if it should be listed with a different legal classification, you have two options:

- File an administrative appeal with the Assessor's Office
- File an appeal with the Arizona Tax Court (check with the Tax Court for fee schedule)

If you choose to file an appeal with the Assessor's Office, please read below for important information before filling out the Petition for Review of Property Value. If you choose to file a case in tax court, please contact the Arizona Tax Court.

To appeal the value of a residential property, use Form 82130R (https://bit.ly/3xnSiGc). To appeal the value of commercial/industrial property, vacant land, agricultural land, or other non-residential property, use Form 82130 (https://bit.ly/3IkrtsB). Please read on about important changes due to Proposition 117.

When filling out either form, you have the choice of requesting an optional meeting to discuss your appeal. Our office will carefully and thoroughly consider your appeal if you do or do not request to meet.

If you would like to appeal your value, please indicate if you are using the market comparison, income, or cost approach to arrive at what you believe is the correct value of your property. We are required by law to use sales data from the previous 2 years when valuing your property, so please use sales, income, and/or cost data from the 2019 to 2020 time frame in your appeal.

For sales comparisons, try to select the most recent sales

of like properties from 2021 and the first half of 2022.

The deadline to file an administrative appeal of your 2024 value is April 17, 2023. You may mail in your appeal or drop it off at our main office in Florence during regular business hours or at the County Annex in Apache Junction on Monday through Thursday from 8 a.m. to 4 p.m., in San Tan Valley on Tuesday and Thursday 8 a.m. to 4 p.m., in Casa Grande on Monday through Thursday from 8 a.m. to 4 p.m., and in Maricopa on Tuesday through Friday from 8 a.m. to 3:30 p.m.

Administration Appeal replies will be mailed no later than Aug. 15, 2023.

If you have not received your notice of value, please use our search page (https://bit.ly/3YRV9CH) to find your property and to check the value for 2024. If you disagree with the value and would like to file a Petition for Review, please follow the steps outlined above.

Proposition 117



Property taxes are calculated based on the Limited Property Value (LPV) and in most cases that amount cannot increase by more than 5% a year. The Full Cash Value (FCV) will no longer have a direct effect on your

State law only allows you to appeal your FCV because the LPV is calculated based on a formula set in statute. When considering whether to appeal your value, check to see if the 2024 LPV is below what you believe to be the correct FCV or market value of your property. If the 2024 LPV is less than what you believe is the proper FCV of your property, winning your appeal will not reduce your 2024 property taxes.



Volunteers needed for Foster Care Review Board

The Foster Care Review Board (FCRB), a program within the Dependent Children's Services Division of the Arizona Supreme Court, is seeking volunteers. Statewide, the FCRB has about 108 Boards and a little over 500 volunteer positions filled by dedicated board members who have a desire to advocate on behalf of children in Arizona's foster care system. In Gila and Pinal Counties, the FCRB facilitates 10 boards which are each comprised of 5 citizens from the community. The Board members are appointed by the Presiding Judge of each county's Juvenile Court.

"We have an urgent need to fill vacancies in both counties," explained Gioia Kaid who works for the Arizona Supreme Court. Currently there are five vacancies in Gila County and 15 in Pinal County.

Foster Care Review Board volunteers commit to meeting one weekday per month to review the cases of children who are in out-of-home care. The meetings are completed via video conference. Each Board reviews its assigned cases until permanency is achieved. As children return home, are adopted, have guardianship granted or age out of the system, new cases are added to the Board's review day. The Board makes recommendations to the Juvenile Court and interested parties involved in the case. Currently, Boards in Gila and Pinal Counties are reviewing the cases of about 900 children. Volunteers receive the training needed to serve in this role.

Jesse Leetham is starting his third term serving on the Foster Care Review Board in Gila County. Leetham is an active member of his community, serving on the Globe City Council and several other boards.

"I enjoy serving on this board, it is a great feeling to help both the children and parents, and be advocates to ensure they get what they need," he explained.

Leetham also explained that the board members receive training and serving on the Foster Care Review board isn't as demanding as serving as a Court Appointed Special Advocate (CASA).

"For those wanting to be service in these roles, but maybe don't have enough time to serve in a CASA role, this might be a better

fit," he explained.

In preparation for a board meeting. volunteers receive court documents and other case materials via a secured website about 10 days before the review date. Board members prepare questions to clarify and gather information with the attending interested parties (case managers, attorneys, parents, foster parents, counselors, licensing workers, Court Appointed Special Advocates, etc.). On the day of the review, an FCRB staff member (program specialist) facilitates the case reviews. Interested parties for each case have an opportunity to appear before the Board and speak about their concerns, successes, wants and needs. The

The two have been in business for three years and opened their storefront at 354 Alden Rd., Kearny just in time for the holiday shopping season.


