# Early voting with Gila County Recorder staff at Hayden Town Hall March 4

In a continuing effort to make 2020 elections as convenient as possible for rural voters, Gila County Recorder Sadie Jo Bingham and her staff have arranged early voting dates so residents of Hayden-Winkelman don't have to drive their ballot to Globe, or vote-by-mail.

Reminder: the only voting happening during February and March is for the Presidential Preference Election March 17, which is limited to candidates of the Democratic party – and open only to Arizona voters who registered as Democrats by the registration deadline Feb. 18.

Check or update your registration conveniently online at servicearizona.com, download a voter registration form at the Arizona Secretary of State's website (azsos.gov) or register at County Recorder Sadie Jo Bingham's Office in the east wing of the Gila County Courthouse in Globe.

Local residents who are registered as Democrats may vote early, and locally, at the Town Hall, 520 Velasco Ave. on Wednesday, March 4, from 10:00 a.m. - 2:00 p.m.

Another innovative outreach effort specific to Gila County residents of the San Carlos and White Mountain Apache lands during this election year: the Gila County Recorder's Office staff includes Edith Starr, who began work as voter outreach assistant and is fluent in Apache. 

# The effects of strike, new realities for local businesses

As the United Steelworkers Strike at ASARCO moves into its fourth month, the local communities closest to the ASARCO operations are starting to feel the pinch. Local residents may already be noticing that grocery store shelves do not have a variety of foods as frequently as they did prior to the strike, business hours are cut back and for some workers their work hours at local businesses have been reduced.

These are all examples of how some businesses are adjusting through the strike. At the municipal level, the Town of Hayden is watching the budget closely; their reserves continue to be taxed as revenues to the town continue to decrease. The Town is considering the possibility of un-incorporating, which will have a trickle down affect throughout the region as the Town of Winkelman contracts with the Town of Hayden for police services. Gila County Supervisor Woody Cline and his staff have been looking at all options to help Hayden stay intact. Should the town be forced to unincorporate, Gila County would have to take over governing the town. At a recent meeting, Mayor Dean Hetrick explained that it will become even more difficult to keep the Senior Center operating at

its current capacity if additional funding is not available. This summer both Gila County and Pinal County provided additional funding to the Hayden Senior Center to ensure the center remains open. Reduced sales tax collection will start to affect each of the municipal budgets in the Copper Basin area, which will force each of the councils to make tough decisions as they plan their next budgets.

Myra Warren from Norm's Hometown Grocery said that the store has had to cut operating hours from 7 a.m. to 8 p.m. Monday through Friday and weekends 8 a.m. to 7 p.m. and fresh produce and baked items have been reduced to once a week deliveries.

"We are able to keep all of our vendors serving the store for now," she said. Warren also explained that while there is a somber tone to everything in town, the store has found ways to support the local striking workers. They teamed up with the Junior Chamber to host a food and toy drive over the holidays to help striking workers and their families. The store offers a 10% discount on the first and third Thursday of the month for every purchase over \$10 and on the second and fourth Thursday they allow the striking workers and their families to spin the wheel for free items with every \$75 purchase.





"We are also donating water, ice, coffee, food and wood to the picket lines," she said.

Over at Old Time Pizza, Gary Birkett shared that while sales are down, customers are still supporting their business and tourism traffic is helping to support their business.

"We have been donating pizza to the Union membership meetings and we offer a discount on food that is going over to the strike lines," he said.


The strike combined with the increase in minimum

wage has forced them to reduce the hours of their staff. As for how long will the strike last, everyone is hoping that the strike ends soon and that there will be a fair contract for workers. Both Warren and Birkett shared that they have heard many of the striking workers are starting to look for new employment or have taken retirement. There is looming concern that if more people take employment out of town, the population will continue to be reduced creating other long term stresses on the communities.


