They thanked everyone for their generosity and support during their stay. Many of the local organizations hosted them for meals or activities. One of the members stated. "This place feels more like home than my own hometown."

The LOST trail alignment is now complete, the entry gates and signage will be installed this week. The Legends of Superior Trails Inc will be hosting a grand opening ribbon cutting celebration on Saturday, April 4. The trail can be accessed from the US 60 park or the Panther Drive trailheads.
