# Kearny Council terminates Town Manager

The Kearny Town Council called a special meeting on Feb. 15 with an agenda item to discuss and or act upon accepting the resignation or terminating the Town Manager Sharon Jakubowski-Wolz.

The council immediately voted to go into a 20-minute executive session to discuss the current status of the Town Manager's contract and to receive legal advice from the Town Attorney, Steven Cooper. Elected bodies can only enter into executive sessions (not open to the public) to discuss certain topics like employment issues, real estate matters, and to receive legal advice that cannot to be divulged publicly.

Following the 20-minute executive session, Mayor Curtis Stacy reopened the public session, allowing for comments from the council on the agenda item. Councilmember David Herrera utilized his time to make allegations that Mayor Stacy had violated the open meeting law, stating that he knew the Mayor had lined

up four votes in advance of the meeting to fire the manager. Councilmember Thomas O'Conner joined in on the discussion with his comments commending Jakubowski-Wolz for receiving a variety of loans and grants to help fund town projects. He expressed his concern that letting her go "would cost the town a lot money, after they had already invested in her."

One of the topics that came up in the discussion was the matter that Jakubowski-Wolz went to a job interview the day before the City and County Managers conference in Sedona. Her interview was with the Town of Dewey-Humboldt. A Facebook post that day showed the agenda of a recent Dewey-Humboldt Council agenda with an item for their council to approve hiring Jakubowski-Wolz.

Councilmember Jackie Jackles, who attended last week's meeting via phone, expressed her concerns that Jakubowski-Wolz had used town resources to attend the interview and also went to other interviews in Oregon, in which she said she would be closer to family.

During the January meeting, Jakubowski-Wolz, asked for a \$15,000 pay raise, which was not approved; instead, the Town department heads, Clerk, Public Works and Police Chief all received a two percent raise.

Mayor Stacy reveled his notes from the situation and explained that he did ask Jakubowski-Wolz if she was happy in Kearny, and did tell her that if she resigned he would do his best to make sure she received her severance package, but he did not align any votes.

"I did tell you," he said to Jakubowski-Wolz during the meeting, "that I don't think I have four votes to keep you."

Newly appointed Councilmember Christian Rios, during his moment for comments, said that he was capable of making his own decisions and he is not being encouraged by anyone in particular on this matter.

Town Attorney Steve Cooper reminded Council that they were given specific legal advice on handling the matter on the agenda and cautioned the council to stay on topic, but after much of the discussion became "he said/she said" responses.

Vice Mayor Bryan Coleman made
a motion to terminate JakubowskiWolz. The motion was seconded by
Councilmember Aleynia Boatman. The
motion passed with a 5-2 vote; Council
members Herrera and O'Conner voted
against the motion to terminate. As per
her contract she will receive her severance
due to the council terminating her. Mayor
Curtis asked Kearny Police Officer Rozzi
to escort Jakubowski-Wolz to her office to
remove personal belongings and turn in
all town keys and other sensitive security

The next agenda item was to appoint an interim Town Manager. Kearny Town Code says that in the absence of a Town Manager the Mayor is in charge of day-to-day managing of the Town. Mayor Stacy explained that he did not want to be in charge of day-to-day operations. Due to limitations within Town Staffing, the Council opted to table the item to a special meeting that was scheduled for Friday, Feb. 17, but the meeting was later rescheduled to Tuesday, Feb. 21.
