

Velasquez sentenced to 20 years for murder of her children

Brittany Velasquez has been sentenced to 20 years in prison after pleading guilty to second degree murder and child abuse in the deaths of her children.

On March 26, 2018, Superior Police were called to her residence in the 100 block of N. Richard Ave. for a report of two unresponsive children. Both children, ages 2 years old and 10 months, were found in the vehicle strapped into their car seats and pronounced dead.

The case was turned over to the Pinal County Sheriff's Office for investigation when evidence at the scene indicated foul play.

At the time, Superior Interim Police Chief Christian Ensley said that the police department has had contact with Velasquez about seven or eight times over the previous two years, one contact in early January 2018 resulting in a report to Child Protective Services. Ensley said CPS took no action on that report.



Velasquez will be on probation for the rest of her life after she is released from prison. She received credit for time served in Pinal County Jail. She remained jailed since her arrest in 2018 and was held on a \$2,000,000 secured bond.

2020 wildfire season one of the worst in a decade

Arizona experiences one of the worst fire seasons in nearly a decade driven by a multitude of factors, including unseasonably warm conditions, a lack of moisture, an overabundance of fine fuels, and increased recreational traffic across the state.

In 2020, 2,520 wildfires burned 978,519 acres of state, federal, and tribal lands. Of those fires, wildland fire investigators say 82% were human-caused. As compared to 2019, 1,869 wildfires burned 384,942 acres on all land jurisdictions. In 2018, 2,000 wildfires burned an estimated 165,000 acres.

Fire managers predicted high and likely extreme fire activity going into the summer due to the overgrowth of fine fuels across the Central region and within the Sonoran Desert. The Arizona Department of Forestry and Fire Management and partnering agencies prepared for the forecasted busy season with additional resources from neighboring states, early arrival of aircraft, and crew prepositioning.

As predicted, fire activity exploded in central Arizona, including across the central Wildland Urban Interface, along Interstate 17, within the Superstitions, southern Arizona, and throughout the Tonto National Forest. The nonexistent monsoon season exacerbated predictions

and pushed fire activity well into the fall with October's 9,537-acre Horse Fire on the Prescott National Forest. The lack of precipitation also kept fire restrictions in place through November.

"This was a historic fire season across the board, throughout the west, from California and Arizona to Oregon, and

Justice of the Peace Nancy Discher retires from office; Board of Supervisors to appoint replacement



The Pinal County Board of Supervisors last week accepted the resignation of Nancy Discher, Justice of the Peace over Precinct 5, and set out the process to appoint a

replacement to see out her remaining term. Judge Discher, who has served the Copper Corridor Justice Court, representing much of eastern Pinal County since January 2015, retired from office effective Jan. 20, 2021.

Judge Discher was a dedicated servant to the people of Precinct 5 over the past six years, implementing a redistricting plan that combined three JP courts into the one Copper Corridor Justice Court.

Judge Shaun Babeu, from Precinct 1's Pioneer Justice Court, paid tribute to Nancy Discher, "Judge Discher has been a friend and colleague for the past six years serving as Justice of the Peace for the Copper Corridor Justice Court. Judge Discher is a dedicated public servant who cared about every individual that came into her courthouse and operated her court in an efficient and effective manner. We wish her well in her well-deserved retirement."

Precinct 5 sits within Supervisor Districts 1 and 4. District 1 Supervisor Kevin Cavanaugh commented, "Pinal County has been blessed to have a person of such incredible talent and integrity as Nancy Discher serving as a Justice. I am sad to see her go and am committed to appointing a person in JP 5 who measures up to her high ideals."

The Pinal County Board of Supervisors are constrained by law on how to select her replacement.

The law that covers vacancies in county offices makes a distinction between whether the vacancy occurs within the first two years of an official's term or afterward. In the case of a mid-term vacancy that occurs after the completion of the first two years of service, Arizona Revised Statute 16-230.A.2 is invoked. This states:

If a county office becomes vacant, the Board

of Supervisors shall appoint a person of the same political party as the person vacating the office to fill the portion of the term until the next regular general election. If the person vacating the office changed political party affiliations after taking office, the person who is appointed to fill the vacancy shall be of the same political party that the vacating officeholder was when the vacating officeholder was elected or appointed to that office.

Judge Discher was elected as a Republican, so the Pinal County Board of Supervisors is only accepting applications from registered Republicans for the Justice of the Peace position, Precinct 5, Copper Corridor Justice Court.

To be eligible for appointment as Justice of the Peace, Arizona law specifies that each potential candidate meets the following criteria:

• Must be a legal Arizona resident living within the Precinct 5, Copper Corridor Justice Court

- Must be registered to vote
- Must be able to read and write the English

language

• Must be at least 18 years of age Interested individuals should take note of the application criteria and deadlines below: Letters of Interest and Résumés by 5 p.m. Friday, Feb. 26, 2021. There is no formal application to submit, and any combination of a letter of interest with résumé and other documents outlining the applicant's qualifications for office shall be emailed, mailed, or submitted in person to: ClerkoftheBoard@pinal.gov Natasha Kennedy, Clerk of the Board Pinal County Board of Supervisors Physical Address: 135 North Pinal Street, Florence, AZ 85132 Mailing Address: PO Box 827, Florence, AZ 85132 520-866-6219

Candidates shall indicate their address, party affiliation, and contact information in their letter of interest.

Title 22 of the Arizona Revised Statutes provides more detail on the duties of a Justice of the Peace.

Man injured in rollover accident

Around 9:30 a.m. on Feb. 1, 2021, Pinal Rural Fire and Medical District crews responded to a reported rollover traffic collision on River Road near milepost 11. The driver was ejected from the vehicle during the collision.

The driver was treated for significant trauma and flown by Native Air to a local hospital in unknown condition. River Road was closed in both directions for nearly an hour for rescue, and while Pinal County Sheriff's Office conducted an incident investigation. It was not readily know what caused the truck to rollover.

Is It Dead, or Just Dormant?

As we wistfully look forward to better days, the National Weather Service is predicting that 2021 will be another dry year. Last summer, the monsoon rains failed to materialize, aside from a very few, lackluster rain showers. The results are concerning. Climb a hill and look around Oracle, and you will see dead and dying trees and shrubs everywhere. In some areas, as much as 20% of the native vegetation has died. Once dead, dry vegetation becomes fuel for fires, and while the Bighorn Fire cleared vegetation in the areas surrounding our town, Oracle itself has plenty of standing fuel. The continuing drought means that Oracle is primed for another dangerous fire season. We can prepare by clearing out dead vegetation, removing lower limbs from living trees to prevent ground fires from spreading to tree crowns, and keeping dry grasses cut short.

Many of you may be wondering – how can I tell if my plant is dead? Many plants go dormant to avoid freezing winter conditions. In addition, desert plants will go dormant in times of drought. Once conditions improve, either from warmer spring weather or improved moisture, buds will begin to swell and slowly open to reveal leaves. Until dormancy breaks, you will need to rely on other signs. The easiest way is to gently bend a small twig or branch – does it bend easily? Or is it brittle? Brittle twigs are dead; if it is pliable, that indicates that it is still alive. You can also use your fingernail to gently scratch through the young bark on twigs – do you see any evidence of green? Pliable twigs and branches with green directly under the bark are still alive. Don't expect dead branches and twigs to regenerate – once the living cells that transport nutrients are dead, they remain dead.

The next problem comes when you try to decide just how much of a tree or shrub is dead – is it enough to remove the entire plant? As a rule of thumb, if the tree or shrub is more than 30% dead, it is unlikely to make a healthy comeback and should be removed. Don't despair, as there are several native plants that will sprout back from healthy roots. Oak trees are notorious for resprouting from the stumps. But don't expect the resprouted stump to grow into a single trunked tree. Usually, the result resembles a shrub, rather than a tree. If your tree or shrub has less than 30% damage, you can prune out the dead parts, and hope for recovery when the conditions are favorable. Remember that pruning stimulates growth and new growth is often frost tender, so try to wait to prune until frost danger has passed, which in Oracle is mid-April. With changing climate, you may find your tree or shrub breaking winter dormancy sooner. This makes it much easier to distinguish dead from dormant and allows you to start pruning. The San Manuel Miners were on the road to Kearny Feb. 2 for a rematch with the Bearcats. Results of those games were unavailable at press time.


Scam alert: text message claiming to be ADOT isn't real; never click on suspicious links in texts and emails

ADOT is working with the Arizona Department of Administration and law enforcement in an effort to protect its customers.






Honoring local law enforcement officers

we are not just talking in terms of data. The extreme drought conditions, excess ground fuel, and inadequate moisture created fast moving, large-scale fires. Under certain conditions, a majority of these fires produced extreme fire behavior that pushed right through retardant lines and created very dangerous situations. This week's recent moisture only helps our drought situation for the short term and residents cannot let their guards down. We need people to be proactive and protect their properties and be fire safe when outdoors," said John Truett Fire Management Officer for the Arizona Department of Forestry and Fire

Management.

It is imperative residents create defensible space around their properties and do their part to help prevent wildfires. Always pay attention to surroundings

when working outdoors, use a spark arrester, and never burn on windy days. Put out campfires completely, secure tow chains, and abide by fire restrictions.

Last year was as one of the most severe and destructive of wildfire seasons, but it was not the worst. In 2011, Arizona hit the million-acre mark in part due to the Wallow Fire in northeastern Arizona. That year, 1,988 fires burned a total of 1,016,428 acres.

Copper Area News is committed to providing our readers with as much information as possible. This graph shows the positive cases as of press time on Jan. 26, 2021. We have also included a graph showing the daily counts for the past week. The state has reported that as of this past week, there has been a decrease in cases statewide. This downward trajectory has not been seen since early September, 2020. Data on January 25 was not available due to technical issues on the ADHS website.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.

2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).

3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.

4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
