Opposition over Fed's proposed changes for military

STATE CAPITOL, PHOENIX - Twenty Arizona State Legislators this week sent a letter to the U.S. Air Force Secretary Frank Kendall expressing their bipartisan opposition to a federal proposal issued in January that would significantly lower altitude limits for supersonic flights and the release of flares

during training. Supersonic flights during military training missions could go as low as 5,000 feet under the proposed changes, down from the current 30,000-foot limit, resulting in much higher levels of noise and disturbance to physical structures for rural communities in southeast Arizona, where

many training zones are located.

The bipartisan letter, authored by State Representative David Cook and signed by 19 of his House and Senate colleagues, also raises important concerns over the release of training flares at lower elevations which, during state fire

restrictions, could present major fire hazards and put people and property at greater risk. The proposed federal changes enable the Air Force to drop flares from 2,000 feet above the ground, rather than at the current 5,000-foot minimum.

Representatives write to express our concern about the U.S. Air Force proposal to allow planes/jets to perform training missions by flying at supersonic speeds at an elevation of 5,000 feet over rural communities in southeastern Arizona. Currently they mi3y not

We believe that training missions are essential to the military in maintaining a "ready" defense but in carrying out these training missions, pilot shoot flares to practice confusing enemy radar in tracking their planes and other objectives.

On June 4, 2021, the day the Telegraph Fire started, Airforce planes were seen over the Tonto National Forest. The fire started in an area that is commonly used by recreationists for camping or hiking. The Forest Service reported the fire was human caused, without providing further detail. However, the U.S. Air Force confirmed that its planes were flying over the forest that day but reported that no plane flew lower than 11,700 feet and that any flare dropped from that altitude would have burned out before reaching the ground. This is still under investigation.

The military should consider conditions related to fire restrictions during the time frames of when local, state and federal fire restrictions are in place and suspend the use of these "flares" or any other munitions that may spark a wildfire in the state of Arizona.

Our state has suffered a number of devastating fires in recent years. We are suffering from one of the most severe droughts in recorded history. It is reckless for the U.S. Air Force to put our communities, citizens, and natural resources at further risk by proposing to fly training sessions at 2,000 feet during which flares could be dropped.

We ask you to bar the use of flares below 5,000 feet in training sessions and not allow their use during fire restrictions when enacted in the state.

"The Air Force will also lower the altitude for supersonic speeds down to 5,000 feet above ground level in the Tombstone, Outlaw, Jackal, Morenci, and Reserve areas, down from 30,000 feet above sea level now."

We ask for you to maintain a level of 25,000 during supersonic speeds.

"Jets that don't break the sound barrier will also be allowed to fly as low as 100 feet above ground level in the Tombstone MOA, and at 500 feet above ground level in the Outlaw, Jackal, Bagdad, and Gladden MOA".

We ask that the military maintain an elevation of 1,000 feet.

APS raises awareness of scams during National Consumer Protection Week

PHOENIX – A knock on the door. An email on your computer. A call on your cell phone. Scammers have many ways to reach you to take your money. As National Consumer Protection Week (March 6-12) approaches, Arizona Public Service Co. (APS) encourages customers to know what to look for and how to avoid being taken.

Spoofing is one common practice to deceive you. Scammers disguise their number to make it appear it is from a known source. In addition to utilities, they spoof the numbers of local businesses, government agencies, even police departments. When you answer, they may threaten disconnection of service within the hour, unless you pay your bill immediately, and often they will demand your bank information or that you pay with a pre-paid debit card. APS will never do this.

Here are ways to protect yourself:
• Never share personal information, like banking/credit card numbers, with an unverified source.

Nearly 300 riders descend on San Manuel for 16th annual Copper Classic

On Saturday, March 5, the 16th annual Copper Classic motorcycle race rolled through San Manuel. Riders from all over Arizona made their way down to compete in the races, with 29% of the riders registering the day of the race.

There was a total of 294 riders registered for the races. All 48 registered mini-bikes competed in their race. Out of the 246

registered big bikes, only 239 riders were on the Moto Tally. The biggest issue the event faced was mechanical problems with some of the riders bikes. Patrick of Peppersuace Motorsports was able to combat this problem by hauling injured riders or broke-down bikes back to the event spot. BHP Copper provided a water truck with 20,000 gallons of water, to help water course sections, to contain dust from getting out of hand.

The day was filled with bike heats taking

off, dust flying in the air, and the loud roar of the engines. As the dust settled, and the day ended, there could only be one rider to take first place. With an overall time of 31 minutes and 29 seconds, Max Gerston was the fastest rider of the event. In second place was Cody Miller, who's overall time was 39 minutes and 45 seconds. Kyler Heimer from the RSMC club took third place, with a time of 41 minutes and 43 seconds, and CTR club rider Alexandru Trapp found himself in fourth place with a

time of 43 minutes and 12 seconds.

"I'm thoroughly exhausted, so it went very well," commented TRS President George Wysopal. "I want to thank Lisa Armenta, and the school for the help. This wouldn't be possible without a supportive community." The event collected over \$700 dollars in camping fees, which will be 100% donated to San Manuel Community Schools, along with a donation from the Trail Riders of Southern Arizona.

San Manuel Miner – January 2006 83 days without rain in San Manuel, says weather girl

As our annual weather report is being compiled for 2005, San Manuel has been without any measurable rain since Oct. 17, 2005, or 83 days without precipitation in the forecast.

The summer so-called rainy season began on July 17 and 6.01 inches fell by its end exactly three months later. That was 42 percent of the year's precipitation of the 10.63 inches, which is well below our 16-year average of 14.32 inches. There was no rainfall in June, November or December.

During the year, there were 12 days of

freezing or below temperatures, with the year's low of 23 degrees recorded on Dec. 6. The high temperature of 104 degrees was hit on July 12, one of the 15 days of 100 degrees or more, all but two of which were in July.

The "weather girl" is frequently asked about her weather instruments, as thermometers and rain gauges in various locations in San Manuel differ from hers.

The "official" thermometer is in the carport and the rain gauge is unprotected on the back fence. The psychrometer for reading the humidity in the back yard records a wet bulb and a dry bulb temperature. The difference between them gives a figure, which is then found on a special chart, giving the relative humidity. Our thanks to Vern Stover Sr. for assisting with the weather reports on three separate occasions.


