

New Geology Trail dedicated at Oracle State Park Earth Day celebration



"Imagine a place at the bottom of an ocean near volcanic offshore islands; or the shoreline of a coastal bay; or a shallow, warm Caribbean like sea alive with shellfish, coral and sea lilies; or volcanic fields dotted with dozens of spewing domes and fissures; or an area covered with faults hoisting land masses 1000s of feet. All of this and much more occurred right here near Oracle State Park over the past 1.7 billion years. Our park and the immediate area surrounding it contain rocks, minerals, and structures that have left a record and incredible story about our past," said Tom Buckley, a volunteer geologist responsible for the design of Oracle State Park's new Geology Trail. "The 1.25 mile geology trail is designed to inspire and further our visitors' knowledge of this unique place. The geology experience can be realized

casually with trailside interpretive panels, or more deliberately through self-guided and geologist-led tours. You can also augment the trail experience by visiting our new rock and mineral exhibit located in the ranch house."

The trail was funded by generous donors, who helped raise \$7,250 for the project. The trail was introduced during last Saturday's Earth Day event, that had a great turnout. The Geology Trail tour was led by Tom Buckley. The event also had a bird walk given by Mary Ellen Flynn, snake encounters given by Picacho Peak State Park herpetologist Dennis Jex. astronomy book talks with David H. Levy and Tim Hunter, music on the trails, and a star party to close out the night.


