At the bottom of the sixth inning, the game was tied 1-1. Luckily, the Lady Miners were able to get 1 more run on the board, resulting in a close 2-1 victory over Santa Cruz Valley. Jazmyne Waddell led the team at the plate with 3 hits and 2 RBIs. On the mound Waddell found 18 first pitch strikes, and 11 strikeouts.



Tri-Community Food Bank adds warehouse,

Mother Theresa once said, "If you can't feed a hundred people, then feed just one."

This is a truth that volunteers at the Tri-Community Food Bank takes seriously.

The food bank, located at 108 Redwood St. in Mammoth, serves more than 300 families or 900 individuals a month. Clients come twice a month. They can take what they want from the lobby, overstock and older bread. Things left over from the thrift store are also available. Clients can also receive assistance once a year for rent or utilities.

Food boxes are prepared in the back of the bank and are based on the size of the family who needs the food. Depending on what has been donated to the bank, extras may be added to the essentials in every food box including hygiene items and sometimes pet food.

Tri-Community Food Bank receives regular deliveries from the United Food Bank, which provides emergency non-perishables. Bashas' donates their day-old bakery items and dairy items. TCFB also spends \$10-12K per year supplementing the donations. Most of the monetary donations comes from the SaddleBrooke Community Outreach. Donations are accepted during hours of operation.

The food bank has served San Manuel, Oracle and Mammoth for many years and recently extended that service to families in Dudleyville. To accommodate the increased client base, a new storage warehouse was built, and a walk-in cooler and freezer were added.

"The Tri-Community Food Bank is an IRS 501(c) (3) non-profit corporation and an Arizona Qualifying Charitable Organization. Our mailing address is PO Box 38, Mammoth, 85618. The Food Bank is an all-volunteer organization," said Rosemary Douglas, public information officer for TCFB.

At the end of the day, after all of the votes had been collected, the winners were announced. Winning the People's Choice was Stephen Argentati. Saraya Dalton






