Gila River Music Festival Set for this weekend in Kearny

The first of this new annual festival is this weekend! Bring a chair and sit, socially distanced, outdoors and enjoy the atmosphere. It is a family event. There is a little bit of something for everyone.

Gila River Music Festival and nonprofit, Arizona Rural Arts Foundation, were established to help with the funding for this event and future events.

The event will begin on Friday, May 21, at Pioneer Park in Kearny, Arizona. The town sits at the base of the majestic Pinal Mountain range and the Gila River runs along the edge of the town. There are tree lined streets, mountain views, a lake, parks, several restaurants, hiking and OHV trails to explore. The festival line up for Friday, May 21, opens with Sydney Swanson, a 14-year-old singer, songwriter and actress, followed at noon by Benjamin Bochenek; 1 p.m. The Floral Ties, an alternative group from Tempe; 2 p.m. Jahlos & The Rebels with a little reggae sound; 4 p.m. Eddie Gutierrez; 5 p.m. country duo Megan & Shane perform; at 8 p.m. Reckless Envy takes the stage to close out the night.

On Saturday, May 22, Ernie Sandoval will kick off the musical entertainment, followed by Tequila Moon's honky-tonk sound; at 1 p.m. Buddy Duke plays some soulful grooves; at 2 p.m. Curt n Rod takes the stage to play some favorites; The Joey's, a fast paced retro rockabilly band play at 4 p.m.; at 5 p.m. Reckless Envy is back up on the stage and that evening, we have the sensational fiddler, Scott Jeffers, with Traveler playing world fusion and closing out the night.

Mobile Homes: Work related to routine maintenance and repair shall be allowed under the Town Code Article 12-3-4. If shall be illegal to reconstruct mobile home units (those built before June 15, 1976) without a rehabilitation permit in the Town of Superior. 1) "A rehabilitation permit shall be obtained from the Department [Arizona Depart of Housing Manufactured Housing Division] before any modification of a mobile home (See A.A.C. R4-34-606, Arizona Administrative Code)." 2) Additions of habitable rooms, accessible structures, storage rooms to a mobile home must be constructed such that they are structurally independent from the mobile home and in compliance with the Technical Codes and a permit issued. B. Manufactured homes: MH installation shall comply requirements of Arizona requirements of Arizona Revised Statutes, Title 41, Chapter 37, Article 3 §41-4001 thru 4010 and Arizona dministrative Code, Title 4, Chapter 34, R4-34-101 thru 805. The references dentified in R4-34-102 shall provide the code requirements for the installation of attached accessory structures. Detached structures shall comply with the Technical Codes. Reconstruction of an MH requires that plans for the reconstruction be submitted and a permit issued. Section B) deleted entirely, Section B (2), (6) and (10) are amended as follows: Foundations: Foundations system manufactured homes and mobile homes not identified by a manufacturer's installation manual are to be submitted for review and approval as an accessory structures submittal. Set upon a permanent foundation, as specified by the manufacturer, and approved by the Arizona Department of Housing, Department Manufactured Housing Division, and that the space at the perimeter, between the home and ground, be enclosed by concrete, concrete masonry units, brick, with required access. Driveway: A driveway a minimum of 9.0 feet width of constructed of asphalt. concrete or dust proof gravel that has clearly defined boundaries. Section B (7) is amended by adding the following text after the last sentence: 7. A carport or garage measuring a minimum of 9.0 feet in width and 18.0 feet in length (an awning attached to the MH can provide the carport area). Section B (10) is amended as follows: 10. Accessory Structures: Building Permits are required for an accessory structure. Plans and calculations submitted by an appropriately licenses person or entity for structures attached as accessory to a manufactured home, mobile home, or factory build building. Plan approval is required prior to installation of the accessory structures that are included as part of the installation.

Accessory structures include the installation, assembly, connection, or construction of any one-story habitable room, storage room, patio, porch, garage, carport, stairs, awning, skirting, retaining wall, solar system or wood decking attached to a new or used manufactured or factory-built home, mobile home, or factor building. Section C is amended entirety by adding new section C: C. All Manufactured Homes Sets: 1. The construction/configuration of exterior (stairs, structures egress handrails, etc.) must comply with the minimum requirements of International Residential Code (Section R311). MHs must have a minimum of two means of egress as required by the 24 CFR Part

3280. Manufactured Home Construction and Safety Standards. a) There shall be a landing at the top and bottom of each stairway. b) The width of each landing shall not be less than the width of the stairway served. c) Every landing shall have a minimum dimension of 36 inches measured in the direction of travel. d) Handrails shall be provided on at least one side of each continuous run of treads or flight with four or more risers. e) Exterior landings, decks, and stairs shall be positively anchored to resist both vertical and lateral forces. f) Where wood or wood-based products/materials are used for landings, decks, and stairs the protection of the material shall be in compliance with R317 of the state adopted International Residential Code 2. For final inspection of a MH set all skirting or foundation elements, required egress elements, required site drainage shall be complete, and all requirements met.
