LeRoy 'Bugs' Lewis

LeRoy "Bugs" Lewis, 86, passed away Saturday May 21, 2022. Bugs was born in Kemmerer, Wyoming, May 17, 1936, to Doris and Leeroy Lewis.

Bugs graduated high school in Kemmerer in 1954 with a basketball scholarship to Casper Junior College and played for two years at Casper. He then transferred to University of Wyoming, playing basketball on a scholarship. Bugs graduated from the University of Wyoming with a Bachelor of Science degree, majoring in physical education and minoring in social studies. After moving to Arizona, he attended Northern Arizona University, obtaining his master's in physical education. Bugs married the love of his life, Loretta Dibler, July 15, 1959. Bugs and Loretta were to celebrate their 63rd anniversary in July. They were blessed with two children, Lana and Larry, both of whom graduated from Ray High School.

Bugs began his teaching career teaching at the junior high level, transitioning to teaching high school. After teaching in Big Piney, Wyoming, for 8 years, in 1967 Bugs and his family moved to Kearny where he taught History, Social Studies and Physical Education. He eventually became the Dean of Students at Ray High School. Mr. Lewis coached football, basketball and track. He was one of the founders of the girls' Meet of Champions track meet. Stage 2 fire restrictions to be implemented across Southern Arizona due to increased fire activity and dry conditions

On Wednesday, May 25, 2022, Stage 2 campfire and smoking restrictions go into effect on state and federal lands throughout Southern and Southeastern Arizona. Agencies entering Stage 2 restrictions include:

• Bureau of Land Management (BLM) Gila District within: Cochise, Graham, Greenlee, Pima, Pinal and Santa Cruz Counties

Coronado National Forest – all districts

• Arizona Department of Forestry and Fire Management for State Trust Lands within: Cochise, Graham, Greenlee, Pima, Pinal, and Santa Cruz Counties.

Beginning May 25, 2022, and until rescinded, the following are prohibited:

• Building, maintaining, attending, or using a fire, campfire, charcoal, coal, or wood stove fire, including within developed campgrounds or improved sites. Pressurized liquid or gas stoves, lanterns, and heaters

with shut-off devices are allowed. When using a portable stove, make sure the area is clear of grasses and other fine fuels · Smoking, except within an enclosed vehicle or building. Smoking is prohibited

in all federal buildings. • Discharging a firearm, including target shooting, except while engaged in a lawful

hunt pursuant to state, federal, or tribal laws and regulations

• Mechanical and industrial prohibitions: operating any internal combustion engine off designated roadways, welding or operating acetylene or other torch with an open flame, and using an explosive.

 Fireworks and exploding targets are never allowed on federal and State Trust Lands.

Violations of restrictions are punishable by fine, imprisonment, or both. Violators may also be held personally responsible for reimbursement of wildland fire suppression costs.

Along with state and federal fire restrictions, local municipalities may also have their own restrictions in place. Residents and visitors should check with their respective county and municipal governments for information on fire Continued on page 10





Oracle Residents Active in 'Being Firewise'

n May 7, the Oracle Firewise and Oracle Fire District held a Free Brush Dump Day for Oracle Fire District residents at Oracle's Brush Dump in conjunction with the National Wildfire Preparedness Day, always held the first Saturday of May. The event was funded by a \$500 grant received from the National Fire Prevention Association (NFPA) and State Farm.

The event was very successful, bypassing

the 2021 number of participating residents by 40. One hundred twenty residents brought in cut, dead vegetation in truck beds, trailers, and dump trucks. Assisting the residents with unloading the brush were national forestry wildland crews from the Coronado National Forest Catalina-Rincon District, and two California crews from Six Rivers and Tahoe. Approximately 20 Oracle Firewise and CERT members volunteered and managed the event. Two evacuation kits designed for a quick evacuation were filled with the basic needs (toiletries, flashlight/batteries, water and snacks) as recommended by NFPA and FEMA. The grant funded these boxes which were raffled to the Oracle Fire District residents who participated. Two recipients were awarded the boxes. One wished to remain anonymous and the other was Oracle resident, Dena Boren with daughter, Nicolette.
