Roadside memorial crosses removed by ADOT

Governor Doug Ducey's Administration and the Arizona Department of Transportation have commenced removing memorial crosses and religious markers from the side

of State Highways. This removal started two weeks ago along State Route 177 and East of Superior on US 60. No notification either personally or via local newspaper was

provided to families of the loved ones who were killed at those sites.

Most families of the deceased consider these memorial sites sacred and holy. When folks questioned ADOT they were notified that they could pick up the crosses and other religious items at the maintenance yard in Globe. When family members went to claim religious items, many of the figurines were found broken and many crosses were

ADOT and Governor Ducey ARE within their legal rights to remove all un-permitted objects from State Right of Way. The issue is that highway deaths have been marked by memorial crosses for almost a hundred years. These crosses also serve as a notice to other drivers to be more cautious while driving. Why is the Ducey administration having them removed now?

The Governor's executive staff has indicated that they will be removing memorial crosses from all rural state highways. Most of our rural highways are in extremely bad condition, seems to me that highway crew's time could be better utilized repairing our roadways versus desecrating sacred ground.



Water Filtration Plant Fixed and Working

am happy to report that the town's water filtration plant is now fixed and tests show that it is working very well. ■ There had been engineering and construction mistakes during the plant's construction several years ago, and untangling the mess was not an easy task.

Some solid particles remain in the line, and such things as testing our fire hydrants will disturb the particles, making the water cloudy. I mention this because a Community Development Block Grant for replacing many of our fire hydrants is now going out for bids. Construction will begin later this year.

Department of Public Safety Sergeant Dave Blue had his last day as Interim Chief of Police for the four towns this past Friday. The financial support from DPS made his time here possible, and for Sergeant Blue's devoted service we give thanks. The four towns, working through an Intergovernmental Agreement (IGA), are interviewing candidates for the interim position. The task force to propose a regional police agency is still working on its proposed structure, which will be taken to all the towns, but this requires several weeks more time to complete. The task force will meet again on Monday, May 16.

Making use of the IGA, Harry Grizzle, Deputy Chief of the Pinal County Sheriff's Office, will be the interim chief for the towns beginning the middle of May. Deputy Chief Grizzle volunteered to serve in this position, which will be funded through Pinal County for a period up to ninety days, and I am very thankful. This should allow the time needed for the task force to complete its proposal.

The Rotary Club is seeking donation of items and services for its planned benefit auction on Saturday, May 14 to support Kearny's swimming pool operations. There will be a steak fry, and there will also be hamburgers and hot dogs and, later in the evening, music.

Lady Cats hold off defending champs; win section title

The then third-ranked Ray softball team entered last Wednesday's regular season finale against then top-ranked and defending State Champion Superior with a chance to win the Section V Championship.

In similar big games during previous seasons, the Lady Cats have been on the short-end of these types of games, but this year has been different as evidenced by their 7-5 victory that made them the Section V Champions and the eventual No.

1-seed in the Division V State Playoffs.

"We played as a team and that's how we won," Ray head coach Rikki Galka said after the game. "We needed this win. We needed this win against this team. It's been a head-game for us since last year."

Player of the Year candidate Stormee Galka pitched six-and-a-third innings, allowing only one run during the first six. But in the seventh inning, the Lady Panthers touched up the Maryville University commit for four runs, leaving a feeling that another heartbreaking loss in a big game was forthcoming.

Rikki new her star player, and daughter,

was tiring so she made the pitching change, calling for freshman phenom Daniella Hinojos to close out the win.

"We needed this win," Stormee answered when asked what it was like to finally break through after several disappointing losses in similar situations. "I know it helps build confidence in our team whenever we beat a team like this because whenever we lose and go into games like this our confidence is low."

Ray jumped out to an early lead by scoring four runs in the third inning off Superior ace Ivie Lopez. The Lady Cats extended their lead in the fifth after Ema Alverado's squeeze bunt scored Janae

Superior answered with a run on an RBI-single by Salcido in its half of the fifth, before Ray scored two more runs to make 7-1 in the sixth.

Ray held a 7 – 5 lead in the Superior seventh with the bases full of Lady Panthers' runners and only one out.

Superior's next hitter flied out right and the runner at third tried to tag up but was thrown out at the plate to complete the game-ending double play.

The loss ended Superior's 15-section game winning streak that dated back to last season.

"This was a good test for us, being down like that," Superior head coach Martin Navarrette said. "It showed what kind of heart our girls (have). I think that's going to be very important going into the playoffs this year."

These two teams are the class of the division and are favorites to meet for the Division V Championship later this month.

Ray won this battle, but the war is not over.

"Last year we went in as the No.5 seed," Navarrette said. "We went through the best teams and we had the toughest road (to the championship). So we've done it once (and) I don't see any reason why we can't do it again."

Central Arizona College students want to keep four-day class schedule

PINAL COUNTY, Ariz. - In response to the proposed switch to a five day schedule presented during the February meeting of the Central Arizona College Governing Board, The Cactus (CAC's newspaper) staff conducted a survey of students.

The pen and paper survey was conducted district wide. It simply asked students if the college should change to a five day week. Students were asked to indicate yes or no, sign their name and provide a reason as to why or why not the change should take place.

Of the 373 students who responded, 309 voted no to changing to a five day week. Students indicated that a change would interfere with work schedules and add a financial burden by having to commute an additional day. Others said the change would take away their day to catch up on homework.

Of the 64 students who voted yes for a change to the schedule, most requested that resources such as the library and learning center be open on Fridays for studying purposes.

CAC currently offers Weekend College classes at the Corporate Center and Superstition Mountain Campus, offering full-time professionals, stay-at-home parents, and



On Wednesday April 27, students at Leonor Hambly K-8 School in Winkelman got to meet with the author, D. A. Lee, of the Time Stands Still Chronicles, a series of science fiction books for children. The 5th, 6th, 7th and 8th grade classes got to meet with Mr. Lee.

"Dennis" D.A. Lee is a former teacher having taught for 36 years. He taught 5th and 7th grade students in the Paradise Valley School District in Phoenix and in Michigan. He is a native of Millington, Michigan.

Mr. Lee's knowledge of the way 5th and 7th grade students think was the reason he made the characters in his series 6th graders about to go into the 7th grade. The book series is about Johnny (J.J.) and Henri (short for Henrietta), two 6th graders who both lost their fathers in a mysterious disappearance two years earlier. Only their grandmothers and Dr. Emory know where their fathers are. Dr. Emory is a 6th grade teacher and mentor with

extraordinary powers. J.J. and Henri receive gifts of a necklace and bracelet that gives them the power to control time. The stories follow them as they grow and learn from their successes and failures through many adventures not realizing that they are preparing for a battle that holds Earth's fate in the balance as well as that of the planet Saros.

You could tell that Mr. Lee was a good teacher as he engaged the students in the discussion of his books and how he wrote them. Most of the kids had read the first book of the series and were familiar with the book's characters. They asked many questions about the books and characters as well as how Mr. Lee came to write them. Whenever D.A. asked a question many hands were raised by the students who wanted to answer.

Mr. Lee told the students that he believes "everybody has a story to tell." He said that you should "believe in yourself and not give up." The students learned that D.A. Lee gave the first names to some of the characters based on people he knew in high school. His hometown of Millington was also used as a blueprint for some of the places in the fictional town of Millville in the book. He gave some writing advice to the students such as how to write dialogue and how he created his characters.

D.A. Lee is also a woodworker and donates wooden cars and trains to charities. He donated a set of the four *The* Time Stands Still Chronicles to the Leonor Hambly School Library. All the kids received a *Chronicles* bookmark and had the opportunity to purchase any of the books for half price. Many of the kids and teachers bought the books including the latest one (book 4) which was not scheduled to be released until the following day. Mr. Lee autographed each book with a personal dedication. The kids enjoyed talking with D.A. Lee and learning about writing. Mr. Lee was leaving for Michigan the following day where he would be talking with more kids at some schools there.



Ray Elementary Pre-K Registration

Ray School District will have its Pre-Kindergarten registration for the 2016-2017 school year on Monday, May 9. 8:30 a.m. - 11:30 a.m. In order to register your child they must be four years of age prior to September 1.
