Manny Guzman V was the special speaker for the 2022 Superior High School commencement ceremony. Below is the text of his speech to the graduates.

Good Evening / Buenas Tardes! I would like to begin by thanking you, the Class of 2022, for the invitation to share a few words at this important milestone moment in your lives. I am humbled and honored to be here with you, your family and friends at the same exact spot where my classmates and I received our diplomas in 1998.

Even though I have been living in Tucson for the past 24 years, Superior is and, has always been, home. Seven generations of family on my dad's side and five on my mom's means that the roots run very deep. It also means that I'm probably related to a few of you.

From an early age, I have been someone who views service to the common good as an expectation and not just a hobby; who can see the trees & the forest (meaning big picture, little picture); and most importantly someone who is grounded in faith and hope.

I do not have this inner compass by accident. It was first instilled in me by my parents who are both Panthers, Class of 1973; my grandparents, extended family & friends and the unique experience of growing up here in Superior, Arizona. Be proud of where you come from, whether you grew up here all your life or have only moved to Superior recently and are graduating from this high school. Once a Panther, Always a Panther. A great slogan, but what does it mean?

It means that we have your back no matter what.

Let's have some Real Talk – your high school years were unimaginably disrupted by a global pandemic. Some of you have experienced profound loss in your families and all of us, me included, had to be reminded to unmute ourselves in Zoom after talking for awhile and then losing our train of thought altogether. A profoundly difficult time for all of humanity, even more so for those without the privilege of access to internet, social services or even medical care.

Just this past week, the devastating killing of elementary school children and teachers in Uvalde, Texas. I have to admit that I had most of this speech written already prior to hearing the news, and I debated even referencing it this evening, but I decided that we cannot and should not look away.



Sí, Se Puede – yes it can be done.......One of my personal heroes is Cesar Estrada Chavez, I first learned about him my junior year of high school when I attended the Cesar Chavez Leadership Institute representing Superior. Sí, Se Puede was and continues to be the rallying cry of the farmworker movement to demand workplace safety like water and bathrooms, just wages and the

removal of pesticides that were causing birth defects in the children of the workers. What's interesting about Sí, Se Puede is that it was not actually Cesar who coined the phrase, it was Dolores Huerta, his sister-in-law and counterpart who is still organizing today at age 92. The phrase was also coined here in Arizona even though the bulk of their action was happening in California. Organizers here in Arizona were facing a slew of laws that punished joining their grape and lettuce boycotts with fines and imprisonment. They were feeling despair and apathy. "No, aqui en Arizona – no, no se puede" – and Dolores responded with a fierce "Come que no se puede, SI SE PUEDE!" – what do you mean it can't be done, YES, IT CAN BE DONE" – and from there the resolve of the people to continue working for the livelihood of

their families was renewed, courage and hope renewed. The United Farmworkers were successful in organizing their boycotts and forcing their corporate employers to give them humane access to shade, water, restrooms and equipment that didn't put such a strain on their backs while picking the food the rest of us enjoy without thinking much about where it came from.

So why is Cesar one of my heroes? I've come to realize that it is because he grounded the work of his life in his deep faith in God. When his fellow organizers started rejecting nonviolence in their approach and were calling for armed retaliation, he fasted for 25 days, only drinking water. When the time came to break his fast, he did it during a Catholic Mass receiving communion.



The action was fasting, but the lesson was that strength comes in many forms – and the strength of our spirit cannot be underestimated, nor should it be neglected.



Run for the school board, join the Optimist Club, coach a little league team, learn how to

Connect yourselves to the traditions that hold our families together. Do you love your family's tamales at Christmastime? Learn to make them alongside your elders or there will be a time when you're having to buy them from somewhere else and they don't quite taste the same. And yes, gentlemen, you need to learn how to make them, too.

These are just a few examples of what I view as part of Superior's legacy. It may look differently for you with other examples, but the call to be renewed in our looking out for one another and preserving our traditions remains. This is vitally important and so is looking forward with hope.

I was on a zoom call the other day with the CEO of Seed Spot who partners with the Superior Enterprise Center for programming and resources, and he mentioned something that caught my attention. Pinal County Public School Districts - The Fabric of Our Community

or over a century, public school districts across
Pinal County have been the fabric that holds our
communities together. The excitement of game night,
sounds of a band or choir performance, civic projects
our students have participated in, fun of Homecoming,
excitement of the Prom, joy of listening to the elementary
Christmas concerts and the pride and excitement anytime
one of our teams competes for a state championship are
just a few of the many ways that our school districts help to
bring our communities together. The pride shown by our
alumni and strong positive bonds between our teachers and
students allow our school districts to be the glue that binds
our communities together and allows our children to have a
positive childhood.

At the same time, as the largest employer in the community, our school districts are critical to the local economy. Eighty percent (80%) to eighty-five (85%) of our budgets go into salaries and benefits for our employees. Research shows that this money has a ripple effect on the local economy and is spent several times over in the community. Our employees, your friends and neighbors, buy homes, have spouses and children working in the community, and shop at our local restaurants, grocery stores and other retail stores. This investment and

reinvestment of the school district budgets in our County is critical for the success of our communities and for the local economy.

This year the Arizona Legislature has an unprecedented budget surplus, and the state is experiencing historic gains in revenue. With over \$4.6 billion in ongoing and one-time revenue our Legislature is in the position to continue to support and build a stronger economy for our local communities and our state. As the Superintendents of the public schools in Pinal County, we believe that the time is right for a historic investment in K-12 education. By providing a substantial investment in public education our Legislature can ensure the continuation of a strong local economy.

Superintendents from around the state are asking for support from the business community, our local governments and our parents for the K-12 Education and Workforce Development priorities. These priorities will provide \$860 million in permanent funding for K-12 education and \$200 million of one-time funding for capital improvements. This \$1 billion investment in K-12 education provides for money to go to the base support level for school districts. What is important about this is that it means that our administrations and Governing Boards can make

the decisions on how to spend the increased funding. We believe that local control is critical in making decisions on how to spend additional funding. Local control is important because we know what is best for the students in our communities.

The educational priorities will also provide additional money for Career and Technical Education to support workforce development in Pinal County. Additional money will also be provided to help with the education of our most vulnerable students. This additional money will go to help students in special education or in areas of high poverty.

Finally, the priorities provide a process for which to address fundamental issues within the K-12 funding formula to ensure that school districts can spend these additional funds. Addressing the Aggregate Expenditure Limit (AEL), exempting Proposition 301 from the AEL and eliminating Proposition 123 spending limits, will ensure that this historic investment in K-12 public education has the maximum positive impact on our students across the County.

Our children are our future. The role of our school districts in creating the fabric that holds our communities together requires a continued investment in our children's education. Strong, healthy school systems means a strong local economy, which supports a strong state economy. Please ask our Legislature to support the K-12 Education and Workforce Development Budget priorities in order to support the local community.

Memorial Day Tribute: Lest We Forget

Memorial Day over the years has become the first official start of summer. Kids are out of school. Most have the day off from work. It's usually marked with trips to the lake, backyard barbeques and local pools opening for kids and adults.

But ofttimes we forget why we have the holiday.

This is the day that has been set aside to remember those men and women who paid the ultimate price for their country, made that ultimate sacrifice.

During war times, small town America has always answered the call to duty. Many of their young men have been killed in action. One of the most extraordinary sacrifices by a small town in America happened during World War II. In the farming town of Bedford, Virginia, population 3,000, 38 young men had joined Company A in the National Guard. Most had joined during and in the years following the Depression for the \$1 a day pay, not anticipating that they would go to war. At the outbreak of the war, they were called to active duty.

On D-Day June 6, 1944, 28 of the 38 sons of Bedford participated in the mass invasion of Normandy, France which would mark the beginning of the end of the war in Europe. On that day 22 of those men would die on Omaha Beach. Most of them were killed in the first minutes of the landing. It was the highest per capita D-Day loss in the nation suffered by one community.

The survivors and the 10 men who joined the fighting a few days later would continue fighting until the war's end. They returned home, some of them physically wounded and most of them scarred emotionally and mentally by their war experiences. Their stories and the stories of their mothers, fathers, wives, friends, family, small town life and sacrifice are told in the book The Bedford Boys: One American Town's Ultimate D-Day Sacrifice by Alex Kershaw.

Two sets of brothers, Bedford and Raymond Hoback and Earl and Joseph Parker were among those killed that bloody morning. Their story along with D-Day, the Omaha Beach landing and the Bedford boys is the history that the acclaimed movie Saving Private Ryan is based. Director of the movie Steven Spielberg would donate a large sum to the construction of a National D-Day Memorial located in Bedford, Virginia which opened in 2001.

The National D-Day Memorial honors those brave men who participated in the invasion and the 4,413 Allied soldiers who died that day in the vicious fighting to secure the beachhead.

On this Memorial Day, we honor those men who once lived in the small mining and ranching communities along the Copper Corridor and made the ultimate sacrifice for their country. May we never forget.

The names were gathered from the internet and community memorials. Where more information was available, it was listed. World War II Army dead were the hardest to find. We apologize if we have left anyone out. We would like to learn their names from family, veteran organizations or friends, so they can be honored. If you have names for us to add to these, please email

BHP Copper to conduct soil sampling in Superior

May 18, 2022 – BHP Copper is working in cooperation with the Voluntary Remediation Program (VRP) at the Arizona Department of Environmental Quality (ADEQ) to conduct soil sampling at selected properties within the town of Superior in an area referred to as the Superior Soil Study Area (SSSA). Soil samples will be analyzed for a range of metals including arsenic, copper, lead, and manganese. Sampling will occur

over three months beginning in June 2022 under a Work Plan approved by ADEQ. Boundaries for the SSSA will ultimately be based on the results of the sampling, but it is expected that this first phase will lead to sampling of additional properties in Superior. All work conducted by BHP Copper is subject to review and approval by ADEQ.

BHP Copper will work with the Town of Superior and



Step 1: Identify an area of interest for your soil sample.

Step 2: Collect soil samples from area of interest.

- If a large area, select 5-10 random spots and collect samples.
- If a small area, randomly select 3 spots to sample.

See table below for sampling depth per spot.

Area of Interest	Sampling Depth (inches)
Garden Area	Collect all soil from surface down 6-8 inches deep per spot
Play or Non- Garden Area	Collect all soil from surface down 1-2 inches deep per spot

Step 3: Mix soil from all spots in a clean container.

Step 4: Remove pebbles, rocks and roots, and air dry. *Do not use a flame or oven to dry the soil!*

Step 5: Transfer 1-2 cups (~0.5 lb) of the mixed soil into a clean 1-quart freezer bag.

Notes:

- Up to 2 samples per person.
- We will accept soil samples until 12 p.m. This will allow time for analysis.
