

Woman drowns in Gila River near Kearny

The Pinal County Sheriff's Office was called to the Gila River near N. Driftwood Way and E. Riverside Dr. on Monday evening shortly after 6:30 p.m. with a report of a possible drowning.

The person reporting the incident said that he and a female were tubing on the Gila River when she went under the water. According to Lauren Reimer, PCSO Public Information Officer, "The male stated he attempted to revive her but was unsuccessful, and the female was deceased."

Reimer said that Sheriff's deputies and local fire crews searched for the victim's body for several hours.

"Loss of daylight, swift water conditions, and thick brush along the riverbank made the search difficult,"

The Arizona Department of Public Safety helicopter was

called in to assist from above.

Around 7 a.m. the following morning, Kearny and Winkelman Fire crews in coordination with PCSO Search and Rescue located the deceased victim on the riverbank. She was identified as 57-year-old Lisa Traut.

"This incident remains under investigation. The Pinal County Medical Examiner will determine the cause of death," Reimer said.










Seniors dominate Miners' bench this season

The San Manuel High School football team is about to begin its 2023 football season.

Continuing his position as head coach is Ernest Ivy, with assistance from David Ward, Kevin Waddell, Manny Laguna, and Pablo Rodriguez. The team is looking big this year with 34 total players joining. The Miners have eight freshman, six sophomores, eight juniors, and 12 seniors this season. The boys had a solid record of 8 wins and 3 losses last season, and with hard work and dedication they can work their way to it again.

During the summer, some of the players competed in a

tournament in St. David. The boys also did the Victory Fundraiser at the Kino Sports Park. Those players were able to test their strength against some bigger division schools, where they showed them how tough the Miners can be. They were able to beat 2A Tanque Verde, and 4A Rio Rico. They were even able to score 17 points on Buena, a 5A school. The boys spent the rest of the summer in the high school's new weight room.

"The kids really enjoy it, I'm happy the school was able to get that in there," commented Coach Ivy, "Anything new, everybody likes. A lot more benches we needed, some good squat racks. We've definitely broke in the new weight room."

When asked who the Miners' main target will be on the

field this year, Coach Ivy stated that Mogollon and St. David are in their sights. In previous years, Mogollon and St. David have proved to be a tough battle for the Miners.

"Our first game coming up is Mogollon. We know it's going to be tough for us, so we have to go up and bring it, or they're going to bring it to us. I'm hoping these boys will be ready. I'm thinking they will," said Coach Ivy.

The Miners will travel to Mogollon on Friday, Aug. 18, to take on the Mustangs. The game is scheduled to have a kick-off of 7 p.m. The Miner varsity team will not have a home game until Sept. 1. The Miner JV team will host Mogollon on Wednesday, Aug. 23, at 6 p.m.


