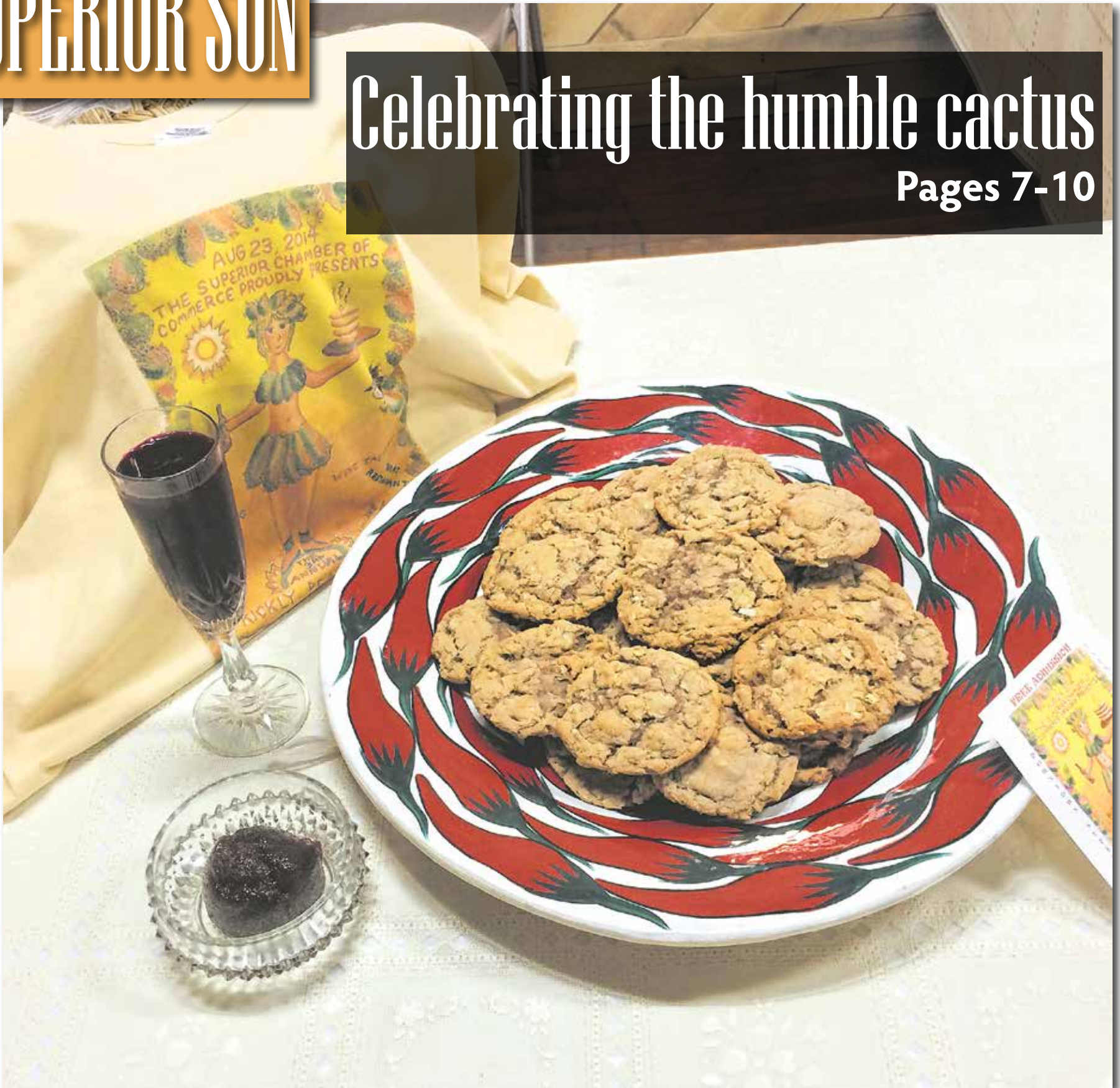

# Hydrology testing to begin on Mary Dr.

Resolution Copper recently informed local residents at a community forum and via mailed letters about the upcoming hydrology test site that will be drilled off of Mary Dr. within the Town limits. The bore hole monitoring will be located on BHP property formerly known as the old rodeo arena.

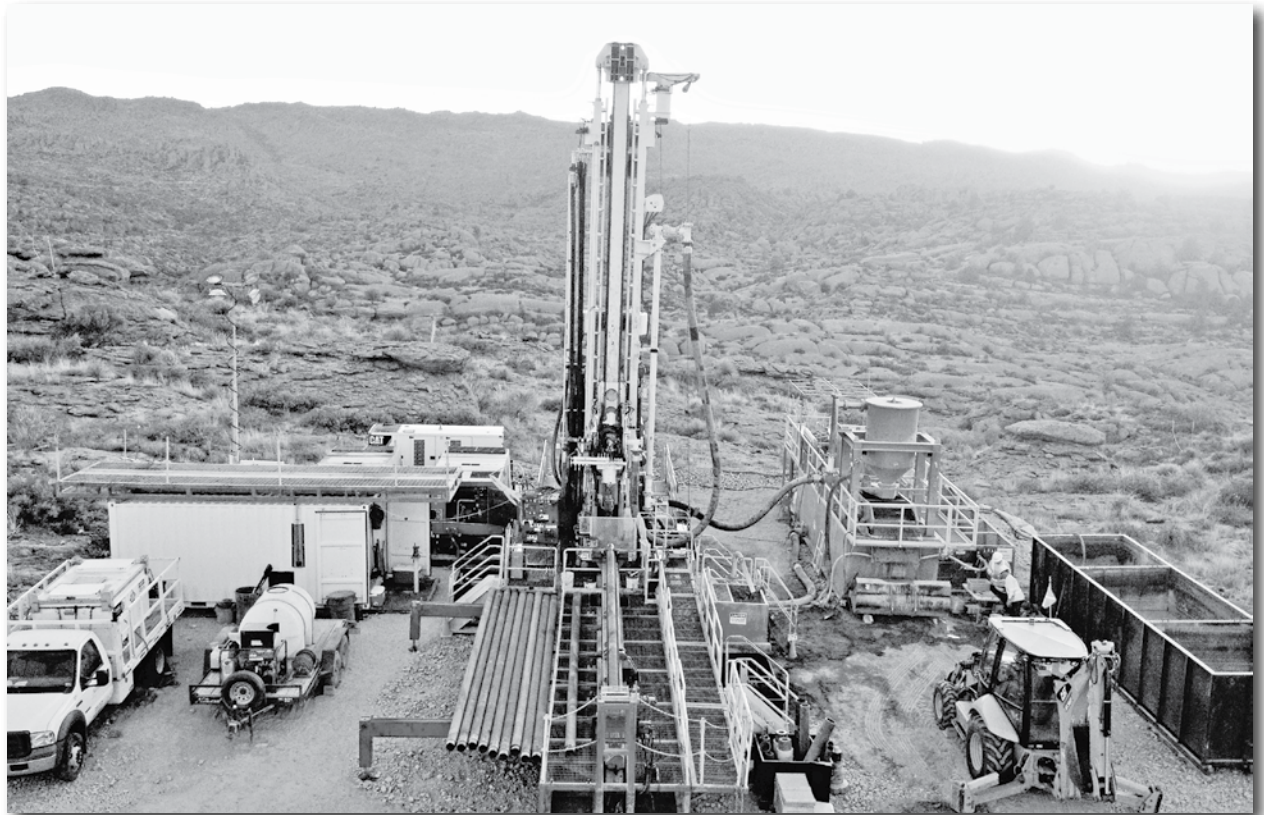
The water monitoring bore hole will allow the company to monitor the hydrology; this is also part of the National Environmental Protection Act (NEPA) permitting process for the project. The NEPA requires that the company do extensive baseline studies and substantive plans for the protection of ground water and surface water. The location chosen will allow the company to monitor both shallow and deep waters in the area to meet the NEPA requirements.

What residents need to be aware of is that the drilling of the bore hole will be a 24 hour a day, 7 day a week operation for about 50 days. A sound barrier wall will be constructed around the rig

and sound mufflers will be installed on equipment to muffle some of the noise. The drill rig will also have lighting that will lessen the light pollution from the rig. It is anticipated that the drilling will end in late September.

Once the well is constructed the monitoring of the water will go on indefinitely. The monitoring site will include a small fenced enclosure to protect equipment and the well head. The monitoring site will include telemetry which will reduce the access requirements.

Construction of the site will begin as soon as permits from the Town of Superior have been approved, which is anticipated to be around Aug. 20, 2014.

# Spend Saturday at the Third Annual Superior Prickly Pear Festival

Are you looking for something to do this Saturday? Have you missed the last two Prickly Pear Festivals, and wondered what it was all about? Maybe you have thought that these little cacti were nothing more than an nuisance and were nothing to celebrate? Come learn more about these cacti and enjoy a day celebrating the many things that are good about our little town of Superior.

Saturday, starts out at 6:30 a.m. with two hike choices; both hikes will include walks through the Tonto National Forest where there is ample viewing of Prickly Pears. The first hike is the annual walk into Pinal City with Tonto National Forest Archeologist Scott Wood. Wood will share historical information on the once famous mining town that was set the foundation for settlement into the area. 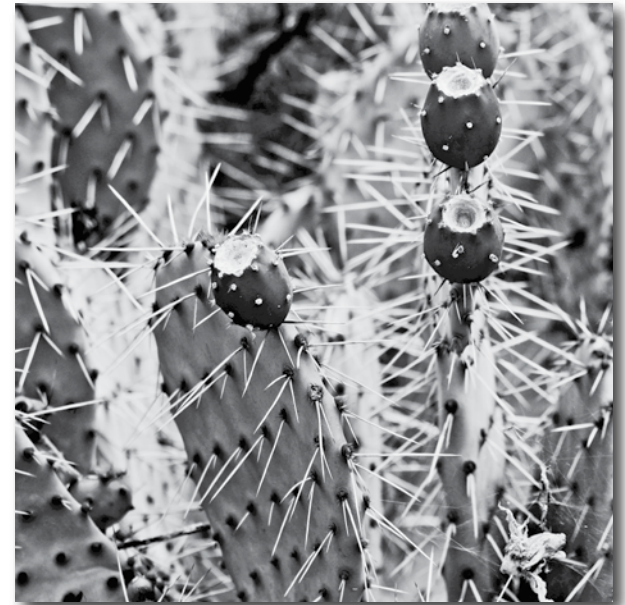



almost any fruit, but will share his fondness for this new wine, and the process, at a free talk at Porter's Cafe. Samples will be available for tasting.

• 1 p.m. – Making mead from prickly pears. This ancient drink gets a modern Southwest twist from Randy Childers, who's made home-made beer for 20 years and has expanded to brew-

ing mead from desert honey, prickly pear juice and a few more ingredients. Learn how from this Gold Canyon expert. The talk, at Porter's Cafe, is free and samples of the finished product, after a year of aging, will be available for tasting.

• 10 a.m. – Harvesting and preparation of tunas and nopales, the fruit and pads of the cacti. Jean Groen, the renowned cook-

book author and desert food expert who draws huge crowds to her demonstrations at the Boyce Thompson Arboretum, and her assistant, Robert Lewis, will show how to safely gather, de-spine and prepare the plants for juicing or use in salads, grilled entrees, desserts and more. The talk, in the Superior Senior Center, 360 Main St., is free.

• Noon – Can prickly pear be effective in treating diabetes, bladder problems and obesity?

Natalie McGee, founder and owner of the Arizona Cactus Ranch in Green Valley, thinks so. McGee was an early convert to the health benefits of prickly pears. She has appeared in national media, including a segment of the Dr. Oz show, and will discuss the growing appreciation in the medical community for the plant's wide health benefits. McGee will speak at the senior center.

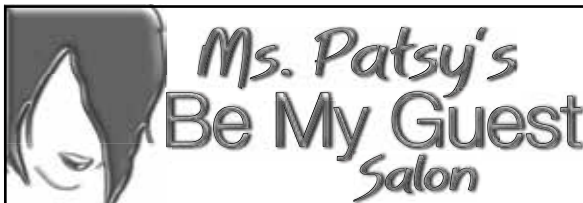

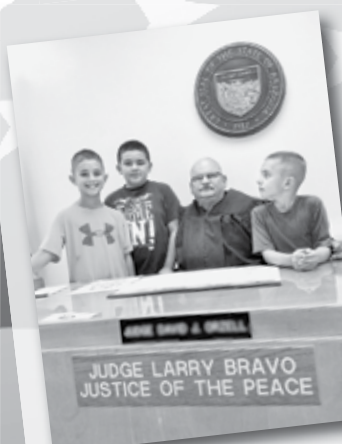

Article V & Article VI: Revises referral from Sections 5.2.A.3 and 6.2.A.3 from Section 13.11 (General Provisions) to Section 3.6 (Home Occupations) and from Section 6.2.B.1 (RV Parks) from Section 13.14 to Section 3.11

Article VIII: Eliminates Section 13.11 (home occupations), Section 13.14 (temporary events or uses) and Section 13.15 (Recreational Vehicle Parks)
