Expect delays on SR 77 between American Avenue and San Manuel Junction beginning Aug. 23



The Arizona Department of Transportation will be paving on State Route 77 between American Ave. in the town of Oracle and Veterans Memorial Boulevard in San Manuel Aug. 23-26.

Work will take place Tuesday through Friday between 5 a.m. and 5 p.m.

One lane will be paved at a time in rotating directions as crews use large milling machines and rollers to grind out existing pavement and compact new pavement.

Tri-Community Food Bank adds warehouse, new freezer and cooler for added operations

Mother Theresa once said, "If you can't feed a hundred people, then feed just one."

This is a truth that volunteers at the Tri-Community Food Bank takes seriously.

The food bank, located at 108
Redwood St. in Mammoth, serves more
than 300 families or 900 individuals
a month. Clients come twice a month.
They can take what they want from
the lobby, overstock and older bread.
Things left over from the thrift store
are also available. Clients can also
receive assistance once a year for rent
or utilities.

Food boxes are prepared in the back of the bank and are based on the size of the family who needs the food. Depending on what has been donated to the bank, extras may be added to the essentials in every food box including hygiene items and sometimes pet food.

Tri-Community Food Bank receives regular deliveries from the United

Food Bank, which provides emergency non-perishables. Bashas' donates their day-old bakery items and dairy items. TCFB also spends \$10-12K per year supplementing the donations. Most of the monetary donations comes from the SaddleBrooke Community Outreach. Donations are accepted during hours of operation.

The food bank has served San Manuel, Oracle and Mammoth for many years and recently extended that service to families in Dudleyville. To accommodate the increased client base, a new storage warehouse was built, and a walk-in cooler and freezer were added.

"The Tri-Community Food Bank is an IRS 501(c)(3) non-profit corporation and an Arizona Qualifying Charitable Organization. Our mailing address is PO Box 38, Mammoth, 85618. The Food Bank is an all-volunteer organization," said Rosemary Douglas, public information officer for TCFB.

Hayden kicks off the season with a 62-0 win over Valley Union

Wow. Wow. Wow. What a game!

The Hayden football team took the field at Valley Union, ready to play after the long drive up to Elfrida. The Lobos were so eager to start their 2022 season that the first play started with Fabian Elvira connecting a 75-yard touchdown pass to Barndon Garner. The Lobos showed their strength on both sides of the ball, dominating from the start with a 16-0 first quarter. By halftime, the boys were up 50-0, scoring 34 points in the second quarter. The second half of the game saw Hayden's JV players getting some time on the field, and that didn't stop the momentum. The game ended with the Lobos devastating Valley Union 62-0.

Hayden's offense had 141 yards passing and 226 yards rushing

for a total of 367 yards. Fabian Elvira was 4-6 with 141 yards passing and 2 touchdowns. His receivers Brandon Garner had 2 receptions for 104 yards and 2 touchdowns, Issac Castillo had 1 reception for 22 yards and Moraes Cruz had 1 reception for 15 yards. Hayden's rushing attack was led by Cruz who had 4 rushes for 73 yards and 2 touchdowns. Deondre Collier had 6 rushes for 57 yards and 1 touchdown, Jando Lorona had 1 rush for 18 yards and 1 touchdown, Jordan Rodriguez had 5 rushes for 22 yards with 1 touchdown, Kino Lorona had 4 rushes for 48 yards with 1 touchdown and Tyler Garner had 1 rush for 5 yards.

Defense was strong all game, keeping Valley Union off the scoreboard. It was led by Dominic Alvarado who had 1 tackle, 2 sacks, 1 fumble recovery and 1 blocked punt. Rene Ochoa had 3 tackles and 1 sack; Andrew Waddell had 1 tackle, 2 assists, and 2 sacks; JJ Aguirre had 1 tackle; Julian Cruz had 2 tackles and 1 assist; Keiston Pool had 1 tackle; Mark Acevedo had 1 tackle, 1 assist, and 1 sack; Angel Moreno had 1 tackle, and 2

assists; Moraes Cruz had 1 tackle; Deondre Collier had 3 tackles; Brandon Garner had 1 forced fumble; Jando Lorona had 1 tackle, and 1 fumble recovery for a 50-yard touchdown; Mathew Armenta had 2 tackles; Izzy Gallego had 1 tackle; Paul Gaither had 1 interception; and Manny Aguirre had 1 sack.

The Lobos have their first home game Friday, Aug. 26, hosting Joseph City with a kickoff time of 7 p.m.

With this start to the season, we can't wait to see where the Lobos go!

APS offering grants to Arizona teachers through 'Supply My Class' program

PHOENIX – Arizona Public Service Co. (APS) is helping local teachers get ready for the upcoming academic year with grants for classroom resources. Marking its fifth year, the APS Supply My Class program will award 500 K-12 Title 1 public or charter schoolteachers with \$500 grants.

The tool is designed to pop open car doors, spread open a vehicle where needed and has the capability to cut the vehicle open to allow the victim's evacuation. The acquisition of the "Combi" provides our rescue team with a "first on scene" tool for all of emergency medical roadside needs in the area.

The best part of the "Combi" is that it weighs about 60

pounds with the spreader attachment and it runs on a battery with a 2nd battery back up. It's a cool 36 inches long with its spreader tips but without the tips its less than 35 inches and about 5 pounds lighter. Some other highlights include a rotating handle to really get to those hard-to-get cuts as well as plenty of lights for night work and tool status.
