Mammoth and the R/O Unit ... \$1,000,000?

Many years ago I drank reverse osmosis water almost exclusively, believing that it was the best drinking water. However, since then I have discovered (through personal experience and research) that the health disadvantages outweigh the advantages.

As far as I can tell, there is only one health advantage R.O. water has over tap water—and that is that the R.O. system does remove some unhealthy contaminants.

A good R.O. system can remove contaminants such as arsenic, nitrates, sodium, copper and lead, some organic chemicals, and the municipal additive fluoride.

Disadvantages

You might be interested to know that reverse osmosis was actually developed as a water treatment method over 40 years ago. The process was used primarily to de-salinate water.

The following are three of the main disadvantages of drinking R.O. water:

1. The water is demineralized. Since most mineral particles (including sodium, calcium, magnesium, magnesium, and iron) are larger than water molecules, they are removed by the semi-permeable membrane of the R.O. system.

Even though you may find some contradictory information online about the health benefits of reverse osmosis water, I am convinced that drinking de-mineralized water is not healthy.

The World Health Organization conducted a study that revealed some of the health risks associated with drinking demineralized water. Just a few of the risks include gastrointestinal problems, bone density issues, joint conditions, and cardiovascular disease. See reference below to review the WHO study online.

Removing the naturally occurring minerals also leaves the water tasteless. Many people thus have to add liquid minerals to their R.O. water to improve the taste.

2. The drinking water is acidic. One of the primary reasons R.O. water is unhealthy is because removing the minerals makes the water acidic (often well below 7.0 pH). Drinking acidic water

will not help maintain a healthy pH balance in the blood, which should be slightly alkaline.

In the natural health and medical communities, acidosis in the body is considered an underlying cause of most degenerative diseases. Live ammo found at brush site

During the past 10 years, the Oracle Fire Department has been managing the Oracle Brush Disposal Site as a way for Oracle residents to easily dispose of flammable yard clippings and dead trees. Over the years we've encountered numerous items that simply do not belong in piles of brush that will eventually be burned. When people dump such things as household garbage, old lumber products, construction debris and other non-allowable items (clearly posted at the entrance gate) they cause our firefighters to have to dig through the piles, collect garbage items and then dispose of them in the fire department dumpster.

In the past we have occasionally gotten such large items that we've had to haul loads of garbage and other waste materials to the Oracle Transfer Station operated by Waste Management Corp. Although our staff tries to regulate what gets brought into the brush site, occasionally people abuse the rules by dumping things that clearly don't belong there. A few of the offenders have been permanently banned from using the brush disposal site and for the past couple of years garbage has not been much of an issue.

Recently an alert citizen reported to us that bullets were seen lying in the dirt along with the brush. My firefighters then had to do a search for those bullets and hopefully they were able to find all of them.

The on-duty crew returned to the fire station with around 30 live rounds of ammunition that ranged from small 9mm, to .45 caliber, to assault rifle rounds, to large hunting rifle bullets. All of these items were unspent live rounds of ammunition that could have the potential of injuring firefighters during our next brush burn.



Although an exploding bullet during a fire, has a much different and generally lessor reaction than a bullet secured inside of a rifle chamber, they can still be hazardous to anyone in the near vicinity.

Burning huge piles of brush presents us with a number of hazardous conditions, including smoke & embers, heat exposure, desert critters, etc. Extinguishing such a large fire requires a great deal of physical energy including getting right in with the ashes and turning over the unburnt material. It's extremely hot, dirty and physically demanding work... and now our firefighters have to be concerned about live ammunition exploding when they are working the burning piles.

Please help us to manage and to continue this important community program by being careful about what is in your load of brush.

ASARCO plans \$100 million upgrade of Hayden smelter to meet new EPA sulfur dioxide emission limits

Project not expected to disrupt operation of plant or employees' hours

Plans for a \$110 million upgrade of the Hayden copper smelter that will bring the apparatus in compliance with new federal regulations concerning emissions of sulfur dioxide (SO2) have been filed by owner ASARCO/Grupo Mexico with the Arizona Department of Environmental Quality (ADEQ).

The rules issued by the US Environmental Protection Agency (EPA) require that SO₂ emissions from the smelter be reduced from 140 ppb (parts per billion) to 75 ppd during a 24-hour period. The Hayden smelter has until Oct. 3, 2018 to meet this standard.

Meeting the standard is important to keep the Hayden copper smelting plant operating and providing employment for residents of the Hayden/ Winkleman area.

To meet EPA's goal, the plan ASARCO filed on June 24 with

ADEQ describes a converter retrofit project that will replace the smelter's five current 13-ft. diameter converters with three 15-ft. diameter converters. Also included in the plan are the installation of improved primary and secondary hoods, and an electrostatic precipitator for solids removal prior to SO₂ recapture at the smelter's existing acid plants. Larger ladles (300 cu. ft. instead of 200 cu. ft.) will be installed to reduce the number of hot metal transfers. Additional upgrades will capture secondary gases and direct them to the acid plant for conversion to a sulfuric acid product.

Overall the plan aims to reduce SO₂ emissions at the Hayden smelter by 85 percent, with a total SO2 capture rate of 99.7 percent of what is produced during the copper smelting process.

The plans were made public during a meeting of the

Arizona House Committee on Energy, Environment and Natural Resources held Aug. 22 at the Gila Community College Pueblo Campus in Globe.

ADEQ is expected to rule on the ARARCO plan by late September. If approved the plan will then go to EPA for an additional 45-day comment period. With EPA approval, ASARCO could begin work on the upgrades before year's


Work on the converter retrofit will be performed as to not disrupt the operation of the smelter and keep all employees working their regular daily schedules, said Krishna Parameswaran, director of environmental services and compliance assurances at ASARCO. The smelting plant must operate within the EPA emission limits by Oct. 3, 2018.

The smelter and surrounding operations are an important parts of the Hayden economy.

It employs 1,400 hourly and salaried workers, who are annually paid \$140.8 million in wages, salaries and fringe benefits. The operations also generate \$28.6 million in property, severance and sales taxes. The company annually generates spending of \$345.8 million on materials, fuel and supplies into the Arizona economy.

Each year the Hayden smelter produces more than 300 million tons of copper that is important in all electri-

Copper Corridor getting its turn to participate in Pinal County Workforce Assessment Survey

Residents of the Copper Corridor are getting their turn to take part in the Pinal County Workforce Assessment Survey.

The Pinal County Economic Development Program (EDP) has announced that the survey went online on Aug. 20 and invites all citizens in the area that includes Superior, Kearny, Winkelman, Dudleyville, San Manuel, Oracle and SaddleBrooke to participate. By answering the questions and telling Pinal County what jobs skills they possess, the county can better promote businesses to relocate here and create new jobs within a shorter commuting distance, said Tim Kanavel, EDP manager.

Drafted and conducted by San Tan Valleybased Strategic Research Initiatives (SRI) LLC under contract with EPD, the survey has already been successfully conducted among residents in the county's northwest pocket encompassing San Tan Valley, Apache Junction and Gold Valley. According to Tim Grainey, SRI member manager, questions asked on the survey include the level of education reached, if residents are homeowners or renters, why they moved to their current community, what they like and dislike about the community, and what their job ambitions are.

Although EDP planned to conduct the Workforce Assessment Survey is five steps, each targeting a segment of the county in successive six-week periods, it decided to first assess the survey and its results to see if it was getting the data it wanted. In the period from late May to early August, EDP and SRI determined that the survey was providing the desired results and was easy for participants to complete. The survey thus wouldn't be changed for the other four county areas.

But to make up for lost time and complete surveying all county residents before Christmas, the Copper Corridor segment and the Central Pinal segment covering Florence, Coolidge, Eloy and Arizona City would be conducted at the same time. In mid-October, the two remaining segments for the areas around Casa Grande and Maricopa will finally be invited to visit the survey's website, Kanavel said.

"We can keep the Copper Corridor and Central Pinal survey results separate by sorting by zip codes," Kanavel explained. "We already did that for the Northwest Pinal segment when we weeded out respondents from Queen Creek, which is mostly located in Maricopa County." The reason behind the survey is rather basic, he added.

"When EDP reaches out to businesses that could potentially relocate or set up shop in Pinal County, one of the first questions they ask is, 'How is your workforce? Do you have people with the skills we will need ready to recruit and hire?" Kanavel said.

"With the survey, we have those statistics ready to share," he concluded.

Once EDP knows what job skills are possessed by residents in specific areas of the county, it can target specific types of businesses to that area.

"Results from the San Tan Valley/Apache Junction/Gold Valley survey surprised us," Kanavel said. "We weren't expecting that so many residents would have skills needed by high tech and medical businesses. Obviously we will promote those types of businesses to that area rather than manufacturing."

The survey also found that the population in Northwest Pinal was relatively young (average age in the mid-30s) or that 40 percent of residents would have at least a high school diplomas with many having some college and possessing college degrees. This, Kanavel said, is attractive to potential employees along with Pinal County's relatively low taxes, plenty of undeveloped land, warm winter weather and

a plethora of entertainment and recreational assets. Kanavel is excited to see results of the Copper Corridor survey. While the population changes in that county segment haven't been as dynamic as in other areas,

in the more southern sections like Oracle and San Manuel some residents commute into Pima County for their jobs and likewise would welcome new job opportunities inside Pinal County that don't require as long of a trip to reach. And the area is in need of additional employment opportunities.

According to Grainey, the survey can be completed in under 15 minutes. Because the growth in parts of Pinal County has been so dynamic since 2002, EDP plans to conduct additional Workforce Assessment Surveys are regular intervals in the future; perhaps as early as 2017. Kanavel said.

cal products, electronic equipment, and even bringing electricity to homes, according to Kelly Norton, president of the Arizona Mining Association. The smelter also products more than 575,000 short tons of sulfuric acid each year.

Although originally built in 1912, the Hayden smelter has been expanded and upgraded on a regular basis, with the last major renovations taking place in 1989 and 1996. In 2012, ASARCO voluntarily undertook a \$10 million project to reduce lead emissions through the addition of a monitor system to keep lead emissions to within EPA rules issued in 2008 that trimmed allowable emission levels to one-tenth of the former standard.

The EPA-required Hayden smelter renovation projects comes only a step behind a more expensive project for the smelter in Miami owned

by Freeport-McMoRan. Budgeted at \$450 million, the Miami smelter will receive new converter mouth covers, converter aisle canopy hoods and aisle scrubbers, an anode plant bag house and a smelter furnace upgrade to meet EPA SO2 emission limits.

Freeport-McMoRan received its permit on July 21 and has begun renovation work that could be completed by the end of 2017. The Miami smelter, which was originally built in 1915, also has undergone numerous upgrades, expansions and renovations in the interim.

Norton emphasized at the meeting that copper smelting is an important contributor to the Arizona economy. At present there are only three copper smelting plants in the US and two are in Arizona (Hayden and Miami). The third is in Salt Lake County, UT, Norton noted.




