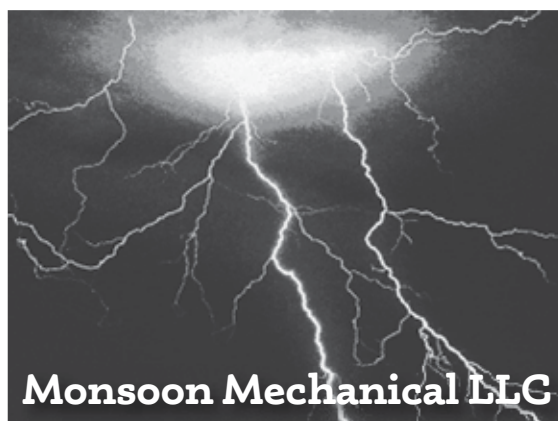

LETTER TO THE EDITOR

Rural Arizona Redistricting and the 5 Eastern Counties

Many of you are learning about this redistricting issue for the first time. It happens every 10 years following the national census. In Arizona, we have a commission appointed to draw the new districts for Congressional and Legislative districts in our state. We citizens have an opportunity to have a say with the commission, and so we must make every effort to make sure our voices are heard. I want to give a quick update on the public hearing already held by the Commission, the upcoming hearing in Safford, and what we all can do still on this matter.

First of all, in the 2001 redistricting, rural Eastern Arizona was given a voice in the legislature with the

5 Eastern Counties District: Gila, Graham, Greenlee, southern Navajo and Apache. In the 2011 redistricting, we proposed keeping our rural 5 Eastern Counties district, and adding the Copper Corridor and the Verde Valley to it. 15 of our rural cities/towns adopted unanimous resolutions supporting this proposal. Sadly, the unsympathetic commission ignored us and splintered our region into several other districts, often joining us with urban and metro areas. In 2021, we again are advocating to a new commission to re-unite the 5 Eastern Counties and once again add to us the Copper Corridor and the Verde Valley. The 5+ Eastern Counties proposal. Public hearings have already been held throughout our

region.

In Florence/Superior, citizens of the Copper Corridor (Superior, Kearny, Hayden, Winkelman, Dudleyville, Mammoth, San Manuel), spoke overwhelmingly of restoring a rural district. I had the chance there to introduce the 5+ Eastern Counties proposal and people afterwards expressed surprisingly strong support of the idea, one saying that it made the most sense of any mentioned that night.

In Egar/Springerville, I was not present, but I had it reported to me that uniting the 5+ Eastern Counties was the strong message given by citizens attending.

supporting children at risk of being left behind; and

- \$50.9 million in new funding to strengthen veterans' health care programs.

Also included in the package were initiatives O'Halleran championed, such as

- \$49 billion for the National Institutes of Health (NIH);
- \$10.6 billion for the Centers for Disease Control and Prevention (CDC);
- over \$907 million for rural broadband to expand service to provide economic development opportunities and improved education and healthcare services, including \$800 million for the ReConnect program;
- \$5.66 billion for Wildland Fire Management, which

includes \$2.45 billion in cap adjusted fire suppression funding;

- and \$4.14 billion for the Forest Service;
- \$8.1 billion for the Indian Health Service;
- \$307 million for Rural Health Initiatives;
- \$621 million for Opioid Abuse Prevention;
- \$97.6 billion for Veterans Medical Care;
- \$61.8 million in funding for scientific and regulatory work on per- and polyfluoroalkyl substances (PFAS), needed to establish drinking water and cleanup standards;
- investments in infrastructure to help rural areas of the country access basic utilities, including \$1.45 billion for rural water and waste program loans and over \$716 million in water and waste grants for clean and reliable drinking water systems and sanitary waste disposal systems, which will provide safe drinking water to millions of rural residents.
- and an additional \$7.195 billion in loan authority for rural electric and telephone infrastructure loans.

In Show Low, Lakeside-Pinetop: I attended along with roughly a hundred people. The 5+ Eastern Counties was supported by citizens over and over again. One gentleman had the good sense to submit a printout of our map proposals to the commissioners.

In Payson, Globe-Miami, it was very frustrating. The commission scheduled the hearing for Sunday at 10 a.m. Predictably, extremely few attended, most being in church during that time. I was the only one to speak of the four in attendance at Globe. A few spoke in Payson. Everyone echoed the desire for a rural legislative district and how unacceptable it is to have little Gila County split into 3 different legislative districts.

Up next, the commission will hold a hearing in Safford and Clifton. This is the last stop in Eastern Arizona for

this tour. I will be attending and it is important that you email everyone you may know in the Gila Valley. Attend the meeting and voice your support for restoring the 5+ Eastern Counties.

Friday, Aug. 6, 2021 at 5 p.m, Graham County Assembly Room, 921 W. Thatcher Blvd., Safford, AZ 85546. Remotely at: Greenly County Courthouse, 253 Fifth St, Clifton, AZ 85533.

Northeastern Arizona spoke loud and clear about the 5+ Eastern Counties. Central eastern AZ spoke strongly of the creating a rural district. We need Southeastern AZ to bring it home with an overwhelming turnout and echoing 5+ Eastern Counties!

We have two map proposals for the commission to consider. One includes the San Carlos and White Mountain Apaches in our district. The other places them with the Navajo. In the second, it is designed with an uninhabited strip of land where all the reservations can be combined and still allow our rural communities to be united. That is a decision to be made by the people of each tribe of where they want to land. If you have any tribal connections, please reach out to them.

C. Community Description: 5+ rural Eastern Counties: Gila, Graham, Greenlee, southern Navajo and Apache,

San Carlos & White Mtn Apache nations, Copper Corridor (Along SR 77/177: Superior to San Manuel), Verde Valley (Campe Verde etc.). We are natural resources focused, mining, farming, ranching, timber, tourism/recreation. Large amounts of National Forest and limited private land, making our issues of education, water, power, federal land management unique and focused. 5+ Eastern Counties: rural and natural resources focused.

D. Additional Comments: Our region transcends partisan, racial, and gender in local and legislative elections. Our survival depends on navigating common issues in ways that are unique to rural Arizona. The vast majority of our area is federal public lands and tribal, leaving a very small percentage as private for economic development and taxation. From the years 2000 to 2010, the 5 Eastern Counties had a voice in the legislature. In 2010, 15 cities and town across the 5+ East Co.'s, unanimously adopted a resolution to keep 5+ East Co.'s united. That was ignored and we were splintered among the four winds. In 2021, please re-United the 5+ rural Eastern Counties.

We are considering another campaign of resolutions from our Counties and Cities/Towns. We will need people in every community willing to get that on their County's/Town's agenda for adoption. Stay tuned for that!

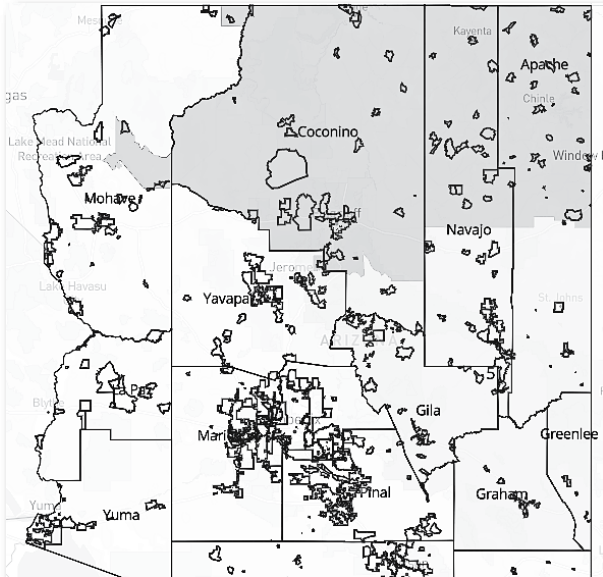

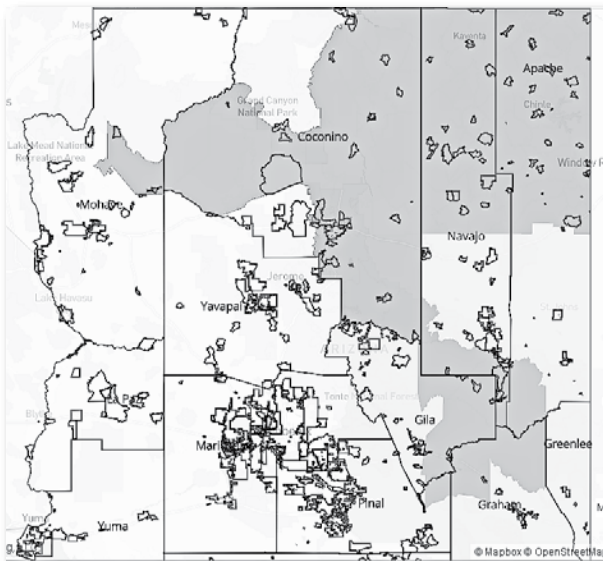

Police Chief to train in Florida; PCSO Lieutenant at the temporary helm

There will be a new person at the helm of the Superior Police Department.

But only temporarily.

Superior Police Chief Frank Alanis has left the department in the capable hands of Pinal County Lieutenant Adrian Leos while he heads to Florida to attend the Senior Management

Institute for Police (SMIP) Session 78.

"I was originally scheduled to attend in 2020 but due to COVID it was cancelled," Chief Alanis said.

The three-week course gives police chiefs and other senior police executives intensive training in the latest management concept and practices used in business and government, Alanis explained. The course is limited to 30 participants which lends well to their

discussions of the most challenging issues facing law enforcement executives today.

Classes are usually held at Boston University, but due to COVID restrictions on the campus, the location was changed to Orlando, Florida, a "hardship" Alanis said he'll endure.

Alanis assured that the taxpayers of Superior will not be shouldering the expense of this class and trip. Existing RICO funds seized from criminals will be used to fund the trip.

With a police department as small as Superior's, this three-week trip would have left the department short-handed and without a leader. Chief Alanis wanted to put someone in charge in his absence who could use the experience as a learning tool.

The Superior Police Department, Alanis explained, has become a "mentoring agency," a place for officers to learn. When Alanis was accepted into this year's class, he decided to ask the Pinal County Chief Deputy Matt Thomas for a suggestion and let them use it as an opportunity for young leaders to step up and take command. Thomas suggested Lt. Leos.

Leos has served with Pinal County Sheriff's Office for 20 years. He began as an 18-year-old serving as a detention officer and going on to serve as a patrol deputy, gang detective and narcotics detective. In 2014, he was promoted to Patrol Sergeant and now serves as the Lieutenant in charge of the "Charlie" division in Western Pinal County. He comes from a law enforcement family. His father and uncle are law enforcement. Better still, Leos is a native to Pinal County, born and raised in the Picacho area.

Leos said he's already seeing the great opportunity this is affording him. He spent the week leading up to the Chief's departure learning how to put a department budget together, calling it "great first hand experience." Leos explained that in a department as big as PCSO, rarely if at all do command officers have the responsibilities of budgeting for the department.

Alanis called this time a "great tryout," explaining that he wants a good plan for succession in the eventuality of his retirement from the department. "I want nothing but the best (for the department) for years to come," he said.

In April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. *Copper Area News* wanted to give something back to the local business community as a thank you for supporting us through these troubled times. One of those industry sectors was indoor gyms and athletic facilities. For a small town like Superior, it is a unique community amenity that a 24-hour gym exists, let alone survived the pandemic and all of its economic implications.

Anthony Torres and Marisa Rodriguez, started their gym in Superior after Anthony began doing cross fit /bootcamp style classes outside at the John F. Kennedy school. He had some residents of Superior who would travel to the Valley for his classes as well and before he knew it, the demand grew and he opened his first gym in Superior on Highway 60. He could of opened a gym in the valley but he and his wife Marisa decided to give Superior a chance, they also knew in the valley, it might be harder to find a niche amongst all the other gyms. Anthony and Marisa have five children, and moving to Superior has been good for their family, you may often see their kids helping with tasks at the gym.

Their original location, the big tin building, didn't have air conditioning or heating, but his customers still joined his gym and they started their Cross Fit style classes. As their gym membership grew, they knew they would need to expand into a facility that had heating and cooling.

They eventually moved the gym to 180 Main Street and changed up the equipment offerings to attract clients who wanted something more than a Cross Fit gym experience. Membership for the gym is \$40 per month; there are no contract fees associated with membership. Once a member joins, Anthony will provide an orientation and overview of the gym and each member has a key code to visit the gym, 24 hours a day, seven days a week.

Knowledge of modern principles and practices of professional library work, library organization, materials, services and equipment; knowledge of principles and practices of categorizing, classifying and processing library materials; knowledge of the principles and techniques of management, supervision and training; knowledge of principles and practices of grant writing and grant administration. Ability to plan, organize, direct and supervise functions of the Public Library system; formulate, implement and evaluate policies and procedures for library programs and services; prepare a variety of reports; analyze existing services and develop improvement plans related to community needs.

PHYSICAL REQUIREMENTS:
