Amos J. Cline Jr.


Amos J. Cline Jr., 91, died peacefully on June 5, 2020 in Hospice care. He was born April 15, 1929 in Twin Branch, WV.

Voucher increase announced by Supervisor Rios

Supervisor Pete Rios is proud to announce the increase of dump vouchers for Eastern Pinal County residents from 3 to 6 per calendar year.

"I continually advocate for these services in the Eastern communities. The vouchers are free to Pinal County residents and I highly encourage everyone to take advantage of them. I also hope it encourages people to not partake in wildcat dumping and care for our land," said Supervisor Rios.

Residents are reminded that in order to obtain vouchers they must present the supervisor's office with a current utility bill that includes name and physical address. Please note that vouchers will not be issued without proper documentation. Those individuals who own more than one residence may only obtain vouchers for their primary residence. Vouchers are redeemable at the Oracle Transfer or the NEW Dudleyville Transfer. Vouchers will be issued according to the name that appears on the utility bill and that person must be present when redeeming the vouchers.

These additional vouchers can be obtained at the Mammoth County Complex located at 118 Catalina Ave. or by contacting Supervisor Rios' office at 520-866-7830 for other options.

Local schools to offer online only learning through first quarter

How are the local schools responding to the need to find a balance between physical safety and other needs?

The Governing Board of the Mammoth San Manuel USD voted to go all online for the first quarter of school, feeling that there are not currently enough answers regarding COVID-19 to make a different choice that will offer the same protection to students, teachers and staff. While they did not specifically say so, there is a feeling that perhaps there was less danger to children during COVID-19, in part, because the schools were closed and the children were protected in the same way and to the same or higher degree in many cases, as their parents. During regularly monthly scheduled board meetings, the situation will be reevaluated with an eye to moving toward more in-person learning. Distance learning begins Monday, Aug. 17.

Teachers have received training in distance learning and are setting up virtual parent-teacher conferences for Monday, Aug. 10, through Friday, Aug. 14.

Recent moisture allows state to lift fire restrictions in some areas

Sufficient monsoonal activity across the northern and southern portions of Arizona allow the Department of Forestry and Fire Management to lift fire restrictions within some state lands.

As of Thursday, July 30, fire restrictions will be lifted on state lands in Apache, Coconino – south of the Grand Canyon, Cochise, Graham, Greenlee, Navajo, Pima, Pinal and Santa Cruz counties.

On Saturday, Aug. 1, Arizona Forestry will also lift restrictions on state land in Yavapai County.

However, restrictions remain in place on state lands within, Gila, La Paz, Maricopa, Mohave and Yuma Counties, along with Coconino, north of the Grand Canyon.

Typically, the arrival of the summer monsoon storms provide increased humidity, ample moisture, and cooler temperatures to help decrease fire activity.

State fire managers feel lackluster monsoon conditions

in the central region warrant restrictions to stay in place longer, and until, more ideal weather conditions are present.

As always, we encourage the public to be mindful of their surroundings and be careful outdoors:

- If campfires are allowed in an area, be sure to put them out completely before leaving the site
- If working outdoors use spark arresters and have a water source nearby
- Never burn on windy days
- · Ensure tow chains are secure
- Check your vehicle thoroughly before getting on the road
- Never pull off into tall grasses
- Do not toss cigarettes out the window
- Fireworks and target shooting are not allowed on state lands at any time of the year



CVIT Remembers Superintendent Pete Guzman

ith a broken heart the staff of Cobre Valley Institute of Technology announces the passing of Superintendent Pete Guzman on Wednesday July 1, 2020.

Superintendent Pete Guzman was one of the founding fathers of CVIT in 2000, as the Superintendent at the origination of the District. It was Pete's vision to make CVIT what it is today. Under his leadership CVIT was formed as a career and technology district with Miami, Hayden and Superior High Schools. San Carlos joined CVIT in 2006, Globe in 2008 and finally Ray High School in 2016. CVIT was Pete's heart and soul and he worked

hard to bring opportunities of free career and technical education to high school students in the Copper Corridor. Today CVIT has career and technical education programs in each member high school and sends its students to two community colleges (CAC and EAC) for college level, industry certified instruction so they are truly work and/or college ready after high school graduation.

Pete was a lifelong resident of Arizona. He was born and raised in Hayden, where his career in education began. He was a teacher, coach, athletic director and a K-8 principal from years 1973-2001. From 2002-2013, Mr. Guzman was also the Superintendent for Superior Unified School District. Pete's honors and awards include but are not limited to: Arizona School Boards Association Superintendent of the Year (2007); All-Arizona Superintendent Award from Arizona School Administrators (2006); Certificate of Recognition from American Red Cross (1993); All-Arizona Hispanic Coach of the Year (1992); Arizona Coaches Association; All-Star Coach (1985, 1986, 1988); Arizona Coach of the Year from Arizona Coaches Association (1988); and All- Star Basketball Coach from Arizona Coaches Association (1983).

Pete Guzman was an extraordinary visionary in education. Above all he was an exceptional human being. One could not go out in public with Pete – have lunch at a local restaurant, etc. – without several people stopping by to say hi and thank him

for what he did for them. He left his mark on students, teachers, and staff wherever he was. His big heart, integrity and compassion was next to none. He treated his employees with respect and care; he made everyone feel important and a part of a team. He surrounded himself with good, student-oriented people and when in doubt he would always ask, "How does this benefit students?" His management style brought him a lot of respect and admiration from students, coworkers, and the community at large.

CVIT's former Executive Program Director Beata Tarasiuk remembers Pete Guzman as a person of extraordinary integrity and passion for education.

"He always believed in me and allowed me to reach for the stars in my professional career. It is a mark of a great leader to allow his employees to shine. He left a legacy of kindness excellence. I still have his words sounding in my head: 'If you need me, call me anytime,' and he always answered the phone," Beata said.

Former Administrative Assistant Rachel Cardenas had this to say: "Mr. Guzman was considerate, courteous and very devoted to his profession and family. It was an honor to have worked with him."

Business Manager Donna Roach said, "He was more than just a boss, he was a friend. He always had time to listen, and had plenty of life stories and experiences to share. His passion for CVIT was the engine that pushed him forward."

Mike O'Neal, the Interim Superintendent, said one of his biggest takeaways from working with and being mentored by Pete for the last four years was that if Pete believed it was in the best interest of kids, he was going to do everything within his power to make it happen.

"The impacts Pete has had on lives of students within the copper corridor are immeasurable, and he will be greatly missed," he added.

Franceen Gregovich-Benton, one of CVIT's Founding Board Members and longtime friend and colleague, said: "Pete was so devoted to education and I learned so much from him. He was such a calming influence. I would be worked up about something and he could calm me down and have me look at the bigger picture. He would say to me, 'It will be fine Fran, don't worry.' He was a true blessing to CVIT and me."

Board Member Yvonne Lees remembers Pete as a lifelong educator and visionary. "Pete was always trying to bring new

education opportunities to our region. He was excited to include San Carlos High School in CVIT, he knew that students would benefit from a variety of programs," she noted.

Mike Fane, CVIT's Board Chairman, remembers Pete Guzman as devoted leader and a lifetime coach.

"We often talked about high school sports," Mike said. "Pete had a true passion for sportsmanship and student education and development through team building. He was a coach in his heart throughout his career in education."

"Mr. Pete Guzman was an exemplary leader," said Anna Flores, Vice Board Chairman. "I served under his phenomenal leadership as the School Counselor when he served as the Superintendent and Principal of the Superior Unified School District. I also worked with Mr. Guzman as a CVIT School Board Member. Mr. Guzman made a significant impact in my life regarding his love for students and staff. He made a difference in the lives of everyone he came in contact with. Mr. Guzman's tireless dedication to education made him a class act. He had a firm belief in holding high expectations for all students while meeting their unique needs and supporting their academic success. Mr. Guzman understood that this is a daunting challenge that educators face each day so valuing and appreciating teachers and school staff were one of his highest priorities. He met challenges regarding education, head-on. He truly gave his heart and soul to his family and

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Aug. 4, 2020.

There are a few points we would like our readers to consider when following this data.

- 1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
- 2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
- 3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
- 4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive

Discarded trophies cause uproar at local district

At a time when schools should be concentrating on preparing for the coming school year — a school year in the time of COVID-19 and where teachers are shifting their paradigm from face-to-face teaching to online only — the Mammoth-San Manuel School District is coming under fire for a dumpster full of trophies.

What Happened?

On Monday, Aug. 3, photos and comments began flooding Facebook and NextDoor of a dumpster full of school trophies.

Randall Yubeta, a member of the Class of 2006, emailed the members of the school board and *San Manuel Miner* to voice his outrage at the sight of so many trophies being discarded.

"There is absolutely no excuse for this type of disregard for the hard work that thousands of alumni have put in not only in the classroom but the fields and areas of competition that these trophies represent," Yubeta wrote in his email.

The trophies were located in a commercial Waste Management dumpster on school property.

According to a post on the school district's Facebook page, "There was a recent upset in the community due to trophies being found in the dumpster. When it was brought to the administration's attention, the trophies were retrieved and are now in storage. The trophy cases in the gym were cleaned and the plan was to make them look more presentable. They now house our many championship trophies so that they can be seen. This should have never occurred and we apologize for upsetting the community over this matter. Administration will look further into this matter and deal with any disciplinary action that should occur."

The district's initial plan was to

photograph the trophies for older invitationals and tournaments and then offer the trophies to alumni.

Administration's Response

In an email to the San Manuel Miner, Julie Dale-Scott, Superintendent of the Mammoth-San Manuel School District said:

"The circumstances that occurred with the Miner trophies is a misunderstanding. It was not something that was planned or directed. I realize that the Mammoth-San Manuel community is one that has had a lot of loss, to start with its copper mine and on to several schools and business closures. It therefore is disturbing that this event has even occurred.

"The actual intent, was to showcase the achievements that created our Miner pride. Currently, the trophy cases in the gym highlight our achievements over the last 67 years in each sport and our hope

is that we can add more eventually. We are very proud of all Miners and realize as educators that not everyone is a bookworm and each of our Miner family has a different talent. Athletics is a bridge to education for some students. Students try harder in their academics because they really want to be on the field or court. Athletics build confidence and the right coaching can create opportunities. Some of our athletes have gone on to play in college, the semipros, and even on professional teams. We are very proud that they call themselves a Miner.

"My hope after retrieving those trophies is to work with our community members to not only find a way to treasure those trophies, but continue to build on our Miner pride. We need to honor the past and allow our young students that continue through our small school to feel what Miner pride is as well by adding new memories."
