Cavanaugh Offers Explanation for Vote

n Wednesday, the Pinal County Board of Supervisors rejected over \$3.3 million dollars from the federal government. The \$3.3 million dollars would have required Pinal County to create a Vaccine Equity Coordinator who would be in charge of federal communications regarding public health.

After reading the fine print, I decided that it was best to reject the federal dollars for a number of reasons, most importantly being that the federal dollars specifically forbid ANY money from being spent on actual vaccines!

OT21-2103 funds cannot be used for purchasing or providing vaccines. Recipients are advised to use other existing funding sources intended for those purposes. (https://www.cdc. gov/publichealthgateway/docs/partnerships/OT21-2103-Recipient-Orientation-QandA.pdf)

So, if the funding cannot be used for actual vaccines, then what is the money for? According to the CDC, "Increase/ improve data collection and reporting for populations

freedom through one-size-fits-all policy.

The federal dollars would not have improved medical care, the dollars were essentially directed at creating a Vaccine Czar in Pinal County.

Item 5. Requirements.

The Intergovernmental Agreement requires, "The activities in this Contract shall be performed...for the purpose of increasing immunization coverage levels of children...and adults...in both public and private sectors of health care." The way the grant attempts to increase immunization levels is through a marketing plan, with cash giveaways and other incentives.

Missing from all of this is a medical doctor's opinion that the vaccine is necessary for you. Immunizations may be good for most but not for all. What if a person has cancer or other ailment which prevents them from receiving the vaccine? According to the NIH:

Patients with blood-related cancers often have dysfunctional immune systems, and as a result they're just not able to respond as well to the COVID-19 vaccine as other people," said Elad Sharon, M.D., M.P.H., a senior investigator at NCI, who was not involved in the new studies but is leading a clinical trial testing COVID-19 vaccines in people being treated for

Now the federal government is creating vaccine mandates for all. Federal employees will take the place of your doctor and tell you what medicine to receive or not receive. Of course, these decisions won't be based upon your individual medical needs but the needs of equity and one-size-fits-all policy. Like most of these rules, they will apply to you and your family, not to elite politicians, or apparently to Federal Postal Workers.

From the time the vaccines were made available, I spent hours on the phone with the Public Health Director making sure that communities in District One had access to them and my staff in the Mammoth Office facilitated scheduling as people became increasingly frustrated with busy signals and hours on hold with the "Central Appointment Desk." Vaccines should be made readily available to those who want them. LOCAL DECISIONS, LOCAL CHOICE

I believe that you have a Constitutionally recognized, God-given right to decide on your own medical care. These

Chairman Offers Apology for Vote

n Sept. 1, 2021, the Pinal County Board of Supervisors acting as the board of directors for the Public Health District meeting turned down 3.2 million dollars of federal grant money to help the county with the COVID-19 pandemic. In my opinion, this decision was shocking and disappointing. I'm sorry.

The purpose of the grant was to ensure greater accessibility of COVID-19 vaccines throughout the public health district, now and in the future. Why my colleagues could not see the benefits to our constituents would need to be asked of them. I believe the decision to turn down the agenda item for the grant revolved around two things, misleading information from a fellow supervisor, and the term "equity".

To begin, during the Sept. 1 Board of Supervisors meeting, it was mentioned that 320,800 of our constituents have been vaccinated. This misleading information was presented in the public meeting and also placed on a public blog by Pinal County Supervisor Kevin Cavanaugh, District 1. This deceptive statement was intentional to create a false perception to show that majority of Pinal County residents have been fully vaccinated; however, that is the furthest from the truth.

The 320,800 number presented by Supervisor Cavanaugh was reflective of the amount of vaccines administered, not the total of people fully vaccinated. According to the Arizona Department of Health and Human Services, only 165,160 citizens in Pinal County are fully vaccinated. I am not sure why a Supervisor's office with a staff of five does not understand the concept that the major vaccines Pinal County distributed requires two doses to be considered fully vaccinated.

The second issue that appeared in the discussion was the word "equity". This word has created strife in this country and in everyday dialogue. Equity is a word I do not fully understand as it is commonly viewed with multiple interpretations.

I was taught the meaning of equity as a term of "net worth" described in economics and accounting as, assets, minus liabilities, equals equity. I also view equity as the measure of value in relationships built. After my research, equity in my perspective as it relates to this issue is fairness, which I would define as "equality".

The word "equity" has become a divisive word that has inflicted animosity among our country and county. Ultimately, I believe it was the driving force as to why the grant was denied. Had a different word been used to identify the role, I firmly believe the agenda item would have passed.

As an elected official, I am given the charge to represent my constituents, not to impose my personal beliefs or philosophy that would impede on a worthy opportunity for the people I represent. I will make it a priority to secure the finances needed to ensure our residents get the vaccine, no matter their location or socio- economic status. Opportunity is the one thing that our country will grant you, and I will fight to ensure each citizen in our county has the opportunity to get vaccinated.

In the future, let's hope my colleagues understand our mission and job as county supervisors, which is to create and facilitate policy that is conducive to our constituent needs. We must do our best to represent the people who elected us. Collectively, we need to put aside our personal beliefs to overlook the divisive verbiage and focus on the foundation of this grant, and that is to provide critical resources to meet the needs of public health, now and in the future. Moving forward, I will explore our options as a county to implement a similar program that will afford the opportunity to anyone who wants to get a vaccine, and to get one in the comfort of their own community.

I am optimistic that we will all come to an understanding and prioritize public health. There should be no room for personal agendas when dealing with the health and wellness of all the great citizens of Pinal County. 





n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. *Copper Area News* wanted to give something back to the local business community as a thank you for supporting us through these troubled times. Our newspapers (*Copper Basin News, Superior Sun and San Manuel Miner*) have been featuring local businesses and non-profits since the beginning of 2021, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, *Copper Area News* has featured 107 businesses and groups in the Copper Corridor.

As the COVID-19 Pandemic took its toll, businesses, families and even local non-profits had to adjust their strategies to keep their missions moving forward while working through the pandemic. Government organizations, too, felt the pinch from the lockdown.

The Kearny Public Library is officially the Arthur E. Pomeroy Library, named after the man who first started it in what became the Masonic Lodge on Fairhaven. It was established in 1963-64.

The Library, with Library Director Janet Danilow and Assistant Librarian Vickie Lechuga, is a very busy place these days as they offer all the latest in books and movies, as well as EBooks for your Kindle.

"We have a large selection of audiobooks for those with eye problems, travelers and the truck drivers out at the mine. We also offer a variety of services such as computers for public use, we also make copies, send faxes, and scan and email," Janet said.

They offer activities for the kids and the adults, such as Story Hour for the little guys on Wednesdays at 1 p.m. The Kearny Library

Activity Center (K.L.A.C.) with Coordinator John Putman is open on Fridays from noon to 3 p.m. There is Coffee and Conversation (C&C) on Tuesday and Thursday mornings for adults only, where their attendees play games and visit for hours over coffee and a sweet (use the SW door in the back) from 8:30 a.m. until whenever.

"Every third or fourth Wednesday," Janet said, "we host the Ladies Day Out for our local ladies, with everyone bringing a potluck dish. Then we have an activity and a craft."

Each April for National Library Week (NLW) the library partners with the school for the NLW Bookmark contest with the three top winners in each grade receiving a goodie bag at the Awards Ceremony held the last Thursday evening of the week. During the week they have cookie trays every day and for the Awards Ceremony, as well as Meat and Cheese, and Fruit and Veggie trays for all their patrons all day.

At the end of May through June the library has the Summer Reading Program (SRP) ending with a pizza and ice cream party and a performer from the AZ State Library website. They also host the Christmas Lighting Contest in December.

"We do our best to keep things new and interesting. If you have never visited or used you Library come in and give us a try," Janet invited.

All of the above activities are free, paid for by the donations made to the Library.

"We would like to thank our community for your support," she added.


