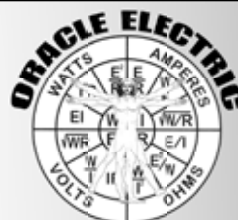
The correction stated: "With regard to item 4 (on the Fact Sheet), the substation and the upgrade of the majority of the

distribution will take 24 to 36 months."

Mammoth Police Report

Mammoth to host traditional Fiestas Patrias Saturday

The Fiestas Patrias commemorates the Grito de Dolores (the Cry of Dolores), which was the event that marks the beginning of the Mexican War of Independence from Spain.

On September 16, 1810, Miguel Hidalgo y Costilla a Roman Catholic priest in the small town of Dolores ordered the church bells rung and when the parishioners were gathered, he encouraged them to revolt. Four days later the town of Guanajuato was taken by a makeshift army led by Hidalgo beginning the revolt that would lead to independence. Hidalgo was captured in July and executed.

The Fiestas Patrias is celebrated throughout Mexico and in the United States of America in areas with large populations of people of Mexican heritage. In the Town of Mammoth and the Tri-Community, the celebration has been an annual event. At one time the Fiesta Patrias was a huge event in Mammoth. According to a *San Manuel Miner* newspaper in 1962, the event was a three

day celebration and they were expecting 15,000 visitors to attend. There was a large parade, sky divers, music, dances, food, entertainment, baseball and softball games. Delegates from the Mexican Consulate attended as did many local politicians. People from around the state and Mexico would attend.

Although the event has dwindled in size the spirit of the celebration continues on. This year's Fiesta will be held on Saturday, Sept. 19, at the Blessed Sacrament Catholic Church in Mammoth. Blessed Sacrament is located just off Hwy. 77. For more information, please contact the church at (520) 487-2451.

Traditional Mass will be celebrated at 2 p.m. and the Fiesta with all the food and wonderful entertainment beginning at 3:30 p.m.

Miner swimmers open season with six school records

After several weeks of practices, the Miner Swim Team opened the season at Phoenix Country Day on Sept. 1 against Phoenix Country Day School, Bradshaw Mountain High School (Prescott Valley), and Scottsdale Christian Academy. The Miners looked sharp in the opener setting six new school records.

The Girls Medley Relay team of Senior Cita Sweeney, Freshman Gianna Sweeney, Freshman Darien Apuron, and Sophomore Raya Woods broke the school record by over 2 seconds with a time of 2:09.25. Gianna Sweeney won the 50 Freestyle in School Record time of 27.23 (previously 27.64 held by Cierra Austin). Against tough competition, Sophomore Will Newman won the 200 IM (2:06.78) and 100 Backstroke (58.02). Senior Jacob Christian won the 500 Freestyle with a time of 5:56.36. Woods, Newman, Christian, and Stratton won both the 200 and 400 Freestyle Relays. The Miners won more Swimming

events than any other team at the meet, but a lack of divers and a smaller overall team size resulted in the boys finishing 2nd in the team scores (PCDS 186, San Manuel 136, Bradshaw Mtn 121, Scottsdale Christian 59).

Head Coach Alex Gort was happy to see several Miners achieve State Qualifying times even though it is not official until they swim them at a Qualifying Meet. Hero awards presented by Oracle Fire Board

On Sept. 9, 2015 at the Oracle Fire Governing Board meeting, Fire Chief Larry Southard and Assistant Fire Chief Robert Jennings presented "Hero" certificates to two civilians who helped with a difficult rescue near Peppersauce Canyon. The two men were Ray Garcia from Coolidge, Arizona and Robert Flemmings from Phoenix. Two Oracle firefighters, Harley Van Coillie and Michael Parra were also recognized for their efforts in the rescue.

The rescue operation took place on Aug. 22, 2015 when a "vehicle over a cliff" was reported. A hunter in the area, Robert Flemmings, about a mile above Peppersauce Canyon caught sight of a vehicle driving off the road down a cliff. The vehicle was heavily damaged and laying about 150 feet down a hill in a ravine. He called 911. The group of hunters in the vicinity climbed down the steep embankment to the vehicle and the injured driver, a woman from Oracle. One of the members of the hunting groups, Ray Garcia is a 17 year veteran of the Coolidge Volunteer Fire Department. He helped stabilize the woman until help arrived.

Robert Flemmings and the other hunters in his group stayed with the rescue crew, climbing up and down the steep incline, bringing medical equipment and supplies to the injured woman. The driver had to be lifted out of the canyon by a DPS helicopter. She was transported to a trauma center with serious injuries. The complex rescue operation took about five hours. It was said that if the hunters had not been in the area that the vehicle would have been impossible to see from the road. The

driver is said to be in good condition.

Ray Garcia said that the Oracle Fire Department did a great job during the rescue.

In other good news announced at the meeting, Oracle Engine 692 and its four man crew have returned from helping fight the Mad River Fire in Northern California.

“The result,” Southard said, “is that,
this year, we face a severe fire threat
right through the winter months. I urge
all property owners to get their mowers,
weed-wackers, pruning shears and chain
saws going to eliminate standing grass,
brush and low lying tree branches from
around their homes and out- buildings.
We recommend at least a 30-foot clearing



around buildings and the more, the better.

Let’s put a damper on now what could
be a severe fire season in the weeks and

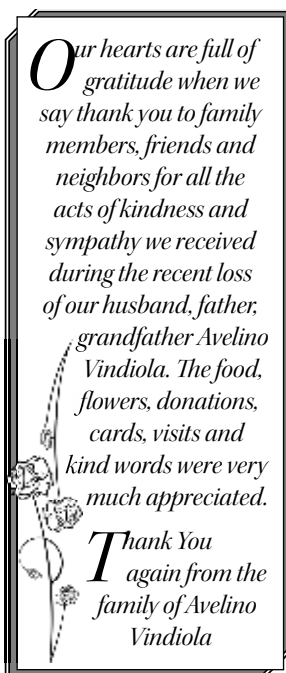

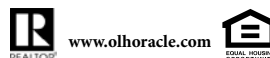
