# Education Critical to Our Future in the Copper Corridor - Visit to Helios Inspires Collaboration

Recently, the mayors and school district superintendents of Globe, Superior, Miami, Hayden, Winkelman and Kearny were all invited to visit the headquarters of Helios Education Foundation in Phoenix. The purpose of the meeting was to learn more about the current educational attainment of K-12 students across the Copper Corridor region as well as the variety of social and economic factors that affect their ability to learn. The data presented to us was compelling, all the more so because it was the most recent data available and could be correlated through technology.

In our session, we learned that simple things like our children having enough to eat throughout the month helps to improve their ability to learn. We learned about the effects that the contamination of lead based paint can have on children. Even air quality can be a factor in our students' success. Of course, school funding also directly impacts the educational attainment of our children and youth, as does the lack of funding and declining enrollment that many of our communities here in our region and across the Arizona have experienced over the years.

These and other equally daunting factors can often

be construed as insurmountable and render us feeling powerless. The meeting last week reminded me that our region has always been resilient and committed to not only fiercely battling challenges, but also to ensuring that our youth have abundant opportunities for their futures. Our communities have educated doctors, lawyers, engineers, miners, educators, business executives and countless hometown heroes who have become leaders in their professions and industries.

One of our greatest advantages as a region is the fact that our leaders are at least willing to come together to have a conversation, to dialog on what actions we can take to address these challenges, how we can leverage our resources and how we can best advocate for our schools and education systems.

This local leader, me, Mayor Mila from Superior, sees a bright future ahead when we can all work together. When we come together, we are a formidable force, as there is strength in a group of many working together as one. Collectively, we share values that bind us all together – we all want great futures for our residents, especially for our children and youth. We can help to shape even brighter futures for our students – those who are here today and those who inevitably will come in the future.

The Mayors of Superior, Kearny and Miami left the meeting last week with a simple challenge: let us use

transition traffic onto the new Pinto Creek Bridge.

The closure is scheduled from 10 p.m. Sunday, Sept. 12, until noon Friday, Sept. 17. It is subject to change based on the weather.

During that time, all eastbound vehicles will be redirected at State Route 177 in Superior, and all westbound vehicles will be redirected at the west end of Miami. Traffic will not be allowed to queue at the closure locations.

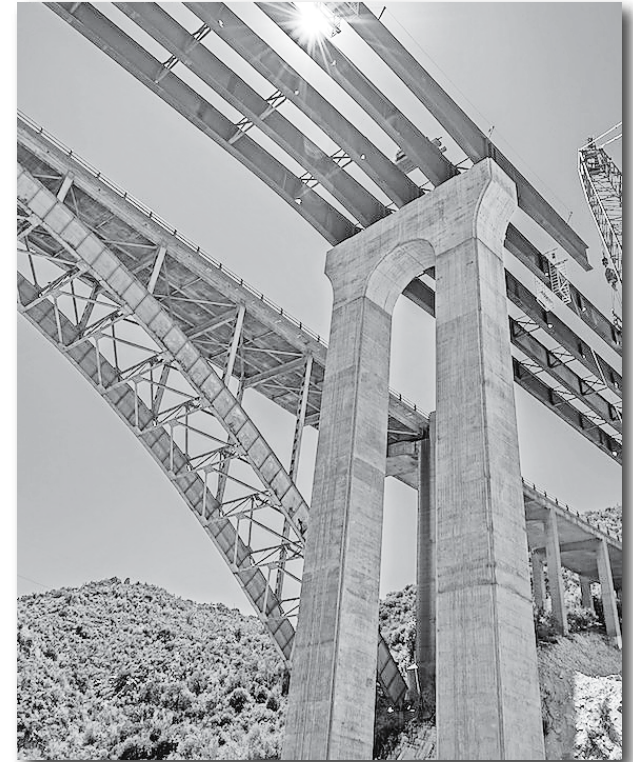
Motorists with a destination between SR 177 and Top-of-the-World west of Pinto Creek or between Miami and Pinto Valley Mine Road east of Pinto Creek will be allowed to pass, however no vehicles will be allowed between Top-of-the-World and Pinto Valley Mine Road.

Traffic will be detoured to SR 177 in Superior and SR 77 in Globe. The detour includes a 10% grade and will significantly increase travel time.

Motorists should proceed with caution, slow down, watch for equipment, and follow the directions of flaggers and law enforcement.

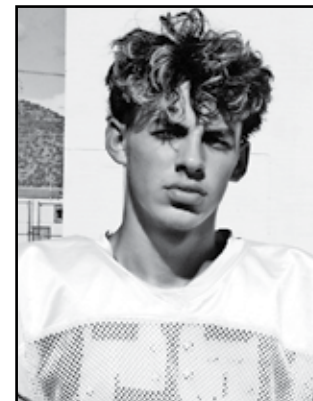

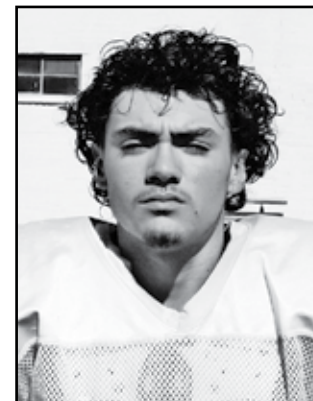

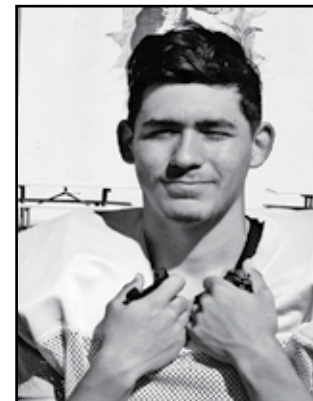

## US 60 Traffic Alert

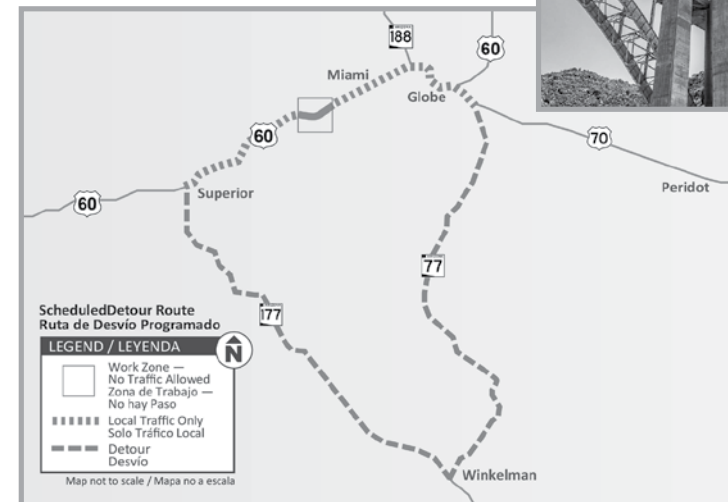
FIVE DAY CLOSURE SCHEDULED IN SEPTEMBER

US 60 is scheduled to close to all through-traffic between Miami and Superior in mid-September so crews can shift traffic from the old Pinto Creek Bridge onto the new bridge. The closure is tentatively scheduled to extend from 10 p.m. Sunday, Sept. 12, through noon Friday, Sept. 17. During those hours, traffic will be detoured to State Routes 77 and 177. Motorists with a destination between SR 177 and Top-of-the-World west of Pinto Creek or between Miami and Pinto Valley Mine Road east of Pinto Creek will be allowed to pass, however no vehicles will be allowed between Top-of-the-World and Pinto Valley Mine Road.

Recently, State and National media have reported an increase in positive COVID-19 Cases. The communities of the Copper Corridor have also started to see an increase in positive cases. The new Delta variant of COVID-19 has been reported as highly transmissible. The CDC and other health officials warn that those who are not vaccinated should continue to practice physical distancing, wear masks in public and avoid crowded places and is also strongly recommending everyone wear a mask indoors and in group settings.

Governor Doug Ducey has signed executive orders that prohibit Cities and Towns from mandating mask wearing, limiting restaurant capacity or other enacting other physical distancing requirements. At this time there is no indication that there will be any restrictions put into place. Local schools are also prohibited from requiring masks be worn on campus.

COVID Vaccines are readily available at local clinics in the region including Cobre Valley Clinics in Superior and Kearny, Pinal County Public Health and Sun Life Clinics. Other chain pharmacies such as Walgreens, grocery story pharmacies and CVS also have vaccines available.

We last reported daily COVID-19 case increased on Aug. 24, 2021. Above is a chart showing our last reported number and the current number of total cases for each of the Copper Corridor communities through Aug. 31, 2021. Keep in mind that zip code data also includes unincorporated areas around a community. For instance, Riverside/Kelvin area is included in the Kearny zip code. Aravaipa and Dudleyville are included in the Winkelman zip codes, etc.

Those experiencing COVID-19 symptoms should seek testing and quarantine until they can confirm a negative test.

**Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.**

ADOT: Prepare for latest round monsoon storms, potential delays; be ready for wet highways, possible flooding and debris

As the National Weather Service forecasts another round of monsoon storms in Arizona this week, drivers should use extreme caution and make plans to avoid hazardous conditions that heavy rainfall could trigger on roadways across the state.

While the National Weather Service has issued a Flash Flood Watch for all of Arizona during part of Tuesday and Wednesday, forecasters expect especially heavy rainfall in southern Arizona and in the Tonto Basin. One additional area of concern where heavy rain is expected is near Globe, where runoff from the Telegraph Fire burn scar makes highways such as US 60 vulnerable to flash flooding, debris flows or sudden closures because of damage.

The forecast calls for up to 4 inches of rain in the wettest parts of Arizona, with isolated storms producing rain as early as Monday, Aug. 30. However, even modest rainfall could lead to flooding in areas where recent storms have saturated the ground.

ADOT maintenance crews across the state have been preparing for the latest storms by clearing debris from drainage systems and checking the more than 55 pump stations along Phoenix-area freeways. Also, crews have staged heavy equipment in areas prone to flooding for faster response times.

ADOT is in close contact with the National Weather Service to get updated forecast information and prepare to respond to areas where flooding or other other adverse conditions may affect safe driving conditions.

The Arizona Department of Transportation urges drivers to pay close attention to weather forecasts and to be ready for the severe weather associated with the monsoon season.

ADOT asks motorists to keep these tips in mind:

- Don't risk crossing a flooded wash, even if it doesn't look deep. Even a few inches of running water poses a serious risk.
- Stay alert in areas prone to falling rocks. Runoff can loosen rocks and boulders from slopes above roadways.

- Don't drive around "Road Closed" signs. You risk your life and face being cited under state law.
- If traffic lights are out, treat an intersection as a four-way stop.
- Inspect your windshield wipers and replace them if necessary.
- Reduce your speed and maintain a safe distance between your vehicle and the one in front of you.
- Avoid sudden braking, which can cause you to slide on wet pavement. To slow down, take your foot off the gas pedal and brake slowly.

- Consider delaying nighttime travel during storms, as the rain can reduce visibility and make it difficult to spot rocks or other debris.
- Use extra caution traveling in areas where recent burn scars leave highways more vulnerable to flooding, debris and other damage.

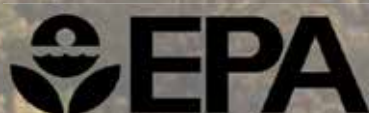
