Full closure of US 60 between Superior, Miami scheduled for Sept. 12-17; all motorists will need to use an alternate route

Motorists who use US 60 between Superior and Miami should plan for a full closure of the highway between Sept. 12 and Sept. 17, while crews build connections and transition traffic onto the new Pinto Creek Bridge.

The closure is scheduled from 10 p.m. Sunday, Sept. 12, until noon Friday, Sept. 17. It is subject to change based on the weather.

During that time, all eastbound vehicles will be redirected at State Route 177 in Superior, and all westbound vehicles will be redirected at the west end of Miami. Traffic will not be allowed to queue at the closure locations.

Motorists with a destination between SR 177 and Topof-the-World west of Pinto Creek or between Miami and Pinto Valley Mine Road east of Pinto Creek will be allowed to pass, however no vehicles will be allowed between Top-of-the-World and Pinto Valley Mine Road.

Traffic will be detoured to SR 177 in Superior and SR 77 in Globe. The detour includes a 10% grade and will significantly increase travel time.

Motorists should proceed with caution, slow down, watch for equipment, and follow the directions of flaggers and law enforcement.



Recently, State and National media have reported an increase in positive COVID-19 Cases. The communities of the Copper Corridor have also started to see an increase in positive cases. The new Delta variant of COVID-19 has been reported as highly transmissible. The CDC and other health officials warn that those who are not vaccinated should continue to practice physical distancing, wear masks in public and avoid crowded places and is also strongly recommending everyone wear a mask indoors and in group settings.

Governor Doug Ducey has signed executive orders that prohibit Cities and Towns from mandating mask wearing, limiting restaurant capacity or other enacting other physical distancing requirements. At this time there is no indication that there will be any restrictions put into place. Local schools are also prohibited from requiring masks be worn on campus.

COVID Vaccines are readily available at local clinics in the region including Cobre Valley Clinics in Superior and Kearny, Pinal County Public Health and Sun Life Clinics. Other chain pharmacies such as Walgreens, grocery story pharmacies and CVS also have vaccines available.

We last reported daily COVID-19 case increased on Aug. 24, 2021. Above is a chart showing our last reported number and the current number of total cases for each of the Copper Corridor communities through Aug. 31, 2021. Keep in mind that zip code data also includes unincorporated areas around a community. For instance, Riverside/Kelvin area is included in the Kearny zip code. Aravaipa and Dudleyville are included in the Winkelman zip codes, etc.

Those experiencing COVID-19 symptoms should seek testing and quarantine until they can confirm a negative test.

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.

Central Arizona College welding program receives award

Central Arizona College's Welding program has been named a Welding Equipment Manufacturers Committee (WEMCO) 2021 Excellence in Welding award recipient.

Each year, in partnership with the American Welding Society (AWS) Foundation, WEMCO recognizes those who are instrumental in strengthening the industry and promoting the image of welding in their communities.

Since the early 1970s, CAC's welding department has trained students for employment opportunities in mining, steel fabrication, steel erection, aerospace, manufacturing, and other industries.

The diversified offerings for students include four certificates; Advanced Structural Welding and Fabrication, Fundamentals of Pipe Welding, Fundamentals of Structural Welding, and Pipefitting/Pipe Welding. Students may also pursue an Associate of Applied Science in Pipe Welding or Structural Welding Technology. Additionally, students have the opportunity to obtain industry welding certifications and industry training certifications through NCCER.

Students are trained in a jobsite setting using specialized pipefitting tools and equipment, allowing them to duplicate work done in a real world environment. Instructors often blend project-based learning with community engagement, so students develop teamwork, management skills, and interpersonal skills.

The CAC welding program has seen extraordinary growth over the past decade, with the introduction of Arizona's only pipe welding program and providing welding courses to local high school students. Today, more than 100 high school students participate in dual enrollment opportunities.

CAC instructors are Certified Welding Inspectors, as well as Certified Welding Educators through the American Welding Society with years of welding industry experience to bring top of the line learning to students.

ADOT: Prepare for latest round monsoon storms, potential delays; be ready for wet highways, possible flooding and debris

As the National Weather Service forecasts another round of monsoon storms in Arizona this week, drivers should use extreme caution and make plans to avoid hazardous conditions that heavy rainfall could trigger on roadways across the state.

While the National Weather Service has issued a Flash Flood Watch for all of Arizona during part of Tuesday and Wednesday, forecasters expect especially heavy rainfall in southern Arizona and in the Tonto Basin. One additional area of concern where heavy rain is expected is near Globe, where runoff from the Telegraph Fire burn scar makes highways such as US 60 vulnerable to flash flooding, debris flows or sudden closures because of damage.

The forecast calls for up to 4 inches of rain in the wettest parts of Arizona, with isolated storms producing rain as early as Monday, Aug. 30. However, even modest rainfall could lead to flooding in areas where recent storms have saturated the ground.

ADOT maintenance crews across the state have been preparing for the latest storms by clearing debris from drainage systems and checking the more than 55 pump stations along Phoenix-area freeways. Also, crews have staged heavy equipment in areas prone to flooding for faster response times.

ADOT is in close contact with the National Weather Service to get updated forecast information and prepare to respond to areas where flooding or other other adverse conditions may affect safe driving conditions.


The Arizona Department of Transportation urges drivers to pay close attention to weather forecasts and to be ready for the severe weather associated with the monsoon season.

ADOT asks motorists to keep these tips in mind:

• Don't risk crossing a flooded wash, even if it doesn't look deep. Even a few inches of running water poses a serious risk.

Stay alert in areas prone to falling rocks. Runoff can loosen rocks and boulders from slopes above roadways.
Don't drive around "Road Closed" signs. You risk your life and face being cited under state law.

• If traffic lights are out, treat an intersection as a four-way stop. Continued on page 14




Flood damage to U.S. 60 between Superior and Miami following recent monsoon rains. Photo Courtesy ADOT





Preparing for a Fall and Winter Garden

The most commonly asked question about prepping for a fall and winter garden is: "How do I know when the summer garden should be pulled out?" I debate this with myself ... every single year! My garden is at 4020 ft elevation in the low North foothills of the Catalina Mts.

This year, I finally decided to thin out every summer vegetable that was not producing or had slowed down so much that I couldn't justify the water usage. Tomatoes this year are abundant due to a good monsoon season. I have cut the long ends of the tomato plants back to the last set tomato, then thoroughly examined all the tomato plants for insects, and then removed the light producers. At the end of August, in the spaces that are moderately shaded by the full grown tomato plants, I'll add some compost to the soil and then plant cool-season seeds: chard, cilantro, snow peas, leaf lettuces, chives, Asian greens and spinach.

It looks like the heat will be with us this year until the middle or end of September, which means I need to watch for bolting (flower production) then trim the flowers back on my cool season plants and maybe even add some temporary shade screen. I know at some point I'll have to sacrifice some squash, tomato & cucumber plants to create space for the rest of the fall/ winter garden that I want to have in the ground by mid-October, if the weather starts cooling down.

I am working to incorporate the "No Till" style of gardening which means I don't pull any plants out of the ground. Instead, I cut every plant off at the base of the stalk, right next to the soil to keep all of the organic material in the soil. Then I'll clean up



all the dead tomato leaves, compost them, and allow the rest of dead leaves to stay on top of the soil.

Next, I add about ½ inch of topsoil mixed with some compost. After seeding, I'll dampen the plant seeds, followed with a thorough watering. I generally like to plant cold weather veggies by mid-October: beets, carrots, chard (yes, again) spinach, dill, fennel, cilantro , snow peas, leaf lettuces and Asian greens. Garlic goes into the ground at the end of October.

n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey. The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. *Copper Area News* wanted to give something back to the local business community as a thank you for supporting us through these troubled times. Our newspapers *(Copper Basin News, Superior Sun and San Manuel Miner)* have been featuring local businesses and non-profits since the beginning of 2021, encouraging our readers to Shop at Home, stay local and support our local businesses. 


