# **Superior Town Council considers** policies for town's library

Policies at the Superior Public Library came under discussion last week at the regular Superior Town Council meeting. Councilman Bruce Armitage expressed his concerns about the inclusion of the Library Bill of Rights1 and the Freedom to Read Statement2 in the policy manual and how these policies could have adverse effects on the youngest patrons of the library.

"My concern is for the kids," Armitage said. "As adults, I don't care what you read. I care about who's covering our kids. Who's the gatekeeper of our children?"

Armitage cited one section in each of the two statements that he believed would cause harm to children and young adults visiting the library.

From the Library Bill of Rights, Armitage quoted: "Materials should not be excluded because of the origin,

background, or views of those contributing to their creation."

Explaining his concern, Armitage said, "Anything could go into our public library. Pornography could go into our library. Bestiality books could go into our library. Child pornography probably could make it into our library."

From the Freedom to Read Statement, Armitage quoted: "Parents and teachers have a responsibility to prepare the young to meet the diversity of experiences in life to which they will be exposed, as they have a responsibility to help them learn to think critically for themselves. These are affirmative responsibilities, not to be discharged simply by preventing them from reading works for which they are not yet prepared."





thought, "Who is taking care of our children? Who's watching our children?"

The councilman said specifically he had a concern about how the library removes a book from its shelves.

When a patron has a problem with a book, he explained, the policy as written states that the person brings it to the

attention of the library director using a form with questions regarding the book's contents and suitability. The library director will reconsider the book along with one or two staff members or other library science officials from the county or the state. Evaluators will submit their suggestions back to the library director who will notify the patron
of his decision on the
status of the book.

Armitage said he has an

the person who created the policy and included the Library Bill of Rights and the Freedom to Read Statement in the policy manual is the one who decides on whether a book is on the shelf or not. He then offered a motion to table the item so that the council could review it more thoroughly and decide if there is a better way to handle removing books from the library and whether the two statements should still be included in the town's handbook. He quickly withdrew the motion to allow the council to discuss the matter (all discussion ceases once a motion is offered).

NCUA

Mayor Mila Besich explained that the library's policy on children was very strictly enforced. "Children under the age of 10 can't be in the library without a parent." She added that children under the age of 18 must have a parent's permission to obtain a library card.

Library Director Tony Soliz said that the internet policy and how it is accessed at the library is governed by Pinal County. "Pinal County IT has the responsibility to monitor and restrict the internet," he said.

Town Manager Todd Pryor said, "For most of the books that Councilman Armitage mentioned, it would be a crime to have in the library. There is an assumption that we've stocked the shelves with controversial items. That's not the fact."

He said that libraries don't cherry pick the books. "If you can censor a book on transgender youth, you can censor the Bible. It's a slippery slope. Libraries don't set the line. They let the public decide what to read."

Current policy at the library specifies that children under the age of 10 must be accompanied by an adult. "Children can't go unescorted," Pryor said. "It's not a daycare. We (the town) don't want the responsibility for being parents."

Pryor asked if the librarian should follow the child around knocking books out of their hands that might be deemed inappropriate. "Or do we want their parent there monitoring what they are looking at like it is supposed to be in the policy?" he asked.

Armitage argued.
"Shouldn't we be providing some standard of protection for our young people in our library?"

Besich countered. "I believe that the standard of protection is set by the parental policies that are currently in place." She said that the library staff does a great job of guiding children and other patrons to the reading material that they need, and it is not for the council to decide what can or cannot be read.

"At no time do I think that anyone on this council wants to endanger children," Besich said, urging the other councilmembers to "look at this with common sense."

Armitage motioned again to table action on the item. It was seconded and all present except for Mayor Besich voted in favor.


