Oracle Fire, other departments fight fire at El Rancho Robles

Early Friday morning, the Oracle Fire Department was dispatched to the scene of a structure fire at El Rancho Robles.


"The intersection given to the 911 dispatchers didn't give us access directly to the fire," said Oracle Fire Chief Robert Jennings, "so the crew did an amazing job realizing the correct location and had to redirect themselves."

The crew arrived on scene at 5:15 a.m., 14 minutes after they were dispatched. Jennings said the fire was knocked down in about 15 minutes. The structure was a large workshop that was unoccupied. The start of the fire was unknown and is not under investigation.


Jennings said that the department was aided by San Manuel, Pinal Rural, Mammoth and Golder Ranch fire departments, who assisted with containment and overhaul. Pinal County Sheriff's Office and the Oracle CERT team were also on scene to assist. One firefighter was treated for dehydration and no other injuries were reported. The last crew cleared the scene at 9:13 a.m.

"Everyone did an amazing job," Jennings said. "We would like to thank everyone for all the help. The recent rains definitely helped in this situation. On a hot dry June or July day at 1400 hours and 20 mph winds, we would have a totally different story!"




