
Highway work zone safety reminder: slow down, pay attention

Arizona drivers: please slow down and stay alert in highway work zones.

That's the message from the Arizona Department of Transportation, following a weekend crash in which a Department of Public Safety trooper's patrol vehicle was struck from behind along the shoulder of an Interstate 10 work zone in Phoenix.

Law enforcement reports show 61 people were killed in work zone-related crashes on local streets and highways across Arizona from 2017 to 2020. More than 850 people were killed nationwide in work zone incidents in 2020 (the most recent year for available national data). The Arizona Department of Public Safety is investigating







Support Local: Regenerating Sonora

n our series to highlight local businesses and nonprofits, this week we are meeting with Chris Casillas founder of local non-profit Regenerating Sonora.

Regenerating Sonora is a 501c(3) non-profit organization that was officially formed in 2019. Chris Casillas founded the organization after working in the tech industry and growing a successful career within that sector, he saw ongoing "existential risk and society in disarray", something we all see on the regular basis but may not identify with ways to improve upon society. Chris, who grew up in Superior through Junior High before moving to the Valley with his parents, remained connected to Superior through his grandparents, and extended family. He is proudly one of Superior's family of multigenerations.

With the ongoing meta crisis, (global warming, degradation of institutions, loss of biodiversity, oppression) facing the world he felt that returning to Superior to grow his nonprofit is what he needed to do. While they are starting with a focus on Superior, he hopes to expand his works across the Copper Corridor and throughout the Sonoran Desert.

Chris operates on a basis that there is a room for everyone to participate and is working on developing systems and programs that help to improve the wellbeing of society.

"Superior is an ideal place to begin," he said.

Currently Regenerating Sonora has started a LEHR garden at 225 Pinal Avenue. The name of the garden is called the Erickson Micro-Farm; currently they are growing cilantro, peppers, melons, squash and kale. This is part of their goals to ensure food stability but also to teach youth where their food comes from. A LEHR garden is a raised garden bed that is also designed to be high yield and highly efficient. Their hopes is to be able to sell nutrient rich soil from their garden but to also produce local foods.

According to the garden website, LEHR is an acronym for Linking Ecosystem & Hardware for Regeneration, LEHR Gardens were created by combining 12 different gardening and soil creation methods into one integrated system. A LEHR Garden is regenerative agriculture for the busy lifestyle.

Chris and his wife recently

married and they plan to

have children in the future. Part of his mission with Regenerating Sonora is to help grow an eco-system that will allow his children and all children in the future to live and thrive. The systems developed within Regenerating Sonora are also designed to help grow jobs and career opportunities, believing that in the circular economy there people can be compensated while contributing to the wellbeing of their community and developing sustainable communities. There are many involved in the success of Regenerating Sonora including the board of directors but also the many residents who come out to support the New Moon planting parties and other community activities they host. There are activities and ways to support for all ages.

Another asset of Regenerating Sonora is the property that was once the Leo's Grocery Store on Pinal

Avenue, which is now called the "Leo's Community Development Center". Chris purchased the building and it is the home of the Regenerating Sonora operations, and during the pandemic, the building served as a location for food distribution for youth. They plan to begin opening the center for youth after school activities later this fall. Students can come hang out, play games or work on homework.

Regenerating Sonora is also partnering with other local non-profits to support community missions in the realm of Arts and Culture. **Both Regenerating Sonora** and Rebuild Superior Inc. teamed up to host and and support local residents who wanted to host regular tardeadas (afternoon parties) in the park. These long standing Hispanic traditions bring the community together for dancing, food, and visiting with others while enjoying Mexican-American culture and traditions. Regenerating Sonora received a \$30,000 grant from the Arizona **Community Foundation** which they have used to help support expansion of the gardens, provided
