He is survived by his wife, Manuela "Nellie" Martinez; children, Monica (Owensby) Martinez, Steven (Renee) Martinez and Leticia Martinez; many grandchildren, Chelsea, Sophia, Gabriel, Amelia, Danny, Paul, Michelle, Katrina, and Rich; and great-grandchildren. He is preceded in death by his mother Manuela, his brothers Richard and Ralph, his daughter Angie, and son Mike Jr, and grandchildren Anthony and Mikey.

As a young boy he was always curious about instruments, so much so he took clarinet lessons to broaden his horizons, even winning a few competitions along the way. To help pay for the lessons, Mike became a paper boy and had a dedicated route he would take to deliver the Oakland Tribune. Those days of paper routes led him on many adventures, including going to Oakland A's baseball games by winning tickets through work raffles. Always curious to learn more about the world, he often spoke of his favorite place to sit and read books, which would be on the bay's end, "watching the tide roll away" reading about everything from literature to engineering, no subject was off limits

When he moved to Winkelman, Arizona with his mother and brothers, he then became a mighty Lobo and was a bat boy for the baseball teams through high school. He would often be seen throughout town with his beloved brother Richard, spending many good days hanging out at the river playing music and fishing, which was one of his favorite hobbies. It was also during this time that Mike held a job as a bag boy at a local grocery store, and movie theater usher in Hayden's bustling town, eventually leading him to work as a janitor at Kennecott at the young age of 19. He was also a brown belt in Martial Arts and proudly displayed every certificate in his home — we think it was to send a message. He continued his education by taking night classes at Central Arizona College, and at the age of 54 he proudly graduated with his Associate of Arts degree. During his 50+ year tenure at Asarco, he went on to advance and become the Metallurgical Technician of the plant, a position that required great intelligence and

foresight. So when he retired, it was well deserved.

Meeting Manuela, or "Nellie" as most know her, at a dance was by chance, and he would often say it was the best chance he ever took. After a few years of courtship and engagement, Mike and Nellie married in a small wedding in Tucson, Arizona. Spending 47



loving years together, it was rare to see one without the other laughing or just talking about the day ahead. In this marriage came 3 children, Monica, Steven, and Leticia. Spending time with them was one of his favorite parts of life. Whether it was overhauling the engine on his Jeep truck, fishing in the local rivers or Roosevelt Lake, or hunting all over the mountains near and far, he had one of his kids beside him learning how to do these things with him. The greatest and most endearing accomplishment in his life was being a family man who showed consistent love and support for his loved ones, and continuous gentle love for his sweetheart Nellie.

He loved going to the movies, or watching one at home, playing his guitar daily while learning new songs, tinkering around outside on his prized Willy's Jeep and taking visitors of the family on adventures into the canyon. It was almost as if those first experiences for everyone else was the first time he was seeing new things as well; he was always so excited to experience new things. He was also a dedicated member of the church choir, and playing in the band was a highlight of his life, because he felt he was performing with his community, for his community, with God as an audience.

What we will miss most about his existence is not able to be summarized in a passage. For the rest of our lives, we will remember his endearing smile and glimmering eyes, sense of humor, warm hugs and forehead kisses in moments we need that comfort. We were lucky to know and love Mike, Dad, Tio Mike, Tata Mike, who walked the earth for 81 years with intention to make those around him better every day. That in itself is a blessing that could only come from God, and one we will forever be thankful for.

# Cavanaugh Responds to Supervisor Miller

efore I begin my response to Supervisor Stephen Miller taking a knee in support of the CDC's bad policy, I would like to address him attacking my staff. I hired four of the hardest working people in Pinal County. Each week they read over one-thousand pages of law, regulations, opinions, and research just to get me prepared for a single Meeting with the Board of Supervisors; notwithstanding the numerous phone calls and constituent comments and issues handled through my office. We work closely together, and I see them as family. For an elected official, especially the Chairman of the Pinal County Board of Supervisors, to attack and disparage my staff is unprofessional and certainly not in accordance with the stated values of Pinal County. In a preparation brief, a staff member quoted a statistic directly from the Pinal Health Department website page that failed to clearly distinguish a count of vaccinated persons versus vaccines delivered, and I referenced that statistic in a meeting. You had the opportunity to address your understanding of the statistic in the Board meeting, but you were unprepared Mr. Miller. You could have walked across the hall to my office after the meeting, emailed me, or called me to discuss the perceived error, but you chose to write an editorial instead and sew the same type of discord you practiced with other Supervisors during the past eight years. My staff deserves an apology, Mr. Miller, and I hope you have the integrity to deliver one.

## The Pinal County Board Rightly Rejected Federal Government Policy

The people of Pinal County elected a Board of Supervisors to represent local interests not the interests of Washington, D.C. Chairman Miller's apology posted on September 17, 2021, is a continuation of take-a-knee politics. Why do I say this? The 'Equity' grant that the Pinal County Board of Supervisors rejected, is a continuation of a political movement that came to national prominence in 2016 when a professional football player began kneeling to protest alleged police brutality. That movement spurned the "Defund the Police Movement" which led to mass riots, burned out buildings, and the take-over of a city block in Seattle.

Whether purposefully or ignorantly, Supervisor Miller has embraced the assumptions of this flawed political ideology. As evidence of this, Supervisor Miller, in his Justin Trudeau-esq¹ apology letter states: "Equity is a word I do not fully understand as it is commonly viewed with multiple interpretations." It is through this type of ignorance that the federal government takes control of local governments, police departments, school boards, and now public health departments. Research would have shown the Chairman that President Biden defined how "equity" shall be interpreted throughout his administration in an Executive Order signed on the day of his inauguration, Jan. 20, 2021. The relevant text of the Executive Order states:

Sec. 2. Definitions. For purposes of this order: (a) The

term "equity" means the consistent and systematic fair, just, and impartial treatment of all individuals, including individuals who belong to underserved communities that have been denied such treatment, such as Black, Latino, and Indigenous and Native American persons, Asian Americans and Pacific Islanders and other persons of color; members of religious minorities; lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons; persons with disabilities; persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality.

#### The Purpose of the Grant Was to Turn Pinal Citizens into a Political Product

The purpose of the grant rejected by the Pinal County Board of Supervisors had nothing to do with unequal access to vaccines in Pinal County; in fact, there is no evidence that vaccines are inequitably distributed in Pinal County. The real purpose of the grant was to create a Vaccine Equity Coordinator position in Pinal County in exchange for a small portion of the funds, and to transfer the remaining millions to some unknown private contractor. The federal government cares little how the money is spent, as long as the Equity Position was established. Why? Section 9 of the Executive Order tells us:

Sec. 9. Establishing an Equitable Data Working Group. Many Federal datasets are not disaggregated by race, ethnicity, gender, disability, income, veteran status, or other key demographic variables. This lack of data has cascading effects and impedes efforts to measure and advance equity. A first step to promoting equity in Government action is to gather the data necessary to inform that effort (emphasis added).

The real reason is to gather citizen data to establish, not discover, inequity. The grant would also have allowed fund recipients to begin to identify individuals who choose to remain un-vaccinated pursuant to their private health decisions in likely preparation for a future vaccine mandate. Other grant-supporting documents state that COVID-19 risk factors are present because of racism and systemic discrimination. In other words, the Vaccine Equity Coordinator is required, because of alleged inequity despite the federal government's admitted lack of data, to support this claim in Pinal County. To further President Biden's political objectives, he needs to divide Americans one against another under the guise of 'equity.' Notably, the rejected grant forbids the use of funds for actual vaccinations. Why did Supervisor Miller leave this out of his apology letter? The grant language includes attractive phrases like "greater accessibility", but the rest of the document can be easily interpreted as 'less privacy, less choice, less freedom, and divisive politics.'

Thomas Jefferson once said, "To compel a man to furnish funds for the propagation of ideas he disbelieves and abhors is sinful and tyrannical." As long as I am a Supervisor, I will fight for the best interests of you, the residents of Pinal County, not the Biden administration, or anyone else who seeks to divide our communities on

Recently, State and National media have reported an increase in positive COVID-19 Cases. The communities of the Copper Corridor have also started to see an increase in positive cases. The new Delta variant of COVID-19 has been reported as highly transmissible. The CDC and other health officials warn that those who are not vaccinated should continue to practice physical distancing, wear masks in public and avoid crowded places and is also strongly recommending everyone wear a mask indoors and in group settings.

Governor Doug Ducey has signed executive orders that prohibit Cities and Towns from mandating mask wearing, limiting restaurant capacity or other enacting other physical distancing requirements. At this time there is no indication that there will be any restrictions put into place. Local schools are also prohibited from requiring masks be worn on campus.

COVID Vaccines are readily available at local clinics in the region including Cobre Valley Clinics in Superior and Kearny, Pinal County Public Health and Sun Life Clinics. Other chain pharmacies such as Walgreens, grocery story pharmacies and CVS also have vaccines available.

We last reported daily COVID-19 case increased on Sept. 13, 2021. Above is a chart showing our last reported number and the current number of total cases for each of the Copper Corridor communities through Sept. 20, 2021. Keep in mind that zip code data also includes unincorporated areas around a community. For instance, Riverside/Kelvin area is included in the Kearny zip code. Aravaipa and Dudleyville are included in the Winkelman zip codes, etc.

Those experiencing COVID-19 symptoms should seek testing and quarantine until they can confirm a negative test.

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.

the basis of race, sexual orientation, or socioeconomic status. The people of my District are my friends, my neighbors, for whom I am honored to serve with no matter their station in life, political party, sexual orientation, color, or other federal data sub-set. The COVID virus is blind to data subsets.

#### **Pinal County Needs Leadership**

Pinal County needs local leadership not acquiescence to federal mandates. As Peter Drucker once said, "Management is doing things right; leadership is doing the right things." The right thing for Pinal County is to solve local problems with local solutions. Leadership is not the blind acceptance of money; real leadership creates solutions.

The Pinal County Public Health Department has done a fantastic job, under the circumstances, of providing access to vaccines within the County having facilitated more than 50 places for vaccine access.

As a Supervisor, I personally wanted to ensure that there were no people who wanted the COVID-19 vaccine but could not get one, so I sent my staff to canvass the district and conduct an anonymous study. I know how much my students are looking forward to playing and canceling a game can risk making it to the post season. It would be devastating to our athletes that have waited so long to play. I know how important sports are to our students and parents in rural Arizona.

With that said, I want to give special thanks to our Hayden High School student athletes and parents who were vaccinated, which allowed this past Friday night games to be played and may have saved our post season dreams. The good news is that our students that are vaccinated can continue athletics without being quarantined. It sure made a difference this weekend and will allow us to continue our fall sport season.

So far this year, Hayden High School had been spared from COVID-19. I can't say that anymore. I knew it was a matter



of time with the COVID-19 positivity rate in our county and community. Friday afternoon I received the call that set-in motion lots of phone calls to some very disappointed players and parents.

The district school medical assistant, Marisa Gallego's work begins when a positive case was reported to the school and the wheels are set in motion. She contacts the county COVID-19 contract tracing team to determine which students must be quarantined and how long they will need to isolate. The team reviews classroom seating charts to determine who is in close contact with the student that tested positive and who will need to be quarantined. The district mitigation plan follows the Gila County Health Services, CDC, and AIA COVID-19 guidance.

n April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. # New US 60 bridge at Pinto Creek opens to traffic; wider structure replaces 72-year old bridge between Superior, Miami

A new US 60 bridge over Pinto Creek opened to traffic Friday, Sept. 17, replacing a 72-year-old structure on the only route between Superior and the Globe-Miami area.

The Arizona Department of Transportation began the \$22.7 million bridge replacement project 23 months ago, constructing the new bridge just feet away from traffic that continued using the existing structure. Then on the night of Sunday, Sept. 12, work crews closed US 60 between Superior and Miami for a round-the-clock operation to realign the roadway to the new bridge.

The 695.5-foot-long bridge opened to the public shortly before noon Friday. While both bridges were designed for two lanes of traffic, the new structure also features 8-foot-wide shoulders and can handle heavier loads.

"US 60 is a critical route for passenger vehicles and commercial traffic, including heavy loads from mines in the area," said ADOT Southeast District Engineer Bill Harmon. "By completing this new bridge at Pinto Creek, we're making sure the highway will

remain reliable and safe for decades to come."

The bridge is expected to handle roughly 7,200 vehicles a day. While the largest milestone of the project is complete, drivers should expect periodic lane restrictions and delays in the area through the rest of 2021. Crews will work to restore the project site to its natural state over the next several months, with work beginning shortly to remove the existing bridge.

The old bridge, opened in 1949 with an estimated lifespan of 50 years, remained safe for traffic but had reached the end of its useful life. As noted on plaques at each end of the structure, the American Institute of Steel Construction bestowed an annual award of merit for 1949's Most Beautiful Steel Bridge, Class II. Days after closing the old bridge, crews removed the plaques so they can be donated to local historical societies.


