The Hayden football team came out of the gates swinging, and swinging hard last Friday, when the North Phoenix Prep team came onto Lobo territory.

Deondre Collier started off the Senior night game with an 81-yard kickoff return for a touchdown. It was all blue and white after that.

The boys ran up 42 points during the first quarter, easing into a 7-point second quarter. At the half, it was 49-0. Coming out of the half, the Lobos scored another

8 points, while the Gladiators still weren't on the scoreboard. The final quarter saw the boys put up another 7 points, while North Phoenix was able to sneak in a mere 6 points. The Lobos ended the night with a howling victory of 64-6.

Offensively Paul Gaither, was 2-2 for 57 yards of passing, and 1 touchdown. Darren Smith was 1-2 with 24 of yards passing. On the receiving end of those passes were JJ Manriquez with 1 reception for a 50-yard touchdown. Tyler Garner had 1 reception with 7 yards and Mario Hong also had 1 reception with 24 yards. Kino Lorona led the rushing attack with 2 rushes for

82 yards and 2 touchdowns. Deondre Collier had 6 rushes for 67 yards and 2 touchdowns. Jordan Rodriguez had 1 carry for a 44-yard touchdown. Eric Fox had 1 carry for a 25-yard touchdown, and Angel Moreno had 2 rushes for 11 yards and 1 touchdown.

Defensively swarming, Hayden kept North Phoenix Prep under control. Izzy Gallego had 2 solo tackles, 2 assists, and 1 forced fumble. Dominic Alvarado had 1 tackle, 1 assist, 2 sacks, and a forced fumble. Deondre Collier had 1 solo tackle, 1 assist, and 1 interception. Rene Ochoa had 2 solo tackles and 2 assists. Mark Acevedo had 1 solo tackle, 2 assists, 2 sacks, and 1 fumble recovery. Keiston Pool had 2 solo tackles with 1 assist. Oscar Rodriguez had 4 solo tackles with 1 assist. Jr Fong, Chris Casillas, Kino Lorona, Eric Fox, Angel Moreno, Tyler Garner, Jarin Cruz, Elijah Morrison, Julius Pinkard, Xavier Aguirre, Mario Hong, Mj Oropeza, Jordan Rodriguez all recorded a tackle, assist or pass defensed.

Hayden now sits with a 6-0 record, and will not play next week due to a forfeit on Dishchii'bikoh's behalf. The Lobos will hit the field once again on Oct. 6 against Cicero Prep.

San Manuel's homecoming plans announced







Boyce Thompson Arboretum kicks off Centennial with 100 Tree Spree

Nemeth also introduced Annie Weaver Bryant, an


